Re: House Bill 452 by Holly Raser, TAX CREDITS FOR CONTRIBUTIONS TO SERVICES FOR DEVELOPMENTAL DISABILITIES

Dear Governor Martz:

I regret to inform you that your amendatory veto on the above referenced bill, which was received by the Senate on Friday April 25, did not get on the Saturday agenda for 2nd and 3rd reading due to my error. I very much regret this mistake. Therefore these Governor Amendments were not adopted (or rejected) by the Senate.

In consultation with the Code Commissioner, there are two possible courses of action:

1. You can sign the bill without the amendment. He thinks possibly the Department of Revenue could handle the lack of clarity with administrative rule.
2. You could veto the bill because of the identified problems.

I have always lived in terror of doing something like this in the flurry of the final hours, but until now it had not happened. I am returning the enrolled bills for your consideration.
