MESSAGES FROM THE GOVERNOR

Dear Speaker Bergren and President Story:

In accordance with the power vested in me as Governor by the Constitution and laws of the State of Montana, I hereby return with amendments House Bill 322, "AN ACT REQUIRING A PERSON NOMINATED OR APPOINTED AS A NEUTRAL ARBITRATOR TO DISCLOSE A CONFLICT OF INTEREST; PROVIDING FOR VACATING AN AWARD BECAUSE OF A FAILURE TO DISCLOSE A CONFLICT OF INTEREST; AND AMENDING SECTIONS 27-5-211 AND 27-5-312, MCA" for the following reasons.

I have proposed these amendments at the request of the bill's sponsor, Representative Blewett. House Bill 322

establishes disclosure requirements for arbitrators. My amendments cover three technical areas. First, they clarify that it is the arbitrator that must comply with the requirements, not the arbitration agreement. Second, they correct what appears to have been an error in an amendment that was placed on the bill in the legislative process, so as to indicate that the disclosure requirements of subsection (4)(d) of section 1 of the bill apply to "neutral" arbitrators, not to "party" arbitrators, whose disclosure requirements are contained in subsection (4)(c) of section 1. Finally, it was always the intent of the bill that its disclosure requirements apply to arbitrators who have been proposed. The sponsor recently learned, however, of a court decision distinguishing "proposed" arbitrators from "nominated" arbitrators. Therefore, my amendments indicate that the disclosure requirements apply not only to "nominated and appointed" arbitrators, but to "proposed" arbitrators," as well.
