 23 ~~—— **"2-15-111. Appointment and qualifications of department heads -- exception.** (1) Except as~~  
 24 ~~provided in [section 3]:~~  
 25 ~~—— (a) At the beginning of each gubernatorial term, the governor shall appoint each department head who~~  
 26 ~~serves as a director as provided in this chapter.~~  
 27 ~~—— (2)(b) An appointment of a director by the governor is subject to the confirmation of the senate, except~~  
 28 ~~that the governor may appoint a director to assume office before the senate meets in its next regular session to~~  
 29 ~~consider the appointment. A director so appointed is vested with all the functions of the office upon assuming the~~  
 30 ~~office and is a de jure officer, notwithstanding the fact that the senate has not yet confirmed the appointment. If~~

1 the senate does not confirm the appointment of a director, the governor shall make a new appointment.

11 NEW SECTION. Section 1. Office of state public defender -- head. (†) There is an office of state  
12 public defender. The head of the office is a director. The director is hired by the governor from a list of nominees  
13 ~~submitted as provided in subsection (2) DIRECTOR OF THE DEPARTMENT OF ADMINISTRATION.~~ The director is not  
14 subject to confirmation by the senate and may be removed by the governor DIRECTOR OF THE DEPARTMENT OF  
15 ADMINISTRATION only for cause.

16 ~~(2) The public defender advisory commission provided for in 2-15-1028 shall submit to the governor a~~  
17 ~~list of three nominees for director of the office of state public defender. If the governor does not hire any individual~~  
18 ~~from the initial list, the governor may request a second list of three nominees and shall hire the director from that~~  
19 ~~list.~~

21 **Section 2.** Section 2-15-1028, MCA, is amended to read:  
22 **"2-15-1028. Public defender advisory commission.** (†) There is a public defender advisory  
23 commission attached to the office of state public defender established in [section 3] [SECTION 1].

24 (2) The commission consists of 11 members appointed by the governor as follows:

25 (a) two attorneys from nominees submitted by the supreme court;

26 (b) three attorneys from nominees submitted by the president of the state bar of Montana, as follows:

27 (i) one attorney experienced in the defense of felonies who has served a minimum of 1 year as a full-time  
28 public defender;

29 (ii) one attorney experienced in the defense of juvenile delinquency and abuse and neglect cases  
30 involving the federal Indian Child Welfare Act; and

- 1 (iii) one attorney who represents criminal defense lawyers;
- 2 (c) two members of the general public who are not attorneys or judges, active or retired, as follows:
- 3 (i) one member from nominees submitted by the president of the senate; and
- 4 (ii) one member from nominees submitted by the speaker of the house;
- 5 (d) one person who is a member of an organization that advocates on behalf of indigent persons;
- 6 (e) one person who is a member of an organization that advocates on behalf of a racial minority
- 7 population in Montana;
- 8 (f) one person who is a member of an organization that advocates on behalf of people with mental illness
- 9 and developmental disabilities; and
- 10 (g) one person who is employed by an organization that provides addictive behavior counseling.
- 11 (3) A person appointed to the commission must have significant experience in the defense of criminal
- 12 or other cases subject to the provisions of Title 47, chapter 1, or must have demonstrated a strong commitment
- 13 to quality representation of indigent defendants.
- 14 (4) A vacancy on the commission must be filled in the same manner as the original appointment and in
- 15 a timely manner.
- 16 (5) Members shall serve staggered 3-year terms.
- 17 (6) ~~(a) The commission is allocated to the department of administration for administrative purposes only,~~
- 18 ~~as provided in 2-15-121, except that:~~
- 19 ~~—— (i) the commission shall hire staff for the commission subject to subsection (6)(b) and the chief public~~
- 20 ~~defender shall hire separate staff for the office, except for any support staff provided by the department of~~
- 21 ~~administration for centralized services, such as payroll, human resources, accounting, information technology,~~
- 22 ~~or other services determined by the commission and the department to be more efficiently provided by the~~

- 24 ~~—— (ii) commission and office of state public defender budget requests prepared and presented to the~~

 2 ~~1 year. The commission shall serve in an advisory capacity, as defined in 2-15-102, to the director of the office~~  
 3 ~~of state public defender.~~

4 (7) While serving a term on the commission, a member of the commission may not serve as a judge, a  
 5 public defender employed by or under contract with the office of state public defender established in ~~47-1-204~~  
 6 ~~[section 3]~~ [SECTION 1], a county attorney or a deputy county attorney, the attorney general or an assistant  
 7 attorney general, the United States district attorney or an assistant United States district attorney, or a law  
 8 enforcement official.

9 (8) Members of the commission may not receive a salary for service on the commission but must be  
 10 reimbursed for expenses, as provided in 2-18-501 through 2-18-503, while actually engaged in the discharge of  
 11 official duties.

12 (9) The commission shall meet quarterly, establish procedures for the conduct of its affairs, and elect  
 13 a presiding officer from among its members. The director of the office of state public defender may call special  
 14 meetings of the commission as needed."

 16 **Section 3.** Section 2-18-103, MCA, is amended to read:

17 **"2-18-103. Officers and employees excepted.** Parts 1 through 3 and 10 do not apply to the following  
 18 officers and employees in state government:

- 19 (1) elected officials;
- 20 (2) county assessors and their chief deputies;
- 21 (3) employees of the office of consumer counsel;
- 22 (4) judges and employees of the judicial branch;
- 23 (5) members of boards and commissions appointed by the governor, the legislature, or other elected  
 24 state officials;
- 25 (6) officers or members of the militia;
- 26 (7) agency heads appointed by the governor;
- 27 (8) academic and professional administrative personnel with individual contracts under the authority of  
 28 the board of regents of higher education;
- 29 (9) academic and professional administrative personnel and live-in houseparents who have entered into  
 30 individual contracts with the state school for the deaf and blind under the authority of the state board of public

1 education;

2 (10) investment officer, assistant investment officer, executive director, and five professional staff  
3 positions of the board of investments;

4 (11) four professional staff positions under the board of oil and gas conservation;

5 (12) assistant director for security of the Montana state lottery;

6 (13) executive director and employees of the state compensation insurance fund;

7 (14) state racing stewards employed by the executive secretary of the Montana board of horseracing;

8 (15) executive director of the Montana wheat and barley committee;

9 (16) commissioner of banking and financial institutions;

10 (17) training coordinator for county attorneys;

11 (18) employees of an entity of the legislative branch consolidated, as provided in 5-2-504;

12 (19) chief information officer in the department of administration;

13 (20) chief business development officer and six professional staff positions in the office of economic  
14 development provided for in 2-15-218;

15 (21) the following positions in the office of state public defender established in ~~section 3~~ [SECTION 1]:

16 (a) the chief public defender PUBLIC DEFENDER DIVISION ADMINISTRATOR appointed by the public defender  
17 commission pursuant to the Montana Public Defender Act, Title 47, chapter 1, and appointed as provided in  
18 47-1-105;

19 (b) the employees in the positions listed deputy public defenders provided for in 47-1-201(3)(a), who are  
20 appointed by the chief public defender PUBLIC DEFENDER DIVISION ADMINISTRATOR; and

21 (22)(c) the chief appellate defender APPELLATE DEFENDER DIVISION ADMINISTRATOR in the office of appellate  
22 defender appointed as provided in 47-1-105; and

23 (d) the chief conflict defender CONFLICT DEFENDER DIVISION ADMINISTRATOR appointed as provided in  
24 47-1-105."

26 **Section 4.** Section 3-5-511, MCA, is amended to read:

27 **"3-5-511. Witnesses' warrants -- state reimbursement.** (1) The witnesses in criminal actions,  
28 witnesses called by a public defender, as defined in 47-1-103, and witnesses called in a grand jury proceeding  
29 shall report their presence to the clerk the first day they attend under the subpoena.

30 (2) At the time any witness is excused from further attendance, the clerk shall give to the witness a

1 county warrant, signed by the clerk, in which must be stated the name of the witness, the number of days in  
2 attendance, the number of miles traveled, and the amount due pursuant to Title 26, chapter 2, part 5, and  
3 46-15-116.

4 (3) The state shall reimburse the clerk for the amount specified in the warrant as follows:

5 (a) if the witness was subpoenaed by the prosecution in a criminal proceeding or in a grand jury or by  
6 an indigent defendant acting pro se, the amount must be reimbursed by the office of court administrator as  
7 provided in 3-5-901; or

8 (b) if the witness was subpoenaed by a public defender, the amount must be reimbursed by the office  
9 of state public defender as provided in ~~47-1-201~~ [section 27] [SECTION 26]."

11 **Section 5.** Section 3-5-604, MCA, is amended to read:

12 **"3-5-604. Court reporters -- transcript of district court proceedings -- costs.** (1) When a transcript  
13 of the testimony and proceedings of a trial or hearing or a part of a trial or hearing is requested, a court reporter  
14 shall furnish the transcript to the requester with all reasonable diligence. The court reporter shall submit an invoice  
15 with the transcript when it is furnished. The court reporter may withhold delivery of the transcript until the  
16 transcription fee is paid or satisfactory arrangement for payment is made.

17 (2) Compensation for transcripts under this section is as follows:

18 (a) (i) Ordinary transcript - \$2 per page for the original furnished to a state or local government agency,  
19 \$2.50 per page for the original furnished to any other party, 50 cents per page for the first copy to each party, and  
20 25 cents per page for each additional copy to the same party.

21 (ii) Expedited transcript - \$4 per page for the original, 50 cents per page for the first copy to each party,  
22 and 25 cents per page for each additional copy to the same party.

23 (iii) Daily transcript - \$5 per page for the original, 50 cents per page for the first copy to each party, and  
24 25 cents per page for each additional copy to the same party.

25 (b) (i) The transcript cost is subject to a cost-of-living adjustment as provided in subsection (2)(b)(ii).

26 (ii) Prior to June 30 of each even-numbered year, the office of the court administrator shall determine  
27 whether an increase of the transcript amount specified in subsections (2)(a)(i) through (2)(a)(iii) must be made  
28 based on the increase, if any, from June of the preceding year to May of the year in which the calculation is made  
29 in the consumer price index, U.S. city average, all urban consumers, for all items, as published by the bureau of  
30 labor statistics of the United States department of labor.

1 (iii) The transcript amount established under subsection (2)(b)(ii) must be rounded to the nearest 5 cents  
2 and becomes effective as the new transcript cost, replacing the costs specified in subsections (2)(a)(i) through  
3 (2)(a)(iii), on July 1 of the year following the year the calculation was made. The office of the court administrator  
4 shall publish the adjusted costs on the judicial branch website prior to July 1 of each year.

5 (3) If the court reporter is not entitled to retain transcription fees under 3-5-601, the transcription fees  
6 required by subsection (2) must be paid to the clerk of district court, who shall forward the amount to the  
7 department of revenue for deposit in the state general fund.

8 (4) (a) If the county attorney, attorney general, or judge requires a transcript in a criminal case, the  
9 reporter shall furnish it. The transcription fee must be paid by the office of court administrator as provided in  
10 3-5-901. The office of the court administrator may pay only for ordinary transcripts and may not pay for daily or  
11 expedited transcripts.

12 (b) If the judge requires a copy in a civil case to assist in rendering a decision, the reporter shall furnish  
13 the copy without charge.

14 (c) In civil cases, all transcripts required by the county must be furnished and must be paid for by the  
15 county pursuant to subsection (2).

16 (5) (a) If a public defender, as defined in 47-1-103, requests a transcript, the transcript must be furnished  
17 to the public defender and paid for by the office of state public defender, as provided in ~~47-1-201~~ section 271  
18 [SECTION 26].

19 (b) If an indigent party is eligible for a public defender but is acting pro se and requests a transcript, the  
20 transcript must be furnished to the party and paid for by the office of court administrator, as provided in 3-5-901.

21 (6) As used in this section, the following definitions apply:

22 (a) "Copy" means any replication of the original transcript regardless of the medium.

23 (b) "Daily transcript" means a transcript of all or part of the proceedings to be delivered the following day.

24 (c) "Expedited transcript" means a transcript of all or part of the proceedings to be delivered within 7  
25 calendar days.

26 (d) "Ordinary transcript" means a transcript of all or part of the proceedings."

28 **Section 6.** Section 3-5-901, MCA, is amended to read:

29 **"3-5-901. State assumption of district court expenses.** (1) There is a state-funded district court  
30 program under the judicial branch. Under this program, the office of court administrator shall fund all district court

- 1 costs, except as provided in subsection (3). These costs include but are not limited to the following:
- 2 (a) salaries and benefits for:
- 3 (i) district court judges;
- 4 (ii) law clerks;
- 5 (iii) court reporters, as provided in 3-5-601;
- 6 (iv) juvenile probation officers, youth division offices staff, and assessment officers of the youth court; and
- 7 (v) other employees of the district court;
- 8 (b) in criminal cases:
- 9 (i) fees for transcripts of proceedings, as provided in 3-5-604;
- 10 (ii) witness fees and necessary expenses, as provided in 46-15-116;
- 11 (iii) juror fees and necessary expenses;
- 12 (iv) for a psychiatric examination under 46-14-202, the cost of the examination and other associated
- 13 expenses, as provided in 46-14-202(4); and
- 14 (v) for commitment under 46-14-221, the cost of transporting the defendant to the custody of the director
- 15 of the department of public health and human services to be placed in an appropriate facility of the department
- 16 of public health and human services and of transporting the defendant back for any proceedings, as provided in
- 17 46-14-221(5);
- 18 (c) except as provided in ~~47-1-201(5) [section 27]~~ [SECTION 26], the district court expenses in all
- 19 postconviction proceedings held pursuant to Title 46, chapter 21, and in all habeas corpus proceedings held
- 20 pursuant to Title 46, chapter 22, and appeals from those proceedings;
- 21 (d) except as provided in ~~47-1-201(5) [section 27]~~ [SECTION 26], the following expenses incurred by the
- 22 state in federal habeas corpus cases that challenge the validity of a conviction or of a sentence:
- 23 (i) transcript fees;
- 24 (ii) witness fees; and
- 25 (iii) expenses for psychiatric examinations;
- 26 (e) except as provided in ~~47-1-201(5) [section 27]~~ [SECTION 26], the following expenses incurred by the
- 27 state in a proceeding held pursuant to Title 41, chapter 3, part 4 or 6, that seeks temporary investigative authority
- 28 of a youth, temporary legal custody of a youth, or termination of the parent-child legal relationship and permanent
- 29 custody:
- 30 (i) transcript fees;

- 1 (ii) witness fees;
- 2 (iii) expenses for medical and psychological evaluation of a youth or the youth's parent, guardian, or other  
3 person having physical or legal custody of the youth except for expenses for services that a person is eligible to  
4 receive under a public program that provides medical or psychological evaluation;
- 5 (iv) expenses associated with appointment of a guardian ad litem or child advocate for the youth; and
- 6 (v) expenses associated with court-ordered alternative dispute resolution;
- 7 (f) except as provided in ~~47-1-201(5)~~ ~~[section 27]~~ [SECTION 26], costs of juror and witness fees and  
8 witness expenses before a grand jury;
- 9 (g) costs of the court-sanctioned educational program concerning the effects of dissolution of marriage  
10 on children, as required in 40-4-226, and expenses of education when ordered for the investigation and  
11 preparation of a report concerning parenting arrangements, as provided in 40-4-215(2)(a);
- 12 (h) except as provided in ~~47-1-201(5)~~ ~~[section 27]~~ [SECTION 26], all district court expenses associated  
13 with civil jury trials if similar expenses were paid out of the district court fund or the county general fund in any  
14 previous year;
- 15 (i) all other costs associated with the operation and maintenance of the district court, including contract  
16 costs for court reporters who are independent contractors; and
- 17 (j) costs associated with the operation and maintenance of the youth court and youth court division  
18 operations pursuant to 41-5-111 and subsection (1)(a) of this section, except for those costs paid by other entities  
19 identified in Title 41, chapter 5.
- 20 (2) If a cost is not paid directly by the office of court administrator, the county shall pay the cost and the  
21 office of court administrator shall reimburse the county within 30 days of receipt of a claim.
- 22 (3) For the purposes of subsection (1), district court costs paid by the office of court administrator do not  
23 include:
- 24 (a) costs for clerks of district court and employees and expenses of the offices of the clerks of district  
25 court;
- 26 (b) costs of providing and maintaining district court office space; or
- 27 (c) charges incurred against a county by virtue of any provision of Title 7 or 46."

- 29 **Section 7.** Section 5-5-228, MCA, is amended to read:
- 30 **"5-5-228. State administration and veterans' affairs interim committee.** (1) The state administration

1 and veterans' affairs interim committee has administrative rule review, draft legislation review, program  
 2 evaluation, and monitoring functions for the public employee retirement plans and for the following executive  
 3 branch agencies and, unless otherwise assigned by law, the entities attached to the agencies for administrative  
 4 purposes:

5 (a) department of administration, except:

6 (i) the state compensation insurance fund provided for in 39-71-2313, including the board of directors  
 7 of the state compensation insurance fund established in 2-15-1019;

8 (ii) the state tax appeal board established in 2-15-1015; and

9 ~~(iii) the office of state public defender; and~~

10 ~~(iv)~~(iii) the division of banking and financial institutions;

11 (b) department of military affairs; and

12 (c) office of the secretary of state.

13 (2) The committee shall:

 3 the office of state public defender but not for the office of ~~chief appellate defender~~ APPELLATE DEFENDER DIVISION.  
 4 (Terminates June 30, 2025--sec. 7, Ch. 232, L. 2015.)"

 7           **"26-2-506. Fees paid by party subpoenaing -- exceptions.** (1) Except as provided in subsection (2),  
 8 fees and compensation of a witness in all criminal and civil actions must be paid by the party who caused the  
 9 witness to be subpoenaed.

10           (2) (a) When a witness is subpoenaed by a public defender, as defined in 47-1-103, the fees and

24 not exceed 5 days, including weekends and holidays, unless the fifth day falls upon a weekend or holiday and  
25 unless additional time is requested on behalf of the respondent.

26 (b) If the court finds that an appropriate person is willing and able to perform the functions of a friend of  
27 respondent as set out in this part and the respondent personally or through counsel consents, the court shall  
28 appoint the person as the friend of respondent. The friend of respondent may be the next of kin, the person's  
29 conservator or legal guardian, if any, a representative of a charitable or religious organization, or any other person  
30 appointed by the court. Only one person may at any one time be the friend of respondent within the meaning of

1 this part. The court may at any time, for good cause, change its designation of the friend of respondent. The court  
2 shall change the designation of the friend of respondent at the request of the respondent or if it determines that  
3 a conflict of interest exists between the respondent and the friend of respondent.

4 (3) If a judge is not available in the county in person, the clerk shall notify a resident judge by telephone  
5 and shall read the petition to the judge. The judge may do all things necessary through the clerk of court by  
6 telephone as if the judge were personally present, including ordering the office of state public defender, provided  
7 for in ~~47-1-201~~ ~~[section 3]~~ [SECTION 1], to immediately provide assigned counsel. The judge, through the clerk of  
8 court, may also order that the respondent be brought before a justice of the peace with the respondent's counsel  
9 to be advised of the respondent's constitutional rights, the respondent's rights under this part, and the contents  
10 of the order, as well as to furnish the respondent with a copy of the order. The respondent must also be advised  
11 that the professional person appointed to conduct the examination under 53-21-123 will include in the  
12 professional person's report a recommendation about whether the respondent should be diverted from involuntary  
13 commitment to short-term inpatient treatment provided for in 53-21-1205 and 53-21-1206. The justice of the  
14 peace shall ascertain the desires of the respondent with respect to the assignment of counsel or the hiring of  
15 private counsel, pursuant to 53-21-116 and 53-21-117, and this information must be immediately communicated  
16 to the resident judge."

17

18 **Section 40.** Section 53-24-302, MCA, is amended to read:

19 **"53-24-302. Involuntary commitment of alcoholics -- rights.** (1) A person may be committed to the  
20 custody of the department by the district court upon the petition of the person's spouse or guardian, a relative,  
21 the certifying physician, or the chief of any approved public treatment facility. The petition must allege that the  
22 person is an alcoholic who habitually lacks self-control as to the use of alcoholic beverages and that the person  
23 has threatened, attempted, or inflicted physical harm on another and that unless committed is likely to inflict  
24 physical harm on another or is incapacitated by alcohol. A refusal to undergo treatment does not constitute  
25 evidence of lack of judgment as to the need for treatment. The petition must be accompanied by a certificate of  
26 a licensed physician who has examined the person within 2 days before submission of the petition unless the  
27 person whose commitment is sought has refused to submit to a medical examination, in which case the fact of  
28 refusal must be alleged in the petition. The certificate must set forth the physician's findings in support of the  
29 allegations of the petition. A physician employed by the admitting facility or the department is not eligible to be  
30 the certifying physician.

1           (2) Upon filing the petition, the court shall fix a date for a hearing no later than 10 days after the date the  
2 petition was filed. A copy of the petition and of the notice of the hearing, including the date fixed by the court, must  
3 be served on the petitioner, the person whose commitment is sought, the person's next of kin other than the  
4 petitioner, a parent or the person's legal guardian if the person is a minor, the administrator in charge of the  
5 approved public treatment facility to which the person has been committed for emergency care, and any other  
6 person the court believes advisable. A copy of the petition and certificate must be delivered to each person  
7 notified.

8           (3) At the hearing, the court shall hear all relevant testimony, including, if possible, the testimony of at  
9 least one licensed physician who has examined the person whose commitment is sought. The person has a right  
10 to have a licensed physician of the person's own choosing conduct an examination and testify on the person's  
11 behalf. If the person has no funds with which to pay the physician, the reasonable costs of one examination and  
12 testimony must be paid by the county. The person must be present unless the court believes that the person's  
13 presence is likely to be injurious to the person. The court shall examine the person in open court or, if advisable,  
14 shall examine the person in chambers. If the person refuses an examination by a licensed physician and there  
15 is sufficient evidence to believe that the allegations of the petition are true or if the court believes that more  
16 medical evidence is necessary, the court may make a temporary order committing the person to the department  
17 for a period of not more than 5 days for purposes of a diagnostic examination.

18           (4) If after hearing all relevant evidence, including the results of any diagnostic examination by the  
19 department, the court finds that grounds for involuntary commitment have been established by clear and  
20 convincing evidence, it shall make an order of commitment to the department. The court may not order  
21 commitment of a person unless it determines that the department is able to provide adequate and appropriate  
22 treatment for the person and that the treatment is likely to be beneficial.

23           (5) A person committed under this section must remain in the custody of the department for treatment  
24 for a period of 40 days unless sooner discharged. At the end of the 40-day period, the person must automatically  
25 be discharged unless before expiration of the period the department obtains a court order from the district court  
26 of the committing district for the person's recommitment upon the grounds set forth in subsection (1) for a further  
27 period of 90 days unless sooner discharged. If a person has been committed because the person is an alcoholic  
28 likely to inflict physical harm on another, the department shall apply for recommitment if after examination it is  
29 determined that the likelihood still exists.

30           (6) A person recommitted under subsection (5) who has not been discharged by the department before

1 the end of the 90-day period must be discharged at the expiration of that period unless before expiration of the  
2 period the department obtains a court order from the district court of the committing district on the grounds set  
3 forth in subsection (1) for recommitment for a further period not to exceed 90 days. If a person has been  
4 committed because the person is an alcoholic likely to inflict physical harm on another, the department shall apply  
5 for recommitment if after examination it is determined that the likelihood still exists. Only two recommitment orders  
6 under subsections (5) and (6) are permitted.

7 (7) Upon the filing of a petition for recommitment under subsection (5) or (6), the court shall fix a date  
8 for hearing no later than 10 days after the date the petition was filed. A copy of the petition and of the notice of  
9 hearing, including the date fixed by the court, must be served on the petitioner, the person whose commitment  
10 is sought, the person's next of kin other than the petitioner, the original petitioner under subsection (1) if different  
11 from the petitioner for recommitment, one of the person's parents or the person's legal guardian if the person is  
12 a minor, and any other person the court believes advisable. At the hearing, the court shall proceed as provided  
13 in subsection (3).

14 (8) A person committed to the custody of the department for treatment must be discharged at any time  
15 before the end of the period for which the person has been committed if either of the following conditions is met:

16 (a) in case of an alcoholic committed on the grounds of likelihood of infliction of physical harm upon  
17 another, that the person is no longer in need of treatment or the likelihood no longer exists; or

18 (b) in case of an alcoholic committed on the grounds of incapacity and the need of treatment, that the  
19 incapacity no longer exists, further treatment will not be likely to bring about significant improvement in the  
20 person's condition, or treatment is no longer adequate or appropriate.

21 (9) The court shall inform the person whose commitment or recommitment is sought of the person's right  
22 to contest the application, be represented by counsel at every stage of any proceedings relating to the person's  
23 commitment and recommitment, and have assigned counsel pursuant to the Montana Public Defender Act, Title  
24 47, chapter 1, if the person wants the assistance of counsel and is unable to obtain private counsel. If the court  
25 believes that the person needs the assistance of counsel, the court shall order the office of state public defender,  
26 provided for in ~~47-1-201~~ ~~[section 3]~~ [SECTION 1], to assign counsel for the person regardless of the person's  
27 wishes. The person whose commitment or recommitment is sought must be informed of the right to be examined  
28 by a licensed physician of the person's choice. If the person is unable to obtain a licensed physician and requests  
29 examination by a physician, the court shall employ a licensed physician.

30 (10) If a private treatment facility agrees with the request of a competent patient or the patient's parent,

1 sibling, adult child, or guardian to accept the patient for treatment, the department may transfer the patient to the  
2 private treatment facility.

3 (11) A person committed under this section may at any time seek to be discharged from commitment by  
4 writ of habeas corpus or other appropriate means.

5 (12) The venue for proceedings under this section is the place in which the person to be committed  
6 resides or is present."

9 **"72-5-225. Procedure for court appointment of guardian of minor -- notice -- hearing --**  
10 **representation by attorney.** (1) Notice of the time and place of hearing of a petition for the appointment of a

12 (a) the minor, if the minor is 14 years of age or older;

13 (2) Upon the filing of a petition, the court shall set a date for hearing on the issues of incapacity. The

24 incapacitated and the place it is proposed that the person will be detained or reside if the requested appointment  
25 is made and submit the visitor's report in writing to the court. Whenever possible without undue delay or expense  
26 beyond the ability to pay of the alleged incapacitated person, the court, in formulating the judgment, shall utilize  
27 the services of any public or charitable agency that offers or is willing to evaluate the condition of the allegedly  
28 incapacitated person and make recommendations to the court regarding the most appropriate form of state  
29 intervention in the person's affairs.

30 (4) The person alleged to be incapacitated is entitled to be present at the hearing in person and to see

1 or hear all evidence bearing upon the person's condition. The person is entitled to be present by counsel, to  
 2 present evidence, to cross-examine witnesses, including the court-appointed physician and the visitor, and to trial  
 3 by jury. The issue may be determined at a closed hearing without a jury if the person alleged to be incapacitated  
 4 or the person's counsel requests it."

 20 the person to be protected be examined by a physician designated by the court. It is preferable that a physician  
 21 designated by the court not be connected with any institution in which the person is a patient or is detained. The  
 22 court may send a visitor to interview the person to be protected. The visitor may be a guardian ad litem or an  
 23 officer or employee of the court.

24 (3) In the case of an appointment pursuant to 72-5-410(1)(h), the court shall direct that the person to be  
 25 protected be examined by a physician as set forth in subsection (2).

26 (4) After hearing, upon finding that a basis for the appointment of a conservator or other protective order
