6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

8 NEW SECTION. Section 1. Captive mergers. (1) A merger between captive stock insurers must meet  
 9 the requirements of 33-3-217 and 33-28-105, except that the commissioner may provide notice to the public of  
 10 the PROPOSED merger PRIOR TO APPROVAL OR DISAPPROVAL OF THE MERGER in place of holding a hearing, at the  
 11 commissioner's discretion.

12 (2) A merger between captive mutual insurers must meet the requirements of 33-3-218 and 33-28-105,  
 13 except that the commissioner may provide notice to the public of the PROPOSED merger PRIOR TO APPROVAL OR  
 14 DISAPPROVAL OF THE MERGER in place of holding a hearing, at the commissioner's discretion.

16 **Section 2.** Section 15-30-2110, MCA, is amended to read:

17 "**15-30-2110. Adjusted gross income.** (1) Subject to subsection (14), adjusted gross income is the  
 18 taxpayer's federal adjusted gross income as defined in section 62 of the Internal Revenue Code, 26 U.S.C. 62,  
 19 and in addition includes the following:

20 (a) (i) interest received on obligations of another state or territory or county, municipality, district, or other  
 21 political subdivision of another state, except to the extent that the interest is exempt from taxation by Montana  
 22 under federal law;

23 (ii) exempt-interest dividends as defined in section 852(b)(5) of the Internal Revenue Code, 26 U.S.C.  
 24 852(b)(5), that are attributable to the interest referred to in subsection (1)(a)(i);

25 (b) refunds received of federal income tax, to the extent that the deduction of the tax resulted in a  
 26 reduction of Montana income tax liability as determined under subsection (15);

27 (c) that portion of a shareholder's income under subchapter S. of Chapter 1 of the Internal Revenue  
 28 Code that has been reduced by any federal taxes paid by the subchapter S. corporation on the income;

29 (d) depreciation or amortization taken on a title plant as defined in 33-25-105;

30 (e) the recovery during the tax year of an amount deducted in any prior tax year to the extent that the

1 amount recovered reduced the taxpayer's Montana income tax in the year deducted;

2 (f) if the state taxable distribution of an estate or trust is greater than the federal taxable distribution of  
3 the same estate or trust, the difference between the state taxable distribution and the federal taxable distribution  
4 of the same estate or trust for the same tax period; and

5 (g) except for exempt-interest dividends described in subsection (2)(a)(ii), the amount of any dividend  
6 to the extent that the dividend is not included in federal adjusted gross income.

7 (2) Notwithstanding the provisions of the Internal Revenue Code, adjusted gross income does not  
8 include the following, which are exempt from taxation under this chapter:

9 (a) (i) all interest income from obligations of the United States government, the state of Montana, or a  
10 county, municipality, district, or other political subdivision of the state and any other interest income that is exempt  
11 from taxation by Montana under federal law;

12 (ii) exempt-interest dividends as defined in section 852(b)(5) of the Internal Revenue Code, 26 U.S.C.  
13 852(b)(5), that are attributable to the interest referred to in subsection (2)(a)(i);

14 (b) interest income earned by a taxpayer who is 65 years of age or older in a tax year up to and including  
15 \$800 for a taxpayer filing a separate return and \$1,600 for each joint return;

16 (c) (i) except as provided in subsection (2)(c)(ii) and subject to subsection (16), the first \$4,070 of all  
17 pension and annuity income received as defined in 15-30-2101;

18 (ii) subject to subsection (16), for pension and annuity income described under subsection (2)(c)(i), as  
19 follows:

20 (A) each taxpayer filing singly, head of household, or married filing separately shall reduce the total  
21 amount of the exclusion provided in subsection (2)(c)(i) by \$2 for every \$1 of federal adjusted gross income in  
22 excess of \$33,910 as shown on the taxpayer's return;

23 (B) in the case of married taxpayers filing jointly, if both taxpayers are receiving pension or annuity  
24 income or if only one taxpayer is receiving pension or annuity income, the exclusion claimed as provided in  
25 subsection (2)(c)(i) must be reduced by \$2 for every \$1 of federal adjusted gross income in excess of \$33,910  
26 as shown on their joint return;

27 (d) all Montana income tax refunds or tax refund credits;

28 (e) gain required to be recognized by a liquidating corporation under 15-31-113(1)(a)(ii);

29 (f) all tips or gratuities that are covered by section 3402(k) or service charges that are covered by section  
30 3401 of the Internal Revenue Code of 1954, 26 U.S.C. 3402(k) or 3401, as amended and applicable on January

1 1, 1983, received by a person for services rendered to patrons of premises licensed to provide food, beverage,  
2 or lodging;

3 (g) all benefits received under the workers' compensation laws;

4 (h) all health insurance premiums paid by an employer for an employee if attributed as income to the  
5 employee under federal law;

6 (i) all money received because of a settlement agreement or judgment in a lawsuit brought against a  
7 manufacturer or distributor of "agent orange" for damages resulting from exposure to "agent orange";

8 (j) principal and income in a medical care savings account established in accordance with 15-61-201  
9 or withdrawn from an account for eligible medical expenses, as defined in 15-61-102, of the taxpayer or a  
10 dependent of the taxpayer or for the long-term care of the taxpayer or a dependent of the taxpayer;

11 (k) principal and income in a first-time home buyer savings account established in accordance with  
12 15-63-201 or withdrawn from an account for eligible costs, as provided in 15-63-202(7), for the first-time purchase  
13 of a single-family residence;

14 (l) contributions or earnings withdrawn from a family education savings account or from a qualified tuition  
15 program established and maintained by another state as provided by section 529(b)(1)(A)(ii) of the Internal  
16 Revenue Code, 26 U.S.C. 529(b)(1)(A)(ii), for qualified higher education expenses, as defined in 15-62-103, of  
17 a designated beneficiary;

18 (m) the recovery during the tax year of any amount deducted in any prior tax year to the extent that the  
19 recovered amount did not reduce the taxpayer's Montana income tax in the year deducted;

20 (n) if the federal taxable distribution of an estate or trust is greater than the state taxable distribution of  
21 the same estate or trust, the difference between the federal taxable distribution and the state taxable distribution  
22 of the same estate or trust for the same tax period;

23 (o) deposits, not exceeding the amount set forth in 15-30-3003, deposited in a Montana farm and ranch  
24 risk management account, as provided in 15-30-3001 through 15-30-3005, in any tax year for which a deduction  
25 is not provided for federal income tax purposes;

26 (p) income of a dependent child that is included in the taxpayer's federal adjusted gross income pursuant  
27 to the Internal Revenue Code. The child is required to file a Montana personal income tax return if the child and  
28 taxpayer meet the filing requirements in 15-30-2602.

29 (q) principal and income deposited in a health care expense trust account, as defined in 2-18-1303, or  
30 withdrawn from the account for payment of qualified health care expenses as defined in 2-18-1303;

1           ~~(r)~~ that part of the refundable credit provided in 33-22-2006 that reduces Montana tax below zero;  
2           ~~(s)~~(r) the amount of the gain recognized from the sale or exchange of a mobile home park as provided  
3 in 15-31-163; and

4           ~~(t)~~(s) the amount of a scholarship to an eligible student by a student scholarship organization pursuant  
5 to 15-30-3104.

6           (3) A shareholder of a DISC that is exempt from the corporate income tax under 15-31-102(1)(l) shall  
7 include in the shareholder's adjusted gross income the earnings and profits of the DISC in the same manner as  
8 provided by section 995 of the Internal Revenue Code, 26 U.S.C. 995, for all periods for which the DISC election  
9 is effective.

10           (4) A taxpayer who, in determining federal adjusted gross income, has reduced the taxpayer's business  
11 deductions by an amount for wages and salaries for which a federal tax credit was elected under sections 38 and  
12 51(a) of the Internal Revenue Code, 26 U.S.C. 38 and 51(a), is allowed to deduct the amount of the wages and  
13 salaries paid regardless of the credit taken. The deduction must be made in the year that the wages and salaries  
14 were used to compute the credit. In the case of a partnership or small business corporation, the deduction must  
15 be made to determine the amount of income or loss of the partnership or small business corporation.

16           (5) Married taxpayers filing a joint federal return who are required to include part of their social security  
17 benefits or part of their tier 1 railroad retirement benefits in federal adjusted gross income may split the federal  
18 base used in calculation of federal taxable social security benefits or federal taxable tier 1 railroad retirement  
19 benefits when they file separate Montana income tax returns. The federal base must be split equally on the  
20 Montana return.

21           (6) Married taxpayers filing a joint federal return who are allowed a capital loss deduction under section  
22 1211 of the Internal Revenue Code, 26 U.S.C. 1211, and who file separate Montana income tax returns may  
23 claim the same amount of the capital loss deduction that is allowed on the federal return. If the allowable capital  
24 loss is clearly attributable to one spouse, the loss must be shown on that spouse's return; otherwise, the loss  
25 must be split equally on each return.

26           (7) In the case of passive and rental income losses, married taxpayers filing a joint federal return and  
27 who file separate Montana income tax returns are not required to recompute allowable passive losses according  
28 to the federal passive activity rules for married taxpayers filing separately under section 469 of the Internal  
29 Revenue Code, 26 U.S.C. 469. If the allowable passive loss is clearly attributable to one spouse, the loss must  
30 be shown on that spouse's return; otherwise, the loss must be split equally on each return.

1 (8) Married taxpayers filing a joint federal return in which one or both of the taxpayers are allowed a  
2 deduction for an individual retirement contribution under section 219 of the Internal Revenue Code, 26 U.S.C.  
3 219, and who file separate Montana income tax returns may claim the same amount of the deduction that is  
4 allowed on the federal return. The deduction must be attributed to the spouse who made the contribution.

5 (9) (a) Married taxpayers filing a joint federal return who are allowed a deduction for interest paid for a  
6 qualified education loan under section 221 of the Internal Revenue Code, 26 U.S.C. 221, and who file separate  
7 Montana income tax returns may claim the same amount of the deduction that is allowed on the federal return.  
8 The deduction may be split equally on each return or in proportion to each taxpayer's share of federal adjusted  
9 gross income.

10 (b) Married taxpayers filing a joint federal return who are allowed a deduction for qualified tuition and  
11 related expenses under section 222 of the Internal Revenue Code, 26 U.S.C. 222, and who file separate Montana  
12 income tax returns may claim the same amount of the deduction that is allowed on the federal return. The  
13 deduction may be split equally on each return or in proportion to each taxpayer's share of federal adjusted gross  
14 income.

15 (10) A taxpayer receiving retirement disability benefits who has not attained 65 years of age by the end  
16 of the tax year and who has retired as permanently and totally disabled may exclude from adjusted gross income  
17 up to \$100 a week received as wages or payments in lieu of wages for a period during which the employee is  
18 absent from work due to the disability. If the adjusted gross income before this exclusion exceeds \$15,000, the  
19 excess reduces the exclusion by an equal amount. This limitation affects the amount of exclusion, but not the  
20 taxpayer's eligibility for the exclusion. If eligible, married individuals shall apply the exclusion separately, but the  
21 limitation for income exceeding \$15,000 is determined with respect to the spouses on their combined adjusted  
22 gross income. For the purpose of this subsection, "permanently and totally disabled" means unable to engage  
23 in any substantial gainful activity by reason of any medically determined physical or mental impairment lasting  
24 or expected to last at least 12 months.

25 (11) (a) An individual who contributes to one or more accounts established under the Montana family  
26 education savings program or to a qualified tuition program established and maintained by another state as  
27 provided by section 529(b)(1)(A)(ii) of the Internal Revenue Code, 26 U.S.C. 529(b)(1)(A)(ii), may reduce adjusted  
28 gross income by the lesser of \$3,000 or the amount of the contribution. In the case of married taxpayers, each  
29 spouse is entitled to a reduction, not in excess of \$3,000, for the spouses' contributions to the accounts. Spouses  
30 may jointly elect to treat half of the total contributions made by the spouses as being made by each spouse. The

1 reduction in adjusted gross income under this subsection applies only with respect to contributions to an account  
2 of which the account owner is the taxpayer, the taxpayer's spouse, or the taxpayer's child or stepchild if the  
3 taxpayer's child or stepchild is a Montana resident. The provisions of subsection (1)(e) do not apply with respect  
4 to withdrawals of contributions that reduced adjusted gross income.

5 (b) Contributions made pursuant to this subsection (11) are subject to the recapture tax provided in  
6 15-62-208.

7 (12) (a) An individual who contributes to one or more accounts established under the Montana achieving  
8 a better life experience program or to a qualified program established and maintained by another state as  
9 provided by section 529A(e)(7) of the Internal Revenue Code, 26 U.S.C. 529A(e)(7), may reduce adjusted gross  
10 income by the lesser of \$3,000 or the amount of the contribution. In the case of married taxpayers, each spouse  
11 is entitled to a reduction, not to exceed \$3,000, for the spouses' contributions to the accounts. Spouses may  
12 jointly elect to treat one-half of the total contributions made by the spouses as being made by each spouse. The  
13 reduction in adjusted gross income under this subsection (12)(a) applies only with respect to contributions to an  
14 account for which the account owner is the taxpayer, the taxpayer's spouse, or the taxpayer's child or stepchild  
15 if the taxpayer's child or stepchild is a Montana resident. The provisions of subsection (1)(e) do not apply with  
16 respect to withdrawals of contributions that reduced adjusted gross income.

17 (b) Contributions made pursuant to this subsection (12) are subject to the recapture tax provided in  
18 53-25-118.

19 (13) (a) A taxpayer may exclude the amount of the loan payment received pursuant to subsection  
20 (13)(a)(iv), not to exceed \$5,000, from the taxpayer's adjusted gross income if the taxpayer:

21 (i) is a health care professional licensed in Montana as provided in Title 37;

22 (ii) is serving a significant portion of a designated geographic area, special population, or facility  
23 population in a federally designated health professional shortage area, a medically underserved area or  
24 population, or a federal nursing shortage county as determined by the secretary of health and human services  
25 or by the governor;

26 (iii) has had a student loan incurred as a result of health-related education; and

27 (iv) has received a loan payment during the tax year made on the taxpayer's behalf by a loan repayment  
28 program described in subsection (13)(b) as an incentive to practice in Montana.

29 (b) For the purposes of subsection (13)(a), a loan repayment program includes a federal, state, or  
30 qualified private program. A qualified private loan repayment program includes a licensed health care facility, as

1 defined in 50-5-101, that makes student loan payments on behalf of the person who is employed by the facility  
2 as a licensed health care professional.

3 (14) Notwithstanding the provisions of subsection (1), adjusted gross income does not include 40% of  
4 capital gains on the sale or exchange of capital assets before December 31, 1986, as capital gains are  
5 determined under subchapter P. of Chapter 1 of the Internal Revenue Code as it read on December 31, 1986.

6 (15) A refund received of federal income tax referred to in subsection (1)(b) must be allocated in the  
7 following order as applicable:

8 (a) to federal income tax in a prior tax year that was not deducted on the state tax return in that prior tax  
9 year;

10 (b) to federal income tax in a prior tax year that was deducted on the state tax return in that prior tax year  
11 but did not result in a reduction in state income tax liability in that prior tax year; and

12 (c) to federal income tax in a prior tax year that was deducted on the state tax return in that prior tax year  
13 and that reduced the taxpayer's state income tax liability in that prior tax year.

14 (16) By November 1 of each year, the department shall multiply the amount of pension and annuity  
15 income contained in subsection (2)(c)(i) and the federal adjusted gross income amounts in subsection (2)(c)(ii)  
16 by the inflation factor for the following tax year, rounded to the nearest \$10. The resulting amounts are effective  
17 for that following tax year and must be used as the basis for the exemption determined under subsection (2)(c).  
18 (Subsection (2)(f) terminates on occurrence of contingency--sec. 3, Ch. 634, L. 1983; subsection (2)(o) terminates  
19 on occurrence of contingency--sec. 9, Ch. 262, L. 2001; subsection ~~(2)(t)~~ (2)(s) terminates December 31,  
20 2023--sec. 33, Ch. 457, L. 2015.)"

22 **Section 3.** Section 15-30-2618, MCA, is amended to read:

23 **"15-30-2618. Confidentiality of tax records.** (1) Except as provided in 5-12-303, 15-1-106, 17-7-111,  
24 and subsections (8) and (9) of this section, in accordance with a proper judicial order, or as otherwise provided  
25 by law, it is unlawful to divulge or make known in any manner:

26 (a) the amount of income or any particulars set forth or disclosed in any individual report or individual  
27 return required under this chapter or any other information secured in the administration of this chapter; or

28 (b) any federal return or federal return information disclosed on any return or report required by rule of  
29 the department or under this chapter.

30 (2) (a) The officers charged with the custody of the reports and returns may not be required to produce



1 them or evidence of anything contained in them in an action or proceeding in a court, except in an action or  
2 proceeding:

3 (i) to which the department is a party under the provisions of this chapter or any other taxing act; or

4 (ii) on behalf of a party to any action or proceedings under the provisions of this chapter or other taxes  
5 when the reports or facts shown by the reports are directly involved in the action or proceedings.

6 (b) The court may require the production of and may admit in evidence only as much of the reports or  
7 of the facts shown by the reports as are pertinent to the action or proceedings.

8 (3) This section does not prohibit:

9 (a) the delivery to a taxpayer or the taxpayer's authorized representative of a certified copy of any return  
10 or report filed in connection with the taxpayer's tax;

11 (b) the publication of statistics classified to prevent the identification of particular reports or returns and  
12 the items of particular reports or returns; or

13 (c) the inspection by the attorney general or other legal representative of the state of the report or return  
14 of any taxpayer who brings an action to set aside or review the tax based on the report or return or against whom  
15 an action or proceeding has been instituted in accordance with the provisions of 15-30-2630.

16 (4) The department may deliver to a taxpayer's spouse the taxpayer's return or information related to  
17 the return for a tax year if the spouse and the taxpayer filed the return with the filing status of married filing  
18 separately on the same return. The information being provided to the spouse or reported on the return, including  
19 subsequent adjustments or amendments to the return, must be treated in the same manner as if the spouse and  
20 the taxpayer filed the return using a joint filing status for that tax year.

21 (5) Reports and returns must be preserved for at least 3 years and may be preserved until the  
22 department orders them to be destroyed.

23 (6) Any offense against subsections (1) through (5) is punishable by a fine not exceeding \$500. If the  
24 offender is an officer or employee of the state, the offender must be dismissed from office or employment and  
25 may not hold any public office or public employment in this state for a period of 1 year after dismissal or, in the  
26 case of a former officer or employee, for 1 year after conviction.

27 (7) This section may not be construed to prohibit the department from providing taxpayer return  
28 information and information from employers' payroll withholding reports to:

29 (a) the department of labor and industry to be used for the purpose of investigation and prevention of  
30 noncompliance, tax evasion, fraud, and abuse under the unemployment insurance laws; or

1 (b) the state fund to be used for the purpose of investigation and prevention of noncompliance, fraud,  
2 and abuse under the workers' compensation program.

3 (8) The department may permit the commissioner of internal revenue of the United States or the proper  
4 officer of any state imposing a tax on the incomes of individuals or the authorized representative of either officer  
5 to inspect the return of income of any individual or may furnish to the officer or an authorized representative an  
6 abstract of the return of income of any individual or supply the officer with information concerning an item of  
7 income contained in a return or disclosed by the report of an investigation of the income or return of income of  
8 an individual, but the permission may be granted or information furnished only if the statutes of the United States  
9 or of the other state grant substantially similar privileges to the proper officer of this state charged with the  
10 administration of this chapter.

11 (9) On written request to the director or a designee of the director, the department shall furnish:

12 (a) to the department of justice all information necessary to identify those persons qualifying for the  
13 additional exemption for blindness pursuant to 15-30-2114(4), for the purpose of enabling the department of  
14 justice to administer the provisions of 61-5-105;

15 (b) to the department of public health and human services information acquired under 15-30-2616,  
16 pertaining to an applicant for public assistance, reasonably necessary for the prevention and detection of public  
17 assistance fraud and abuse, provided notice to the applicant has been given;

18 (c) to the department of labor and industry for the purpose of prevention and detection of fraud and  
19 abuse in and eligibility for benefits under the unemployment compensation and workers' compensation programs  
20 information on whether a taxpayer who is the subject of an ongoing investigation by the department of labor and  
21 industry is an employee, an independent contractor, or self-employed;

18           (e) shall submit to a licensing background examination that meets the requirements provided in

10 (d) Rates may be considered unfairly discriminatory if they violate 33-18-206, 33-22-526, 49-2-309, or

12 (2) In order to determine whether the proposed premium rates for health insurance coverage are not  
13 excessive, inadequate, unjustified, or unfairly discriminatory, the commissioner may consider:

14 (a) the health insurance issuer's financial position, including but not limited to surplus, reserves, and  
15 investment savings;

16 (b) historical and projected administrative costs and medical and hospital expenses, including medical  
17 trends;

18 (c) the historical and projected medical loss ratio;

19 (d) changes to covered benefits or health plan design, along with actuarial projections concerning cost  
20 savings or additional expenses related to those changes;

21 (e) changes in the health insurance issuer's health care cost containment and quality improvement  
22 efforts following the health insurance issuer's last rate filing for the same category of health plan;

23 (f) product development and startup costs, drug and other benefit costs or expenses, and product age  
24 and credibility;

25 (g) whether the proposed change in the premium rate is necessary to maintain the health insurance  
26 issuer's solvency or to maintain rate stability and prevent excessive rate increases in the future;

27 (h) historical and projected claims experience;

28 (i) trend projections related to utilization and service or unit cost;

29 (j) allocation of the overall rate increase to claims and nonclaims costs;

30 (k) allocation of current and projected premium for each enrollee each month;

1 (l) the 3-year history of rate increases for the product or group of products associated with the rate  
2 increase if the product is 3 years old or older and otherwise any available rate history;

3 (m) employee and executive compensation data from the health insurance issuer's annual financial  
4 statements; and

5 (n) any other applicable information identified in administrative rules adopted pursuant to Title 33, except  
6 that the administrative rules may not include by reference any provisions of Public Law 111-148 and Public Law  
7 111-152 or any regulations promulgated under those laws.

8 (3) The commissioner shall review rate filings and, if applicable, shall provide a notice of deficiencies  
9 containing detailed reasons describing why the commissioner finds that the proposed premium rate is excessive,  
10 inadequate, unjustified, or unfairly discriminatory. The notice must be provided within 60 days of receipt of filing.

11 (4) Within 30 days after receiving a notice of deficiencies alleging that a proposed rate is excessive,  
12 inadequate, unjustified, or unfairly discriminatory, the insurer may amend its rate filing, request reconsideration  
13 based upon additional information, or, unless the rate is unfairly discriminatory pursuant to subsection (1)(d),  
14 implement the proposed rate, ~~unless the rate is unfairly discriminatory, pursuant to subsection (1)(d).~~

15 (5) At the end of the 30-day period described in subsection (4), if the insurer implements a rate that the  
16 commissioner has determined to be excessive, inadequate, or unjustified, ~~or unfairly discriminatory~~, the  
17 commissioner shall publish the finding on the commissioner's website indicating the commissioner's

21 (2) The commissioner shall by rule establish the timing and manner of the premium adjustments. Every  
22 entity providing medicare supplement policies or certificates in this state shall annually file with the commissioner  
23 its rates, rating schedule, and supporting documentation demonstrating that it is in compliance with the applicable  
24 loss ratio standards of this part. An entity transacting medicare supplement insurance in this state may not adjust  
25 its rates more than twice a year and may not adjust its rates for the first year a policy is in force, except to allow  
26 for changes in federal laws or regulations relating to medicare. Each filing of rates and rating schedules must  
27 demonstrate that the actual and expected losses in relation to premiums complies with the requirements of this  
28 part.

29 (3) An entity may not provide compensation to its insurance producers that is greater than the renewal  
30 compensation that would be paid on an existing policy or certificate if:

- 1 (a) the existing policy or certificate were replaced by another policy or certificate with the same insurer  
2 and the new benefits are substantially similar to the benefits under the old policy or certificate; and  
3 (b) the old policy or certificate was issued by the same insurer or insurance group."

5 **Section 27.** Section 33-22-1815, MCA, is amended to read:

6 **"33-22-1815. Qualifications for voluntary purchasing pool.** A voluntary purchasing pool of disability  
7 insurance purchasers may be formed solely for the purpose of obtaining disability insurance upon compliance

9 (1) It contains at least 51 eligible employees.

10 (2) It establishes requirements for membership. The voluntary purchasing pool shall accept for

25 (b) ~~Except for the rates for the small business health insurance pool established in 33-22-2001, rates~~  
26 Rates for voluntary purchasing pool groups must be set pursuant to the provisions of 33-22-1809.

27 (c) At its discretion, premiums may be paid to the disability insurance policies, certificates, or contracts  
28 by the voluntary purchasing pool or by member employers.

29 (7) A person marketing disability insurance policies, certificates, or contracts for a voluntary purchasing  
30 pool must be licensed as an insurance producer."

14 the commissioner to transact the business of insurance in this state through a business unit with a principal place

16 (6) "Branch operations" means any business operations of a branch captive insurance company in this

18 (7) (a) "Business entity" means a corporation, limited liability company, ~~partnership, limited partnership,~~

20 (b) The term does not include a sole proprietor.

21 (8) "Captive insurance company" means any pure captive insurance company, association captive

6 ~~agreement~~, a subscribers' agreement, a charter, or any other document that establishes a business entity.

7 (23) "Parent" means a sole proprietorship, business entity, or individual that directly or indirectly owns,  
8 controls, or holds with power to vote more than 50% of the outstanding voting securities of a captive insurance

10 (24) "Participant" means a sole proprietorship or business entity and any affiliates that are insured by a  
11 protected cell captive insurance company in which the losses of the participant are limited through a participant  
12 contract to the participant's share of the assets of one or more protected cells identified in the participant contract.

13 (25) "Participant contract" means a contract by which a protected cell captive insurance company insures  
14 the risks of a participant and limits the losses of each participant in the contract.

25 **Section 37.** Section 33-31-401, MCA, is amended to read:

26 **"33-31-401. Examination.** (1) The commissioner may examine the affairs of a health maintenance  
 27 organization as often as is reasonably necessary to protect the interests of the people of this state. The  
 28 commissioner shall make an examination at least once every ~~3~~ 5 years. ~~The~~ Similarly, the commissioner shall  
 29 examine a health maintenance organization operated by an insurer or health service corporation as a plan at least  
 30 once every 5 years. The provisions of 33-1-408 and 33-1-409 apply to examinations under this section.

7 incurred on account of the examination the actual travel expenses, a reasonable living-expense allowance, and  
8 a per diem, all at reasonable rates customary therefor and as established or adopted by the commissioner. The  
9 commissioner may present an account periodically during the course of the examination or at the termination of  
10 the examination as the commissioner considers proper. A person may not pay and an examiner may not accept  
11 any additional emolument on account of any examination.

12 (b) If a health maintenance organization fails to pay the charges and expenses as referred to in  
13 subsection (3)(a), the commissioner shall pay them out of the funds of the commissioner in the same manner as  
14 other disbursements of funds. The amount paid is a lien upon all of the person's assets and property in this state  
15 and may be recovered by suit by the attorney general on behalf of the state and restored to the appropriate fund.

16 (4) In lieu of an examination, the commissioner may accept the report of an examination made by the  
17 commissioner of another state."

19 **Section 38.** Section 33-32-102, MCA, is amended to read:

20 "**33-32-102. Definitions.** As used in this chapter, the following definitions apply:

21 (1) "Adverse determination", except as provided in 33-32-402, means:

22 (a) a determination by a health insurance issuer or its designated utilization review organization that,  
23 based on the provided information and after application of any utilization review technique, a requested benefit  
24 under the health insurance issuer's health plan is denied, reduced, or terminated or that payment is not made in  
25 whole or in part for the requested benefit because the requested benefit does not meet the health insurance  
26 issuer's requirement for medical necessity, appropriateness, health care setting, level of care, or level of  
27 effectiveness or is determined to be experimental or investigational;

28 (b) a denial, reduction, termination, or failure to provide or make payment in whole or in part for a  
29 requested benefit based on a determination by a health insurance issuer or its designated utilization review  
30 organization of a person's eligibility to participate in the health insurance issuer's health plan;

- 1 (c) any prospective review or retrospective review of a benefit determination that denies, reduces, or  
2 terminates or fails to provide or make payment in whole or in part for a benefit; or  
3 (d) a rescission of coverage determination.
- 4 (2) "Ambulatory review" means a utilization review of health care services performed or provided in an  
5 outpatient setting.
- 6 (3) "Authorized representative" means:  
7 (a) a person to whom a covered person has given express written consent to represent the covered  
8 person;  
9 (b) a person authorized by law to provided substituted consent for a covered person; or  
10 (c) a family member of the covered person or the covered person's treating health care provider only if  
11 the covered person is unable to provide consent.
- 12 (4) "Case management" means a coordinated set of activities conducted for individual patient  
13 management of serious, complicated, protracted, or otherwise complex health conditions.
- 14 (5) "Certification" means a determination by a health insurance issuer or its designated utilization review  
15 organization that an admission, availability of care, continued stay, or other health care service has been  
16 reviewed and, based on the information provided, satisfies the health insurance issuer's requirements for medical  
17 necessity, appropriateness, health care setting, level of care, and level of effectiveness.
- 18 (6) "Clinical peer" means a physician or other health care provider who:  
19 (a) holds a nonrestricted license in a state of the United States; and  
20 (b) is trained or works in the same or a similar specialty to the specialty that typically manages the  
21 medical condition, procedure, or treatment under review.
- 22 (7) "Clinical review criteria" means the written screening procedures, decision abstracts, clinical  
23 protocols, and practice guidelines used by a health insurance issuer to determine the necessity and  
24 appropriateness of health care services.
- 25 (8) "Concurrent review" means a utilization review conducted during a patient's stay or course of  
26 treatment in a facility, the office of a health care professional, or another inpatient or outpatient health care setting.
- 27 (9) "Cost sharing" means the share of costs that a covered member pays under the health insurance  
28 issuer's health plan, including maximum out-of-pocket, deductibles, coinsurance, copayments, or similar charges,  
29 but does not include premiums, balance billing amounts for out-of-network providers, or the cost of noncovered  
30 services.



1 (10) "Covered benefits" or "benefits" means those health care services to which a covered person is  
2 entitled under the terms of a health plan.

3 (11) "Covered person" means a policyholder, a certificate holder, a member, a subscriber, an enrollee,  
4 or another individual participating in a health plan.

5 (12) "Discharge planning" means the formal process for determining, prior to discharge from a facility,  
6 the coordination and management of the care that a patient receives after discharge from a facility.

7 (13) "Emergency medical condition" has the meaning provided in 33-36-103.

8 (14) "Emergency services" has the meaning provided in 33-36-103.

9 (15) "External review" describes the set of procedures provided for in Title 33, chapter 32, part 4.

10 (16) "Final adverse determination" means an adverse determination involving a covered benefit that has  
11 been upheld by a health insurance issuer or its designated utilization review organization at the completion of the  
12 health insurance issuer's internal grievance process as provided in Title 33, chapter 32, part 3.

13 (17) "Grievance" means a written complaint or an oral complaint if the complaint involves an urgent care  
14 request submitted by or on behalf of a covered person regarding:

15 (a) availability, delivery, or quality of health care services, including a complaint regarding an adverse  
16 determination made pursuant to utilization review;

17 (b) claims payment, handling, or reimbursement for health care services; or

18 (c) matters pertaining to the contractual relationship between a covered person and a health insurance  
19 issuer.

20 (18) "Health care provider" or "provider" means a person, corporation, facility, or institution licensed by  
21 the state to provide, or otherwise lawfully providing, health care services, including but not limited to:

22 (a) a physician, physician assistant, health care facility as defined in 50-5-101, osteopath, dentist, nurse,  
23 optometrist, chiropractor, podiatrist, physical therapist, psychologist, licensed social worker, speech pathologist,  
24 audiologist, licensed addiction counselor, or licensed professional counselor; and

25 (b) an officer, employee, or agent of a person described in subsection (18)(a) acting in the course and  
26 scope of employment.

27 (19) "Health care services" means services for the diagnosis, prevention, treatment, cure, or relief of a  
28 health condition, illness, injury, or disease.

29 (20) "Health insurance issuer" has the meaning provided in 33-22-140.

30 (21) "Network" means the group of participating providers providing services to a managed care plan.

1 (22) "Participating provider" means a health care provider who, under a contract with a health insurance  
2 issuer or with its contractor or subcontractor, has agreed to provide health care services to covered persons with  
3 the expectation of receiving payment, other than coinsurance, copayments, or deductibles, directly or indirectly  
4 from the health insurance issuer.

5 (23) "Person" means an individual, a corporation, a partnership, an association, a joint venture, a joint  
6 stock company, a trust, an unincorporated organization, or any similar entity or combination of entities in this  
7 subsection.

8 (24) "Prospective review" means a utilization review conducted prior to an admission or a course of  
9 treatment.

10 (25) (a) "Rescission" means a cancellation or the discontinuance of coverage under a health plan that  
11 has a retroactive effect.

12 (b) The term does not include a cancellation or discontinuance under a health plan if the cancellation  
13 or discontinuance of coverage:

14 (i) has only a prospective effect; or

15 (ii) is effective retroactively to the extent that the cancellation or discontinuance is attributable to a failure  
16 to timely pay required premiums or contributions toward the cost of coverage.

17 (26) (a) "Retrospective review" means a review of medical necessity conducted after services have been  
18 provided to a covered person.

19 (b) The term does not include the review of a claim that is limited to an evaluation of reimbursement  
20 levels, veracity of documentation, accuracy of coding, or adjudication for payment.

21 (27) "Second opinion" means an opportunity or requirement to obtain a clinical evaluation by a health care  
22 provider other than the one originally making a recommendation for a proposed health care service to assess the  
23 clinical necessity and appropriateness of the initial proposed health care service.

24 (28) "Stabilize" means, with respect to an emergency condition, to ensure that no material deterioration  
25 of the condition is, within a reasonable medical probability, likely to result from or occur during the transfer of the  
26 individual from a facility.

27 (29) (a) "Urgent care request" means a request for a health care service or course of treatment with  
28 respect to which the time periods for making a nonurgent care request determination could:

29 (i) seriously jeopardize the life or health of the covered person or the ability of the covered person to  
30 regain maximum function; or

1 (ii) subject the covered person, in the opinion of a ~~physician~~ health care provider with knowledge of the  
 2 covered person's medical condition, to severe pain that cannot be adequately managed without the health care  
 3 service or treatment that is the subject of the request.

4 (b) Except as provided in subsection (29)(c), in determining whether a request is to be treated as an  
 5 urgent care request, an individual acting on behalf of the health insurance issuer shall apply the judgment of a  
 6 prudent lay person who possesses an average knowledge of health and medicine.

7 (c) Any request that a ~~physician~~ health care provider with knowledge of the covered person's medical  
 8 condition determines is an urgent care request within the meaning of subsection (29)(a) must be treated as an  
 9 urgent care request.

10 (30) "Utilization review" means a set of formal techniques designed to monitor the use of or to evaluate  
 11 the clinical necessity, appropriateness, efficacy, or efficiency of health care services, procedures, or settings.  
 12 Techniques may include ambulatory review, prospective review, second opinions, certification, concurrent review,  
 13 case management, discharge planning, or retrospective review.

14 (31) "Utilization review organization" means an entity that conducts utilization review, other than a health  
 15 insurance issuer performing a review for its own health plans."  
 16

17 **Section 39.** Section 33-32-103, MCA, is amended to read:

18 **"33-32-103. Utilization review plan.** An entity covered under the provisions of this chapter may not  
 19 conduct a utilization review of health care services provided or to be provided to a patient covered under a  
 20 contract or plan for health care services issued in this state unless that entity, at all times, maintains and can  
 21 provide at the commissioner's request ~~with the commissioner~~ a current utilization review plan that includes:

22 (1) a description of review criteria, standards, and procedures to be used in evaluating proposed or  
 23 delivered health care services that, to the extent possible, must:

24 (a) be based on nationally recognized criteria, standards, and procedures;

25 (b) reflect community standards of care, except that a utilization review plan for health care services  
 26 under the medicaid program provided for in Title 53 need not reflect community standards of care;

27 (c) ensure quality of care; and

28 (d) ensure access to needed health care services;

29 (2) policies and procedures to ensure that a representative of the entity conducting the utilization review  
 30 is reasonably accessible to patients and health care providers at all times;

- 1 (3) policies and procedures to ensure compliance with all applicable state and federal laws to protect  
2 the confidentiality of individual medical records;
- 3 (4) a copy of the materials designed to inform applicable patients and health care providers of the  
4 requirements of the utilization review plan; and
- 5 (5) any other information that may be required by the commissioner that is necessary to implement this  
6 chapter."

8 **Section 40.** Section 33-32-403, MCA, is amended to read:

9 **"33-32-403. Notice of right to external review.** (1) A health insurance issuer shall:

10 (a) notify the covered person or, if applicable, the covered person's authorized representative in writing  
11 of the covered person's right to request an external review pursuant to 33-32-410, 33-32-411, or 33-32-412; and

12 (b) include the appropriate statements and information described in subsection (4) at the same time that  
13 the health insurance issuer sends written notice of:

14 (i) an adverse determination upon completion of the health insurance issuer's utilization review process  
15 described in Title 33, chapter 32, part 2; and

16 (ii) a final adverse determination.

17 (2) The health insurance issuer shall include in the written notice required under subsection (1) the  
18 following, or substantially equivalent, language:

19 "We have denied your request for the provision of or payment for a health care service or course of  
20 treatment. You have the right to have our decision reviewed by health care professionals who have no association  
21 with us if our decision involved making a judgment as to the medical necessity, appropriateness, health care  
22 setting, level of care, or level of effectiveness of the health care service or treatment you requested. You may  
23 exercise this right by submitting a request for external review to us [insert address and telephone number of the  
24 unit of the health insurance issuer that administers the external review program]."

25 (3) (a) The commissioner may prescribe the form and content of the notice required under this section.

26 (b) The notice must also include the following information:

27 (i) information sufficient to identify the claim involved, including the date of service, the health care  
28 provider, and, if applicable, the claim amount; and

29 (ii) a statement describing the availability, upon request, of the diagnosis code and its corresponding  
30 meaning and the treatment code and its corresponding meaning. On receiving a request for a diagnosis or

1 treatment code, the health insurance issuer shall provide the information as soon as practicable. A health  
2 insurance issuer may not consider a request for the diagnosis code and treatment information, in itself, to be a  
3 request for an external review as outlined in this part.

4 (4) The health insurance issuer shall include in the notice required under subsection (1) a statement that:

5 (a) for a notice related to an adverse determination:

6 (i) the covered person or, if applicable, the covered person's authorized representative may file a  
7 grievance under the health insurance issuer's internal grievance process provided for in 33-32-308;

8 (ii) if the health insurance issuer has not issued a written decision to the covered person or the covered  
9 person's authorized representative within the time period provided in 33-32-308 or 33-32-309, as applicable, after  
10 the date the covered person or the covered person's authorized representative files the grievance with the health  
11 insurance issuer and the covered person or the covered person's authorized representative has not requested  
12 or agreed to a delay, the covered person or the covered person's authorized representative may file a request  
13 for external review pursuant to 33-32-404. Under those conditions, the covered person or the covered person's  
14 authorized representative is considered to have exhausted the health insurance issuer's internal grievance  
15 process for the purposes of 33-32-307.

16 (iii) the covered person or the covered person's authorized representative may file a request for an  
17 expedited external review to be conducted pursuant to 33-32-411 or 33-32-412, as applicable, under the following  
18 circumstances:

19 (A) a review under 33-32-411 may be requested if the covered person has a medical condition with  
20 regard to which the timeframe for completion of an expedited grievance review of an adverse determination would  
21 seriously jeopardize the life or health of the covered person or would jeopardize the covered person's ability to  
22 regain maximum function; and

23 (B) a review under 33-32-412 may be requested if the adverse determination involves a denial of  
24 coverage based on a determination that the recommended or requested health care service or treatment is  
25 experimental or investigational and the covered person's treating health care provider certifies in writing that the  
26 recommended or requested health care service or treatment that is the subject of the adverse determination  
27 would be significantly less effective if not promptly initiated. The physician's health care provider's certification  
28 must be submitted at the same time that the covered person or the covered person's authorized representative  
29 files a request for an expedited review of a grievance involving an adverse determination. However, the  
30 independent review organization assigned to conduct the expedited external review is responsible for determining

1 whether the covered person is required to complete the expedited review of the grievance before the expedited  
2 external review can begin.

3 (iv) informs the covered person or the covered person's authorized representative of the other exhaustion  
4 methods listed in 33-32-405;

5 (b) for a notice related to a final adverse determination, the covered person or the covered person's  
6 authorized representative may file a request for:

7 (i) an expedited external review under 33-32-411 if the covered person has a medical condition for which  
8 the timeframe for completion of a standard external review under 33-32-410 would seriously jeopardize the life  
9 or health of the covered person or would jeopardize the covered person's ability to regain maximum function;

10 (ii) an expedited external review under 33-32-411 if the covered person has received emergency services  
11 and has not been discharged from a facility and the request concerns an admission, the availability of care, a  
12 continued stay, or a health care service for which the covered person received emergency services;

13 (iii) a standard external review under 33-32-412 if the denial of coverage was based on a determination  
14 that the recommended or requested health care service or treatment is experimental or investigational; or

15 (iv) an expedited external review under 33-32-412 if a covered person to which subsection (4)(b)(iii)  
16 applies attaches a written certification from the covered person's treating health care provider that the  
17 recommended or requested health care service or treatment that is the subject of the request would be  
18 significantly less effective if not promptly initiated.

19 (5) In addition to the information to be provided in subsections (1) and (2), the health insurance issuer  
20 shall:

21 (a) include a description of both the standard and the expedited external review procedures as required  
22 by the disclosure requirements under 33-32-423, highlighting the provisions in the external review procedures  
23 that give the covered person or, if applicable, the covered person's authorized representative the opportunity to  
24 submit additional information and including any forms used to process an external review; and

25 (b) state that the commissioner's office is available to assist covered persons with the external review  
26 process. This statement must include the commissioner's contact information.

27 (6) Among the forms provided under this section, the health insurance issuer shall include an  
28 authorization form or other document approved by the commissioner that complies with the requirements of 45  
29 CFR 164.508 and 33-19-206, by which the covered person, for purposes of conducting an external review under  
30 this part, authorizes the health insurance issuer and the covered person's treating health care provider to disclose

1 protected health information, including medical records, concerning the covered person for the purposes of the  
2 external review."

3

4 **Section 41.** Section 33-32-410, MCA, is amended to read:

5 **"33-32-410. Standard external review.** (1) Within ~~4 months~~ 120 days after the date of receipt of a notice  
6 of an adverse determination or a final adverse determination pursuant to 33-32-403, a covered person or, if  
7 applicable, the covered person's authorized representative may file a request for an external review with the  
8 health insurance issuer.

9 (2) Within 5 business days after the date of receipt of the external review request, the health insurance  
10 issuer shall complete a preliminary review of the request to determine whether:

11 (a) the individual is or was a covered person in the health plan at the time the health care service or  
12 treatment was requested or, in the case of a retrospective review, was a covered person in the health plan at the  
13 time the health care service or treatment was provided;

14 (b) the health care service or treatment that is the subject of the adverse determination or the final  
15 adverse determination is a covered service under the covered person's health plan but is not covered because  
16 of a determination by the health insurance issuer that the health care service or treatment does not meet the  
17 health insurance issuer's requirements for medical necessity, appropriateness, health care setting, level of care,  
18 or level of effectiveness;

19 (c) the covered person has exhausted the health insurance issuer's internal grievance process as set  
20 forth in Title 33, chapter 32, part 3, or the covered person is exempt under 33-32-307(2); and

21 (d) the covered person or the covered person's authorized representative has provided all of the  
22 information and forms required to process an external review.

23 (3) (a) Within 1 business day after completion of the preliminary review, the health insurance issuer shall  
24 notify the covered person or, if applicable, the covered person's authorized representative in writing as to whether:

25 (i) the request is complete; and

26 (ii) the request is eligible for external review.

27 (b) (i) If the request is not complete, the health insurance issuer shall inform the covered person or, if  
28 applicable, the covered person's authorized representative in writing and include in the notice the information or  
29 materials that are needed to make the request complete.

30 (ii) If the request is not eligible for external review, the health insurance issuer shall inform the covered

1 person or, if applicable, the covered person's authorized representative in writing and include in the notice the  
2 reasons for the request's ineligibility.

3 (4) (a) The commissioner may specify the form for the health insurance issuer's notice of initial  
4 determination under subsection (3) and any supporting information to be included in the notice.

5 (b) The notice of initial determination provided under subsection (3) must include a statement informing  
6 the covered person or, if applicable, the covered person's authorized representative of the right to appeal to the  
7 commissioner a health insurance issuer's initial determination that the external review request is ineligible for  
8 review.

9 (5) (a) If the commissioner receives an appeal under subsection (4), the commissioner may require a  
10 referral for external review, notwithstanding a health insurance issuer's initial determination that the request is  
11 ineligible.

12 (b) A determination by the commissioner under subsection (5)(a) must be based on the terms of the  
13 covered person's health plan and all applicable provisions of Title 33, chapter 32, parts 2 through 4.

14 (6) (a) If the request is eligible for external review, the health insurance issuer shall within 1 business  
15 day assign an independent review organization on a random basis, or using another method of assignment that  
16 ensures the independence and impartiality of the assignment process, from the list of approved independent  
17 review organizations compiled and maintained by the commissioner pursuant to 33-32-416 to conduct the  
18 external review.

19 (b) In making the assignment, the health insurance issuer shall consider whether an independent review  
20 organization is qualified to conduct the particular external review based on the nature of the health care service  
21 or treatment that is the subject of the adverse determination or final adverse determination.

22 (c) The health insurance issuer shall also take into account other circumstances, including conflict of  
23 interest concerns pursuant to 33-32-417(4).

24 (7) The assigned independent review organization, in reaching its decision, is not bound by any  
25 decisions or conclusions reached during the health insurance issuer's utilization review process set forth in Title  
26 33, chapter 32, part 2, or the health insurance issuer's internal grievance process set forth in Title 33, chapter 32,  
27 part 3.

28 (8) Within 1 business day of assigning an independent review organization pursuant to subsection (6),  
29 the health insurance issuer shall notify, in writing, the covered person or, if applicable, the covered person's  
30 authorized representative that the health insurance issuer initiated an external review.



1           (9) The health insurance issuer shall include in the notice provided to the covered person or, if  
2 applicable, the covered person's authorized representative a statement that the covered person or the covered  
3 person's authorized representative may submit in writing to the assigned independent review organization within  
4 10 business days following the date of receipt of the notice provided pursuant to subsection (8) any additional  
5 information for the independent review organization to consider when conducting the external review. The  
6 independent review organization shall accept and consider information submitted within 10 business days after  
7 the date of receipt of the notice and may accept and consider additional information submitted after the 10  
8 business days.

9           (10) Within 5 business days after assigning an independent review organization pursuant to subsection  
10 (6), the health insurance issuer or its designated utilization review organization shall provide to the assigned  
11 independent review organization the medical records, documents, and any information used in making the  
12 adverse determination or final adverse determination.

13           (11) Except as provided in subsection (12), failure by the health insurance issuer or its designated  
14 utilization review organization to provide the documents and information within the time specified in subsection  
15 (10) may not delay the conduct of the external review.

16           (12) (a) If the health insurance issuer or its designated utilization review organization fails to provide the  
17 documents and information within the time specified in subsection (10), the assigned independent review  
18 organization may terminate the external review and make a decision to reverse the adverse determination or final  
19 adverse determination.

20           (b) Within 1 business day after making a decision under subsection (12)(a), the independent review  
21 organization shall notify the covered person or, if applicable, the covered person's authorized representative as  
22 well as the health insurance issuer.

23           (13) If the provisions of subsection (12) do not apply, the assigned independent review organization shall  
24 review all of the information and documents received pursuant to subsection (10) and any other information  
25 submitted in writing to the independent review organization by the covered person or, if applicable, the covered  
26 person's authorized representative pursuant to subsection (9).

27           (14) On receipt of any information submitted by the covered person or, if applicable, the covered person's  
28 authorized representative pursuant to subsection (9), the assigned independent review organization shall within  
29 1 business day after receipt forward the information to the health insurance issuer.

30           (15) On receipt of the information, if any, forwarded as provided in subsection (14), the health insurance

1 issuer may reconsider its adverse determination or final adverse determination that is the subject of the external  
2 review.

3 (16) Reconsideration by the health insurance issuer of its adverse determination or final adverse  
4 determination pursuant to subsection (15) may not delay or terminate the external review.

5 (17) The external review may be terminated only if the health insurance issuer decides, on completion  
6 of its reconsideration, to reverse its adverse determination or final adverse determination and provide coverage  
7 or payment for the health care service or treatment that is the subject of the adverse determination or final  
8 adverse determination.

9 (18) (a) Within 1 business day after making a decision to reverse its adverse determination or final  
10 adverse determination, as provided in subsection (17), the health insurance issuer shall notify the following in  
11 writing of its decision:

12 (i) the covered person or, if applicable, the covered person's authorized representative; and

13 (ii) the assigned independent review organization.

14 (b) The assigned independent review organization shall terminate the external review on receipt of the  
15 notice from the health insurance issuer sent pursuant to subsection (18)(a).

16 (19) In addition to the documents and information provided pursuant to subsection (10), the assigned  
17 independent review organization shall consider the following information and documents in making a decision,  
18 to the extent the information or documents are available:

19 (a) the covered person's medical records;

20 (b) the attending health care professional's recommendation;

21 (c) consulting reports from appropriate health care professionals and other documents submitted by the  
22 health insurance issuer, the covered person, the covered person's authorized representative, or the covered  
23 person's treating health care provider;

24 (d) the terms of coverage under the covered person's health plan with the health insurance issuer to  
25 ensure that the independent review organization's decision is not contrary to the terms of coverage under the

8 (b) the health insurance issuer.

9 (21) The independent review organization shall include in the notice sent pursuant to subsection (20):

10 (a) a general description of the reason for the request for the external review;

11 (b) the date the independent review organization received the assignment from the health insurance  
12 issuer to conduct the external review;

13 (c) the time period over which the external review was conducted;

14 (d) the date of the independent review organization's decision;

10 **"33-32-417. Minimum qualifications for independent review organizations.** (1) To be approved to

11 conduct external reviews as provided in 33-32-416, an independent review organization shall establish and

12 maintain written policies and procedures that govern all aspects of both the standard external review process and

13 the expedited external review process set forth in 33-32-410 through 33-32-412. The written policies and

14 procedures must include, at a minimum:

15 (a) a quality assurance mechanism that ensures:

16 (i) that external reviews are conducted within the specified timeframes and that required notices are

 24 (e) ~~funding new programs to assist eligible small employers with the costs of providing health insurance~~

 26 ~~\_\_\_\_\_ (f) the cost of administering the tax credit, the purchasing pool, and the premium incentive payments and~~  
 27 ~~premium assistance payments as provided in Title 33, chapter 22, part 20; and~~  
 28 ~~\_\_\_\_\_ (g) providing a state match for the medicaid program for premium incentive payments or premium~~  
 29 ~~assistance payments to the extent that a waiver is granted by federal law as provided in 53-2-216.~~  
 30 (4) (a) On or before July 1, the budget director shall calculate a balance required to sustain each

1 program in subsection (3) for each fiscal year of the biennium. If the budget director certifies that the reserve  
 2 balance will be sufficient, then the agencies may expend the revenue for the programs as appropriated. If the  
 3 budget director determines that the reserve balance of the revenue will not support the level of appropriation, the  
 4 budget director shall notify each agency. Upon receipt of the notification, the agency shall adjust the operating  
 5 budget for the program to reflect the available revenue as determined by the budget director.

6 (b) Until the programs or credits described in subsections (3)(b) and (3)(d) ~~through (3)(g)~~ are established,  
 7 the funding must be used exclusively for the purposes described in subsections (3)(a) and (3)(c).

8 (5) The phrase "trended traditional level of appropriation", as used in subsection (3)(c), means the  
 9 appropriation amounts, including supplemental appropriations, as those amounts were set based on eligibility  
 10 standards, services authorized, and payment amount during the past five biennial budgets.

11 (6) The department of public health and human services may adopt rules to implement this section."
