THE DEPARTMENT SHALL REPORT TO THE LEGISLATIVE FINANCE COMMITTEE BY DECEMBER 31, 2019, ON THE NUMBER OF FILES REVIEWED AND THE NUMBER OF PROBATIONERS AND PAROLEES ELIGIBLE FOR CONDITIONAL DISCHARGE FROM SUPERVISION. FUNDING MAY BE EXPENDED ONLY AFTER THE BUDGET DIRECTOR CERTIFIES THAT THE DEPARTMENT HAS COMPLETED THE EVALUATION OF ALL PAROLE FILES AND HAS NOTIFIED ALL ELIGIBLE PROBATIONERS AND PAROLEES"**.
