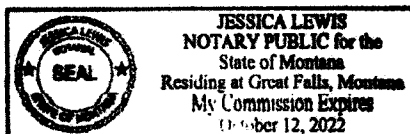

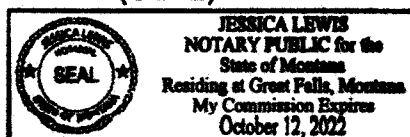

## **Complaint form from Sheridan Buck and J.C. Kantorowicz**

### **STATEMENT OF FACTS:**

The individuals listed on the Complaint Form (Page 2) constitute the "Shadow Group" who erroneously portrayed themselves as the Cascade County Republican Central Committee. They conducted business transactions, had expenditures, and clearly operated as a PAC that may have supported candidates during the 2018 election in Cascade County. They did these things all without ever filing any of the required paperwork with Montana COPP or the Montana Secretary of State's Office. Refer to Exhibits 12-25.

Each political committee must appoint a committee treasurer, 13-37-201 and 203, MCA and Cindy Ingman is listed as the Treasurer while Ed Buttrey is listed as the Finance Chair. The name of the treasurer must be certified to the Commissioner of Political Practices on Form C-2, 13-37-201, MCA. To date they have not filed a C-2 form. The treasurer is prohibited from performing any duty until a certification statement is filed, 13-37-203, MCA. Also, only an appointed and certified treasurer or an appointed and certified deputy treasurer may make deposits to or draw funds on the political committee account, 44.11.409, ARM. Refer to Exhibit 1.

The treasurer must keep detailed accounts that must be current within not more than 10 days after the date of receiving a contribution or making an expenditure, except that accounts shall be current as of the 5th day before the date of filing a report. . . 13-37- 208(1), MCA. Refer to Exhibit 1.

In addition to the accounting and reporting duties required by law, the treasurer for a political committee is required to preserve committee accounts and reports for a minimum of four years or for the length of the term of office, whichever is longer, 13-37- 208(3), MCA and 13-37-231(2), MCA. Refer to Exhibit 1.

Exhibit 2 (Pages 15-16) indicate that a packet of information was reproduced and mailed to 28 individuals. Exhibits 3-11 will prove that expenses were incurred but no paper trail exists indicating where the money came from or who had the authority to expend those funds. With no financial reporting to COPP, it is unknown if any donations were received or if any funds were collected from unwitting donors who thought they were donating to the legitimate Cascade County Republican Central Committee (CCRCC) possibly perpetrating fraud.

Each political committee must designate one primary depository. This depository may be a bank, a credit union, a savings and loan association, or a building and loan association; however, this depository must be authorized to transact business in Montana and must offer accounts on which the equivalent of a check may be drawn. Accounts must be completely separate from any personal accounts, 13-37-205, MCA, although they may be in the same depository. To date they have not provided this information to COPP. All monetary receipts shall be deposited in the political committee account and that all money spent by the political committee be by checks, debit card, wire transfer, or other electronic means drawn on this account, 44.11.409(4), ARM.

Immediately after designating or changing a primary depository and after appointing a treasurer, a political committee must complete and file a Statement of Organization (Form C-2) with the Commissioner of Political Practices, 13-37-201, MCA. This was clearly NOT done by the Shadow Group.

## **Complaint form from Sheridan Buck and J.C. Kantorowicz**

In addition, before making a deposit to the political committee account, the treasurer is required to prepare a statement of amounts received from each contributor, 13-37-207(2), MCA. This statement, all cash receipts, and the deposit slip must be kept together as part of the committee records maintained by the treasurer.

Receipts must be written for any contributions of currency and coin of \$25 or more. Cash receipts must show: • The contributor's full name • Complete mailing address • Occupation • Employer • The exact amount received • Date of receipt, and • The name of the individual who received the contribution on behalf of the committee, 44.11.407, ARM. Clearly this was not done.

In-kind contributions must be accounted for and reported in the same manner as other contributions. The in-kind item or service must be identified in detail. Documents provided with this complaint clearly show that former Senator Ed Buttrey (now Representative Buttrey) provided a meeting location on numerous occasions, yet did not show any of this "in-kind" activity on his financial reports. (see attached). 44.11.403, ARM (1) A candidate or political committee shall report an in-kind contribution on the appropriate reporting schedule and shall describe what was received consistent with the reporting requirements specified in ARM 44.11.402. Please refer to Exhibit 4 and Exhibit 5.

Anonymous contributions are illegal in Montana, 13-37-217, MCA. All contributions are required to have a source. A contribution is defined by law, in part, as "an advance, gift, loan, conveyance, deposit, payment, or distribution of money or anything of value to support or oppose a candidate or ballot issue. . ." 13-1-101(9), MCA. In other words, "pass the hat" types of donations are prohibited.

It is unclear if money laundering is an intent of this group, since it is unknown exactly how much money went through their coffers. Use of an intermediary to pass funds along from a third party as a means of concealing the identity of the true donor is illegal. A campaign may not knowingly accept a contribution in a name other than that of the person who is the actual contributor, 13-37-217, MCA.

Are there any debts or obligations outstanding? All debt or obligations must be in writing at the time it is incurred and must be signed by the parties and retained for inspection. (44.11.506, ARM)

Were any donations made to specific candidates by this Shadow Group?

A number of email communications were sent by the Shadow Group without proper attribution. Please note, that the impostors actually tried to steal the identity of a legitimate group which not only is cause for concern financially, but also presented problems during the election to the Cascade County Election Office and Rina Fontana-Moore, Clerk and Recorder. Refer to Exhibits 12-26.

Exhibits 26-28 provide documentation from the Montana State GOP acknowledging the Shadow Group is not the legitimate CCRCC.

It's appalling to think that seasoned legislators such as Representative Ed Buttrey, former Representative Roger Hagan, Senator Brian Hoven, Representative Wendy McKamey, Senator Steve Fitzpatrick, Representative Fred Anderson, and others associated with this Shadow



No person who was previously appointed to a precinct committee member position is eligible to vote at the June 26<sup>th</sup> Central Committee meeting.

Under Montana Law, a vacancy in a precinct committee representative position must be filled by the party governing body as provided in its rules [Section 13-38-201(5), MCA].

Under the rules of the Montana Republican Party, a person can only be appointed to a precinct position after the primary election is conducted (Montana Republican Party Rules, Section C, Committees, III. B. ii). The rule states the following:

Appointment. If no candidate is elected under (i), following the election the County Central Committee may appoint a person to that position.

The appointment must be made during a meeting of the Central Committee (Montana Republican Party Rules, Section H., Vacancies).


Since there has not been a meeting of the Central Committee since the June 5, 2018 election, no person could have been appointed to a precinct position. Dear Sheridan:

I wanted to follow up and discuss with you the meeting of committeemen and committeewomen that occurred on June 26, 2018. At 6:01 on June 26, 2018, Mr. Polaski stood up and stated he was parliamentarian and indicated he was calling the meeting to order. He stated you were going to act as the presiding officer during the meeting. He asked if anyone objected and I indicated I did. Then, Mr. Polaski told me I was being removed from the meeting. He also attempted to remove Roger Hagan from the meeting.

The conduct of Mr. Polaski was not authorized under Roberts Rules of Order or any applicable law or authority. Roberts Rules of Order specially states that a parliamentarian acts in an advisory capacity and his advice is not binding on the committee. A parliamentarian cannot run a meeting and make decisions about who may attend a meeting. Moreover, you did not follow the correct procedures outlined in Roberts Rules of Order for dealing with people who are not following procedure. Roberts Rules of Order contains specific requirements and you did not satisfy any of the requirements.

We all know the purpose of Mr. Polaski's conduct and your conduct was to stop the meeting and to prevent me and other precinct people from exercising our rights to appoint precinct people and a new executive board. Your conduct and the conduct of Mr. Polaski violated my rights and the rights of Mr. Hagan under the Montana Constitution, Montana state law, the rules of the Montana Republican Party, and the Rules of the Cascade County Republican Central Committee. It is disappointing you and the other former members of the executive board feel the need to shut down debate and to stop participation in a meeting.


The purpose of this letter is to advise you to preserve all videotape footage and other documentary evidence pertaining to the meeting. This includes all videotapes, audiotapes, emails, communications, written materials, or other documents which may pertain in anyway to the June 26, 2018 meeting. The videotape materials show you and Mr. Polaski engaged in conduct which violated my rights and the rights of Mr. Hagan. The videotape evidence also shows 21 people attended the meeting in the adjacent room where you and the other members of the executive board were removed. Depending upon the result of our appeal to the Montana Republican Party, litigation may be instituted against you and Mr. Polaski for the conduct at the meeting. If you fail to preserve these materials, an action may be brought against you for spoliation of evidence.

Thank you for your prompt response to the letter I dropped off at the party office last Wednesday. I am writing to appeal the decision rendered in the email you sent to me on June 29, 2018 and to ask for a determination as to the identity of the correct precinct people for the Cascade County Republican Central Committee. On June 28, 2018, I sent you a letter regarding various issues with the Cascade County Republican Central Committee. In the letter, I indicated I was making an appeal. In looking at your response, I think the proper procedure would be ask you for an initial determination first with regard to precinct people.

I would like a determination as to whether Lori Badgley, Michael Badgley, Bill Davis, Vicky Jo Reeves, and Keith Reeves were properly appointed to precinct positions because the appointments occurred prior to the primary election. Under Section C Committees, III Central Committees, B. Selection of Precinct Committeemen and Committeewomen, the rules plainly state "If no candidate is elected under (i), following the election the County Central Committee may appoint a person to that position."

All the people identified above were supposedly appointed to these positions prior the primary election. There is no way any of these people could be appointed prior to the primary election and carryover post-primary. Under party rules, a term for committeeman or committeewoman is no greater than 2 years or the next primary election. If these people were appointed prior to the election they would have been appointed to a term longer than 2 years by the 2020 primary.

Additionally, I would like a determination as to whether Carol Wells was appointed to precinct position 19A3. On June 26, 2018, we held a meeting and Ms. Wells was voted into the committeewoman position by a 20-0 vote with one person abstaining.

The explanation and basis for my request pertaining to these precinct positions is contained in my June 28, 2018 letter to you.

I would like to appeal your ruling that the current executive board cannot be changed. Under the rules of the party, each central committee may adopt its own rules as to the determination of membership on its executive committee. Section C Committees, III Central Committees, G. County Executive Committee. Under the rules of the Cascade County Republican Central Committee, the executive board serves at the pleasure of the precinct committeeman and precinct committeewoman and may be removed at any time. Article VI. Executive Board. I have mailed a copy of the local rules to you for your review in the June 26, 2018 letter.

I did not see anything in the state GOP rules that prohibited a local central committee from adopting rules that permitted local committeeman and committeewomen from removing and replacing the current executive board at time other than a convention. The Cascade County Republican Central Committee has authorized such a removal in its rules. As such, I would request that you give effect to the local rules and rule the executive board may be changed in Cascade County pursuant to its rules and was in fact changed at the meeting held on June 26, 2018.

Finally, I would like you to provide me with a copy of the June 23, 2018 amended By Laws you referred to in your reply as I am unable to secure them from the mtgop.org website.

Dear Chairwoman. Lamm,

**BACKGROUND:**

In June of 2018, Roger Hagan, a resident of Cascade County, requested that the State Chairman recognize a Cascade County Republican Central Committee ("CCRCC") Executive Board slate that was allegedly elected at a special meeting held that same month.

On or about June 29, 2018, in response to the aforementioned state rules appeal filed by Mr. Hagan, you, as Chairman, submitted a response to Mr. Hagan's request stating that the Montana Republican Party Bylaws ("State Party Rules") require the Montana State Republican Party ("State Party") to recognize those central committee officers elected during the county convention period stated in the State Party Rules. Further, you advised Mr. Hagan to resolve any dispute as to who are the proper officers at the county level, while noting that the next Cascade County Convention is required by state party rules to be held between February 1 and May 1 of 2019.

In turn, Mr. Hagan exercised his right under the State Party Rules to appeal the Chair's decision and State Party Rules interpretation. You referred Mr. Hagan's appeal to this State Party Rules Subcommittee.

The Subcommittee met in early August of this year to review Mr. Hagan's appeal. After that meeting, the Subcommittee requested that Mr. Hagan and Ms. Sheridan Buck, who was elected CCRCC Chair in May of 2017 each submit a 'legal type brief' outlining their respective positions on the Chairwoman's June 29, 2018, rules application and determination.

Those briefs were timely submitted by the end of August 2018. The members of the Subcommittee reviewed the copious amount of paper that was provided in this matter. And, in early November, the Subcommittee reconvened to deliberate on this matter and to render an opinion the merits of Mr. Hagan's rules appeal.

The Subcommittee was asked to determine if the county precinct committee persons appointed in April 2018 were validly appointed. The Subcommittee did not consider this issue as it is moot. Any precinct committee persons who were appointed prior to the primary election only held their positions until June 5, 2018, the date of Montana's 2018 primary election. *See id.* Sect. C.III.H. As clearly set forth in the State Party Rules, all county central committee vacancies existing after the 2018 primary election can only be filled during a properly called and noticed meeting with a quorum of precinct committee persons present. The chair of the next CCRCC convention held in accordance with the State Party Rules may not recognize the persons appointed at the April Meeting as voting members.

### CLOSING:

All this being stated, the Subcommittee agrees unanimously that the State Party Chairwoman was correct to point out in her challenged decision that it is not the State Party's role to be the arbiter of county central committee leadership and governance conflicts, nor is it the State Party's role to determine "which type" of Republicans are proper persons to file county party positions. Ultimately, it will be the job of the State Central Committee to determine who to recognize as having proper credentials.

As stated above, county central committees are associations separate and distinct from the State Party, but subject thereto. And, therefore, the determination of the validity of the actions of the CCRCC will be determined only at the next special or regular meeting of the State Central Committee.

As specifically stated under the State Party's rules, the CCRCC may adopt its own rules for the membership and function of the executive committee. *See id.* Sect. C.III.G. As a general matter, it is not the purpose of the Rules Committee of the MRP to determine who are the members of the executive committee or whether the CCRCC has complied with its own by-laws. Rather, as made clear by the Chairwoman, and as reinforced by this Subcommittee decision, the State Party's limited role in this proceeding has been to determine whether the State Party's own rules have been properly interpreted and applied. As noted above, the Subcommittee determines they have and, as such, the State Party should recognize, for State Party purposes, those CCRCC officers elected during the convention held on May 2, 2017, and whose names were given to the State Party on May 3, 2017.

### NOTICE AND ADVISEMENT

Under State Party Rules Sect. F, the parties may appeal this decision of the Rules Subcommittee to the full Rules Committee of the State Party. **The appeal must be filed within 10 days of the date the parties are given notice by the Chair of this decision.**

Further, the Rules Subcommittee suggests to the Chairwoman that, given the animosity between some members of the CCRCC, the Chair make herself or other trusted observers available to the CCRCC to serve as a neutral bystander and observer during the 2019 county convention process.

This being stated, the Subcommittee would remind the parties to this appeal and the CCRCC that another organizational convention to elect county officers is required to be held in early 2019, a few short months from now and must be held in compliance with Montana Code Annotated Section 13-38-205.

In his appeal, Mr. Hagan asserts that, regardless of the clear language of the State Party Rules, a new slate of county officers was allegedly elected at a meeting called in June of 2018 and should be so recognized by the State Party. Setting aside the fact that the State Party rules clearly state that the State Party will only recognize new county officers in the event of death, resignation, failure to maintain status of an elector of the county, or removal from the county (none of which circumstances present themselves here), *see id.* Sect. C.III.G the Subcommittee determines that the June 26, 2018 meeting suffered from multiple procedural infirmities and, thus, that meeting does not provide a legal basis to overturn the Chairman's challenged decision.

Under the materials presented, the Subcommittee determines, pursuant to Section C.III.I. of the State Party Rules, that the June 2018 meeting was properly called by a majority of the members of the CCRCC. However, under the clear terms of the CCRCC's own bylaws, the Chair is and was specifically tasked with chairing any and all properly called meetings of the CCRCC, such as the one at issue.

Under the facts presented to this Subcommittee, it is clear that, after the properly called CCRCC meeting of that date dissolved into chaos, the "hallway meeting" that took place immediately thereafter among some of the precinct persons was not a proper meeting of the CCRCC. This is because Chair Sheridan Buck adjourned the duly-called and properly-noticed meeting prior to the hallway meeting taking place. Under Roberts Rules of Order, which are incorporated into the County's own bylaws in Art. III, sect. F., Chair Sheridan Buck had the authority to close a meeting if no objection to the same was heard.

Based on the evidence presented, nobody objected to Chair Buck's action to adjourn the meeting and, therefore, any actions that were taken during the hallway meeting were improper and so void *ab initio*. What is more, any actions taken during the hallway meeting are also void because (1) that meeting was not properly noticed pursuant to the CCRCC's bylaws—the notice of special meeting published in the Great Falls Tribune on June 22, 2018, pertained to the meeting ultimately adjourned by Chair Buck, not to the subsequently held hallway meeting, and (2) County Chair Buck did not preside over the hallway meeting.

Mr. Hagan's appeal also requested an application of the State Party Rules regarding the appointment of vacancies in county committee precinct positions. The appointment of precinct committee persons is clearly explained in the State Party Rules in Section C.III.H:

Vacancies in the office of precinct committeeman or precinct committeewoman may be filled by a majority vote of the members of the County Central Committee present at a meeting called and noticed for that purpose. For the appointment to be effective, a quorum of duly elected and appointed precinct committeemen and committeewomen must be present at the meeting where a vacancy can be filled... Precinct committeemen and committeewomen hold such a position for a term of two years from the date of their election or in the case of an appointment until the next regularly scheduled primary election.

After discussing this matter extensively, for the reasons stated below, the Subcommittee agrees that the Chairwoman's decision of June 29, 2018 was correct and that, therefore, Mr. Hagan's appeal must be denied.

#### LEGAL PRINCIPLES & DECISION REASONING:

It is a truism that the Montana State Republican Party and the Cascade County Republican Central Committee are separate and distinct associations. *Eu v. San Francisco Cnty. Democratic Cent. Comm.*, 489 U.S. 214 (1989). As such, the CCRCC is free to organize and operate in any matter it so chooses, separate and distinct from the State Party, so long as the entity governs itself in a manner that is not inconstant with other authority.

The affairs of a given county central committee, including the CCRCC, are controlled principally by five authorities: (1) The Rules of the Republican National Committee, (2) the Rules of the Montana Republican Party, (3) the central committee's own governing document, (4) state law, and (5) Roberts Rules of Order (to the extent any of the above designate the Rules are to be followed).

The State Party Rules specifically provide that the State Party will recognize, for its own governance purposes, those central committee officers who were elected during county central committee conventions held between February 1 and May 1 in odd-numbered years. See Montana Republican Party Bylaws Sect. C.III.C..

Further, under the State Party Rules, after the county officers are elected at the county convention, the central committee submits its officer list to the State Party by May 6 of any odd-numbered year. See *id.* at Sect. C.III.F.

And, under the State Party's rules, the State Party must recognize, for its own governance purposes, county officers who are elected under this process for a term of two years unless a vacancy occurs at the county level because of death, resignation, failure to maintain status of an elector of the county, or removal from the county. *Id.* at Sect. C.III.G.

In her challenged decision, the Chairwoman correctly cited to and applied the above-recited State Party Rules for purposes of determining who the State Party recognizes as being the current officers of the CCRCC. As correctly noted by the Chair in her appealed decision, the CCRCC held a county convention in May of 2017 wherein the CCRCC's officers for the 2017-2019 time period were elected. And, subsequently, the CCRCC submitted to the State Party its list of officers for the 2017-2019 time period. Consequently, as correctly determined by the Chairwoman, those persons who were listed as CCRCC's officers in May of 2017 are those persons recognized by the State Party as CCRCC's officers for State Party purposes. Ultimately, the final decision on who will be recognized as the officers of the CCRCC will be the decision of the Credentials Committee at the next special or regular meeting of the State Central Committee, subject to the review of the entire State Central Committee.

Nothing in the materials submitted by Mr. Hagan demonstrates conclusively that the Chair misinterpreted the State Party Rules or misapplied them to the facts as presented. Therefore, the Subcommittee finds no basis upon which to recommend that Mr. Hagan's appeal be granted.




