NEW SECTION. Section 1. Hotline. (1) The department shall create and maintain a hotline to receive reports of suspected abuse of the provisions of this chapter.

(2) AN INDIVIDUAL MAKING A COMPLAINT MUST BE A RESIDENT AND SHALL PROVIDE THE INDIVIDUAL'S NAME, STREET ADDRESS, AND PHONE NUMBER.

(3) (A) THE DEPARTMENT SHALL PROVIDE A COPY OF THE COMPLAINT TO THE PERSON OR LICENSEE THAT IS THE SUBJECT OF THE COMPLAINT.

(B) THE DEPARTMENT MAY NOT REDACT THE INDIVIDUAL'S NAME OR CITY OF RESIDENCE FROM THE COMPLAINT COPY.)

~~(2)~~(4) The department may:

(a) investigate reports of suspected abuse of the provisions of this chapter; or

(b) refer reports of suspected abuse to the law enforcement agency having jurisdiction in the area where the suspected abuse is occurring.

NEW SECTION. Section 2. Department to conduct background checks. (1) In addition to any other requirement imposed under this chapter, before issuing any license under this chapter the department shall conduct:

(a) a fingerprint-based background check meeting the requirements for a fingerprint-based background check by the department of justice and the federal bureau of investigation in association with an application for initial licensure and every ~~3~~ 5 years thereafter; and

(b) a name-based background check in association with an application for initial licensure and each year thereafter except years that an applicant is required to submit fingerprints for a fingerprint-based background check.

(2) For the purpose of the background records check required under subsection (1), the department shall obtain fingerprints from each individual listed on an application submitted under this chapter and each individual who has a controlling beneficial ownership or financial interest in the license or prospective license, including:

(a) each partner of an applicant that is a limited partnership;

- 1 (b) each member of an applicant that is a limited liability company;
- 2 (c) each director and officer of an applicant that is a corporation;
- 3 (d) each individual who holds a 5% financial interest in the license applicant or is a controlling
- 4 beneficial owner of the person applying for the license; and
- 5 (e) each individual who is a partner, member, director, or officer of a legal entity that holds a 5%
- 6 financial interest in the license applicant or is a controlling beneficial owner of the person applying for the
- 7 license.

8 (3) (a) Except as provided in subsection (3)(b), an employee of a marijuana business shall undergo a

9 criminal background check prior to beginning employment.

10 (b) An employee of a former medical marijuana licensee in good standing with the department as of

11 [the effective date of this section] shall undergo a criminal background check within 90 days of [the effective

12 date of this section].

13 (4) The department may establish procedures for obtaining fingerprints for the fingerprint-based and

14 name-based background checks required under this section.

15

16 **NEW SECTION. Section 3. Licensing of marijuana transporters.** (1) (a) A marijuana transporter

17 license may be issued to a person to provide logistics, distribution, delivery, and storage of marijuana and

18 marijuana products. A marijuana transporter license is valid for 2 years. A licensed marijuana transporter is

19 responsible for the marijuana and marijuana products once it takes control of the marijuana or marijuana

20 product.

21 (b) A marijuana transporter may contract with multiple licensed marijuana businesses.

22 (c) On or after March 1, 2022, and except as otherwise provided in this section, all persons who

23 transport marijuana or marijuana products shall hold a valid marijuana transporter license. The department shall

24 begin accepting applications on or after January 1, 2022. The department may allow for a reasonable grace

25 period for complying with this requirement.

26 (d) The department shall establish by rule the requirements for licensure, and the applicable fee for a

27 marijuana transporter license or the renewal of a transporter license. The department may not license a person

28 to be a marijuana transporter if the applicant meets any of the criteria established for denial of a license under

1 16-12-203(2).

2 (2) A person who obtains a testing laboratory license and any other person who is not licensed under
3 this chapter must apply for and obtain a marijuana transporter license in order to transport marijuana or
4 marijuana products.

5 (3) A registered cardholder or consumer is not required to possess a marijuana transporter license
6 when purchasing marijuana or marijuana products at a dispensary.

7 (4) A person who obtains a cultivator license, manufacturer license, adult-use dispensary license, or
8 medical marijuana dispensary license or is an employee of one of those licensees, may:

9 (a) transport marijuana or marijuana products between other licensed premises without a transporter
10 license so long as such transportation:

11 (i) complies with rules implementing the seed-to-sale tracking system set forth in 16-12-105; and

12 (ii) includes a printed manifest containing information as required by the department; and

13 (b) deliver marijuana from a dispensary to a registered cardholder provided that the person delivering
14 the marijuana or marijuana products:

15 (i) complies with rules adopted by the department; and

16 (ii) includes a printed delivery manifest from a dispensary to a registered cardholder containing the
17 registered cardholder's address and cardholder number and the dispensary's address and license number.

18 (5) (a) A marijuana transporter licensee may maintain a licensed premises to temporarily store
19 marijuana and marijuana products and to use as a centralized distribution point.

20 (b) The licensed premises must be located in a jurisdiction that permits the operation of a marijuana
21 business and comply with rules adopted by the department.

22 (c) A marijuana transporter may store and distribute marijuana and marijuana products from this
23 location. A storage facility must meet the same security requirements that are required to obtain a license under
24 this chapter.

25 (6) A marijuana transporter shall use the seed-to-sale tracking system developed pursuant to 16-12-
26 105 to create shipping manifests documenting the transport of retail marijuana and retail marijuana products
27 throughout the state.

28 (7) A marijuana transporter may deliver marijuana or marijuana products to:

1 ~~(a)~~ licensed premises; ~~only~~ and ~~may not make deliveries of marijuana or marijuana products to~~

2 ~~(b)~~ individual consumers or registered cardholders ~~who have ordered marijuana or marijuana~~

3 ~~products through a dispensary and paid the dispensary directly for the marijuana or marijuana products.~~

4 ~~(8)~~ A marijuana transporter may not display a logo or other form of advertising on a delivery vehicle.

5 ~~(9)~~ A marijuana transporter may not accept payment for marijuana or marijuana products from a

6 consumer or registered cardholder.

7 ~~(8)(10)~~ A person delivering marijuana or marijuana products for a marijuana transporter must possess

8 a valid marijuana worker permit provided for under [section 7] and be a current employee of the marijuana

9 transporter licensee.

10

11 NEW SECTION. Section 4. Licensing of cultivators. (1) (a) The department shall license cultivators

12 according to a tiered canopy system. All cultivation that is licensed under this chapter may only occur at an

13 indoor cultivation facility.

14 (b) The system shall include, at a minimum, the following license types:

15 (i) A micro tier canopy license allows for a canopy of up to 250 square feet at one indoor cultivation
16 facility.

17 (ii) A tier 1 canopy license allows for a canopy of up to 1,000 square feet at one indoor cultivation
18 facility.

19 (iii) A tier 2 canopy license allows for a canopy of up to 2,500 square feet at up to two indoor cultivation
20 facilities.

21 (iv) A tier 3 canopy license allows for a canopy of up to 5,000 square feet at up to three indoor
22 cultivation facilities.

23 (v) A tier 4 canopy license allows for a canopy of up to 7,500 square feet at up to four indoor
24 cultivation facilities.

25 (vi) A tier 5 canopy license allows for a canopy of up to 10,000 square feet at up to five indoor
26 cultivation facilities.

27 (vii) A tier 6 canopy license allows for a canopy of up to 13,000 square feet at up to five indoor
28 cultivation facilities.

1 (viii) A tier 7 canopy license allows for a canopy of up to 15,000 square feet at up to five indoor
2 cultivation facilities.

3 (ix) A tier 8 canopy license allows for a canopy of up to 17,500 square feet at up to five indoor
4 cultivation facilities.

5 (x) A tier 9 canopy license allows for a canopy of up to 20,000 square feet at up to six indoor cultivation
6 facilities.

7 (xi) A tier 10 canopy license allows for a canopy of up to 30,000 square feet at up to seven indoor
8 cultivation facilities.

9 (c) A cultivator shall demonstrate that the local government approval provisions in 16-12-301 have
10 been satisfied for the jurisdiction where each proposed indoor cultivation facility or facilities is or will be located.

11 (d) When evaluating an initial or renewal license application, the department shall evaluate each
12 proposed indoor cultivation facility for compliance with the provisions of 16-12-207 and 16-12-210.

13 (e) A cultivator may apply to advance to the next licensing tier in conjunction with a regular renewal
14 application by demonstrating that its proposed additional or expanded indoor cultivation facility or facilities are
15 located in a jurisdiction where the local government approval provisions contained in 16-12-301 have been
16 satisfied.

17 (2) The department is authorized to create additional tiers as necessary.

18 (3) The department may adopt rules:

19 (a) for inspection of proposed indoor cultivation facilities under subsection (1); and

20 (b) for investigating owners or applicants for a determination of financial interest; and

21 (c) in consultation with the department of agriculture and based on well-supported science, to require
22 licensees to adopt practices consistent with the prevention, introduction, and spread of insects, diseases, and
23 other plant pests into Montana.

24 (4) Initial licensure and annual fees for these licensees are:

25 (a) \$1,000 for a cultivator with a micro tier canopy license;

26 (b) \$2,500 for a cultivator with a tier 1 canopy license;

27 (c) \$5,000 for a cultivator with a tier 2 canopy license;

28 (d) \$7,500 for a cultivator with a tier 3 canopy license;

- 1 (e) \$10,000 for a cultivator with a tier 4 canopy license;
- 2 (f) \$13,000 for a cultivator with a tier 5 canopy license;
- 3 (g) \$15,000 for a cultivator with a tier 6 canopy license;
- 4 (h) \$17,500 for a cultivator with a tier 7 canopy license;
- 5 (i) \$20,000 for a cultivator with a tier 8 canopy license;
- 6 (j) \$23,000 for a cultivator with a tier 9 canopy license; and
- 7 (k) \$27,000 for a cultivator with a tier 10 canopy license.

8 (5) The fee required under this part may be imposed based only on the tier of licensure and may not
9 be applied separately to each indoor cultivation facility used for cultivation under the licensure level.

10

11 **NEW SECTION. Section 5. Licensing of dispensaries.** (1) Except as provided in 16-12-201(2), an
12 applicant for a dispensary license shall demonstrate that the local government approval provisions in 16-12-301
13 have been satisfied in the jurisdiction where each proposed dispensary is located.

14 (2) When evaluating an initial or renewal application, the department shall evaluate each proposed
15 dispensary for compliance with the provisions of 16-12-207 and 16-12-210.

16 (3) An adult-use dispensary licensee may operate at a shared location with a medical marijuana
17 dispensary if the adult-use dispensary and medical marijuana dispensary are owned by the same person.

18 (4) A medical marijuana dispensary is authorized to sell exclusively to registered cardholders
19 marijuana, marijuana products, and live marijuana plants.

20 (5) An ~~adult dispensary~~ ADULT-USE DISPENSARY is authorized to sell marijuana, ~~or~~ marijuana products,
21 AND LIVE MARIJUANA PLANTS to consumers or registered cardholders.

22 (6) The department shall charge a dispensary license fee for an initial application and at each
23 renewal. The dispensary license fee is \$5,000 for each location that a licensee operates as an adult-use
24 dispensary or a medical marijuana dispensary.

25 (7) The department may adopt rules:

- 26 (a) for inspection of proposed dispensaries;
- 27 (b) for investigating owners or applicants for a determination of financial interest; and
- 28 (c) establishing or limiting the THC content of the marijuana or marijuana products that may be sold at

1 an adult-use dispensary or medical marijuana dispensary.

2 (8) (a) Marijuana and marijuana products sold at a dispensary are regulated and sold on the basis of
3 the concentration of THC in the products and not by weight.

4 (b) Except as provided in subsection (8)(c), for purposes of this chapter, a single package is limited
5 to:

6 (i) for marijuana sold as flower, 1 ounce of usable marijuana. The total potential psychoactive THC of
7 marijuana flower may not exceed 35%.

8 (ii) for a marijuana product sold as a capsule, no more than 100 milligrams of THC per capsule and no
9 more than 800 milligrams of THC per package.

10 (iii) for a marijuana product sold as a tincture, no more than 800 milligrams of THC;

11 (iv) for a marijuana product sold as an edible or a food product, no more than 100 milligrams of THC. A
12 single serving of an edible marijuana product may not exceed 10 milligrams of THC.

13 (v) for a marijuana product sold as a topical product, a concentration of no more than 6% THC and no
14 more than 800 milligrams of THC per package;

15 (vi) for a marijuana product sold as a suppository or transdermal patch, no more than 100 milligrams of
16 THC per suppository or transdermal patch and no more than 800 milligrams of THC per package; and

17 (vii) for any other marijuana product, no more than 800 milligrams of THC.

18 (c) A dispensary may sell marijuana or marijuana products having higher THC potency levels than
19 described in subsection (8) to registered cardholders.

20 (9) A licensee or employee is prohibited from conducting a transaction that would result in a
21 consumer or registered cardholder exceeding the personal possession amounts set forth in 16-12-106 and
22 [section ~~24~~ 16].

23

24 **NEW SECTION. Section 6. Combined-use marijuana licensing -- requirements.** (1) The
25 department may issue a total of eight combined-use marijuana licenses to entities that are:

26 (a) a federally recognized tribe located in the state; or

27 (b) a business entity that is majority-owned by a federally recognized tribe located in the state.

28 (2) A combined-use marijuana license consists of one tier 1 canopy license and one dispensary

1 license allowing for the operation of a dispensary. Cultivation and dispensary facilities must be located at the
2 same licensed premises.

3 (3) A combined-use marijuana licensee shall operate its cultivation and dispensary facilities on land
4 that is located:

5 (a) within 25 air-miles of the exterior boundary of the associated tribal reservation; and

6 (b) in a county that has satisfied the local government approval provisions in 16-12-301.

7 (4) An applicant under this section must satisfy all licensing requirements under this chapter and is
8 subject to all fees and taxes associated with the cultivation and sale of marijuana or marijuana products
9 provided for in this chapter.

10 (5) A license granted under this section must be operated in compliance with all requirements
11 imposed under this chapter.

12 (6) After a tribe or a majority-owned business of that tribe is licensed under this section, that tribe or
13 another majority-owned business of that tribe may not obtain another combined-use license until the prior
14 license is relinquished, lapses, or is revoked by the department.

15
16 **NEW SECTION. Section 7. Marijuana worker permit -- requirements.** (1) A marijuana worker
17 permit is required for an employee who performs work for or on behalf of a marijuana business if the individual
18 participates in any aspect of the marijuana business.

19 (2) (a) Except as provided in subsection (2)(b), a marijuana business may not allow an employee to
20 perform any work at the licensed premises until it has verified that that the employee has obtained a valid
21 marijuana worker permit issued in accordance with this chapter.

22 (b) An employee of a former medical marijuana licensee in good standing with the department as of
23 [the effective date of this section] shall obtain a marijuana worker permit within 90 days of [the effective date of
24 this section].

25 (3) An applicant for a marijuana worker permit shall submit:

26 (a) an application on a form prescribed by the department with information including the applicant's:

27 (i) name;

28 (ii) mailing address;

- 2 (iv) signature; and
- 3 (v) response to conviction history questions requested by the department;
- 4 (b) a copy of a driver's license or identification card issued by one of the fifty states in the United
- 5 States or a passport;
- 6 (c) proof of having passed any training required by the department; and
- 7 (d) a fee established by the department.
- 8 (4) (a) Except as provided in subsection (4)(b), an application that does not contain the elements set
- 9 forth in subsection (3) is incomplete.
- 10 (b) The department may review an application prior to receiving the fee but may not issue a permit
- 11 until the fee is received.
- 12 (5) The department shall deny an initial or renewal application if the applicant:
- 13 (a) is not 18 years of age or older;
- 14 (b) has had a marijuana license or worker permit revoked for a violation of this chapter or any rule
- 15 adopted under this chapter within 2 years of the date of the application;
- 16 (c) has violated any provision of this chapter; or
- 17 (d) makes a false statement to the department.
- 18 (6) An employee of a licensee shall carry the employee's worker permit at all times when performing
- 19 work on behalf of a marijuana business.
- 20 (7) A person who holds a marijuana worker permit must notify the department in writing within 10
- 21 days of:
- 22 (a) a conviction for a felony;
- 23 (b) the issuance of any citation for violating a marijuana law imposed under this chapter or the
- 24 marijuana laws of any other state; or
- 25 (c) the issuance of any citation for selling or dispensing alcohol or tobacco products to a minor.

27 ~~NEW SECTION. Section 8. — Local government taxing authority — specific delegation. As~~
28 ~~required by 7-1-112, [sections 8 through 12] specifically delegate to the qualified electors of a county the power~~

1 to authorize their county to impose a local-option marijuana excise tax within the corporate boundary of the
2 county.

3
4 ~~NEW SECTION. Section 9. — Limit on local-option marijuana excise tax rate -- goods subject to~~
5 ~~tax. (1) The rate of the local-option marijuana excise tax must be established by the election petition or~~
6 ~~resolution provided for in [section 10], and the rate may not exceed 5%.~~

7 ~~(2) The local-option marijuana excise tax is a tax on the retail value of all marijuana and marijuana~~
8 ~~products sold at an adult-use dispensary or medical marijuana dispensary within a county.~~

9 ~~(3) If a county imposes a local-option marijuana excise tax:~~

10 ~~(a) 50% of the resulting tax revenue must be retained by the county;~~

11 ~~(b) 45% of the resulting tax revenue must be apportioned to the municipalities on the basis of the ratio~~
12 ~~of the population of the city or town to the total county population; and~~

13 ~~(c) the remaining 5% of the resulting tax revenue must be retained by the department to defray costs~~
14 ~~associated with administering [sections 8 through 12]. The funds retained by the department under this~~
15 ~~subsection (3)(c) must be deposited into the marijuana state special revenue account established under 16-12-~~

17 ~~(4) For purposes of this section, tax revenue means the combined taxes collected under any local-~~
18 ~~option marijuana excise tax collected on retail sales within the county.~~

20 ~~NEW SECTION. Section 10. — Local-government excise tax -- election required -- procedure --~~

21 ~~notice. (1) – A county that has permitted an adult-use dispensary or medical marijuana dispensary to operate~~
22 ~~within its borders may not impose or, except as provided in this section, amend or repeal a local-option~~
23 ~~marijuana excise tax unless the local-option marijuana excise tax question has been approved by a majority of~~
24 ~~the qualified electors voting on the question.~~

25 ~~(2) The local-option marijuana excise tax question may be presented to the qualified electors of a~~
26 ~~county by a petition of the electors as provided in 7-5-131, 7-5-132, 7-5-134, 7-5-135, and 7-5-137 or by a~~

22 **NEW SECTION. Section 12. — Use of local-option marijuana excise tax revenue.** Unless
23 otherwise restricted, a county or municipality may appropriate and expend revenue derived from a local-option
24 marijuana excise tax for any activity, undertaking, or administrative service that the municipality is authorized by
25 law to perform, including costs resulting from the imposition of the tax or due to administrative burdens imposed
26 on the municipality as a result of licensing or regulatory requirements imposed in this chapter.

28 **NEW SECTION. Section 8. Unlawful possession of marijuana, marijuana products, or**

1 **marijuana paraphernalia in motor vehicle on highway.** (1) Except as provided in subsection (2), a person
2 commits the offense of unlawful possession of marijuana, marijuana products, or marijuana paraphernalia in a
3 motor vehicle if the person knowingly possesses marijuana, marijuana products, or marijuana paraphernalia, as
4 those terms are defined in 16-12-102, within the passenger area of a motor vehicle on a highway.

5 (2) This section does not apply to marijuana, marijuana products, or marijuana paraphernalia:

6 (a) purchased from a dispensary and that remains in its unopened, original packaging;

7 (b) in a locked glove compartment or storage compartment;

8 (c) in a motor vehicle trunk or luggage compartment or in a truck bed or cargo compartment;

9 (d) behind the last upright seat of a motor vehicle that is not equipped with a trunk; or

10 (e) in a closed container in the area of a motor vehicle that is not equipped with a trunk and that is not
11 normally occupied by the driver or a passenger.

12 (3) (a) A person convicted of the offense of unlawful possession of marijuana, marijuana products, or
13 marijuana paraphernalia in a motor vehicle shall be fined an amount not to exceed \$100.

14 (b) A violation of this section is not a criminal offense within the meaning of 3-1-317, 3-1-318, 45-2-
15 101, 46-18-236, 61-8-104, or 61-8-711 and may not be recorded or charged against a driver's record, and an
16 insurance company may not hold a violation of this section against the insured or increase premiums because
17 of the violation. The surcharges provided for in 3-1-317, 3-1-318, and 46-18-236 may not be imposed for a
18 violation of this section.

20 **NEW SECTION. Section 9. Purpose.** The purpose of [sections 44 through 28 9 THROUGH 23] is to:

21 (1) provide a regulatory system for providing marijuana for the use of individuals with debilitating
22 medical conditions, including posttraumatic stress disorder, in order to alleviate the symptoms of the debilitating
23 medical condition;

24 (2) allow for the limited cultivation, manufacture, delivery, and possession of marijuana as permitted
25 by this chapter;

26 (3) allow persons to assist registered cardholders with the cultivation of marijuana and manufacture of
27 marijuana products permitted by this chapter.

28 (4) provide for a registry of individuals with debilitating medical conditions entitled to purchase

2 (5) provide the process for obtaining a registry identification card.

4 NEW SECTION. Section 10. Definitions. As used in [sections 14 through 28 ~~9 THROUGH 23~~], the

7 (a) is licensed under Title 37, chapter 3; and

8 (b) is the physician to whom a patient's treating physician has referred the patient for physical
9 examination and medical assessment.

10 (2) "Standard of care" means, at a minimum, the following activities when undertaken in person or
11 through the use of telemedicine by a patient's treating physician or referral physician if the treating physician or
12 referral physician is providing written certification for a patient with a debilitating medical condition:

13 (a) obtaining the patient's medical history;

14 (b) performing a relevant and necessary physical examination;

15 (c) reviewing prior treatment and treatment response for the debilitating medical condition;

18 (e) discussing with the patient and ensuring that the patient understands the advantages,
19 disadvantages, alternatives, potential adverse effects, and expected response to the recommended treatment;

20 (f) monitoring the response to treatment and possible adverse effects; and

21 (g) creating and maintaining patient records that remain with the physician.

22 (3) "Telemedicine" has the meaning provided in 33-22-138.

23 (4) "Treating physician" means an individual who:

24 (a) is licensed under Title 37, chapter 3; and

25 (b) has a bona fide professional relationship with the individual applying to be a registered cardholder.

26 (5) "Written certification" means a statement signed by a treating physician or referral physician that
27 meets the requirements of [section 48 ~~13~~] and is provided in a manner that meets the standard of care.

28

1 NEW SECTION. **Section 11. Medical marijuana registry -- department responsibilities --**

2 **issuance of cards -- confidentiality.** (1) The department shall establish and maintain a registry of persons
3 who receive registry identification cards under [sections 44 through 28 9 THROUGH 23].

4 (2) The department shall issue registry identification cards to Montana residents who have debilitating
5 medical conditions and who submit applications meeting the requirements of [sections 44 through 28 9
6 THROUGH 23].

7 (3) (a) Registry identification cards issued pursuant to [sections 44 through 28 9 THROUGH 23] must:

8 (i) be laminated and produced on a material capable of lasting for the duration of the time period for
9 which the card is valid;

10 (ii) state the name, address, and date of birth of the registered cardholder;

11 (iii) indicate whether the cardholder is obtaining marijuana and marijuana products through the system
12 of licensed cultivators, manufacturers, or dispensaries;

13 (iv) state the date of issuance and the expiration date of the registry identification card;

14 (v) contain a unique identification number; and

15 (vi) contain other information that the department may specify by rule.

16 (b) Except as provided in subsection (3)(c), in addition to complying with subsection (3)(a), registry
17 identification cards issued pursuant to this part must:

18 (i) include a picture of the registered cardholder; and

19 (ii) be capable of being used to track registered cardholder purchases.

20 (c) (i) The department shall issue a temporary registry identification card on receipt of an application.

21 The cards are valid for 60 days and are exempt from the requirements of subsection (3)(b). Printing of the
22 temporary registry identification cards is exempt from the provisions of Title 18, chapter 7.

23 (ii) A card may be issued before an applicant's payment of the fee has cleared. The department shall
24 cancel the temporary registry identification card after 60 days and may not issue a permanent registry
25 identification card until the fee is paid.

26 (4) (a) The department shall review the information contained in an application or renewal submitted
27 pursuant to this part and shall approve or deny an application or renewal within 30 days of receiving the
28 application or renewal and all related application materials.

1 (b) If the department fails to act on a completed application within 30 days of receipt, the department
2 shall refund the fee paid by an applicant for a registry identification card.

3 (c) Applications that are not processed within 30 days of receipt remain active until the department
4 takes final action.

5 (d) The department shall issue a registry identification card within 5 days of approving an application
6 or renewal.

7 (5) Review of a rejection of an application or renewal may be conducted as a contested case hearing
8 pursuant to the provisions of the Montana Administrative Procedure Act.

9 (6) Registry identification cards expire 1 year after the date of issuance unless a physician has
10 provided a written certification stating that a card is valid for a shorter period of time.

11 (7) (a) A registered cardholder shall notify the department of any change in the cardholder's name,
12 address, or physician, or a change in the status of the cardholder's debilitating medical condition within 10 days
13 of the change.

14 (b) If a change occurs and is not reported to the department, the registry identification card is void.

15 (8) The department shall maintain a confidential list of individuals to whom the department has issued
16 registry identification cards. Individual names and other identifying information on the list must be confidential
17 and is not subject to disclosure, except to:

18 (a) authorized employees of the department as necessary to perform the official duties of the
19 department;

20 (b) authorized employees of state or local government agencies, including law enforcement agencies,
21 only as necessary to verify that an individual is a lawful possessor of a registry identification card;

22 (c) a judge, magistrate, or other authorized judicial officer in response to an order requiring disclosure;
23 and

24 (d) another person or entity when the information pertains to a cardholder who has given written
25 consent to the release and has specified:

27 (ii) the person or entity to whom it may be released.

1 NEW SECTION. **Section 12. Individuals with debilitating medical conditions -- requirements --**

2 **minors -- limitations.** (1) Except as provided in subsections (2) through (5), the department shall issue a
3 registry identification card to an individual with a debilitating medical condition who submits the following, in
4 accordance with department rules:

- 5 (a) an application on a form prescribed by the department;
- 6 (b) an application fee or a renewal fee;
- 7 (c) the individual's name, street address, and date of birth;
- 8 (d) proof of Montana residency;
- 9 (e) a statement, on a form prescribed by the department, that the individual will not divert to any other
10 individual the marijuana or marijuana products that the individual cultivates, manufactures, or obtains through

- 17 (h) the written certification and accompanying statements from the individual's treating physician or
18 referral physician as required pursuant to [section ~~48~~ 13].

19 (2) The department shall issue a registry identification card to a minor if the materials required under
20 subsection (1) are submitted and the minor's custodial parent or legal guardian with responsibility for health
21 care decisions:

- 22 (a) provides proof of legal guardianship and responsibility for health care decisions if the individual is
23 submitting an application as the minor's legal guardian with responsibility for health care decisions; and
- 24 (b) signs and submits a written statement that:
 - 25 (i) the minor's treating physician or referral physician has explained to the minor and to the minor's
26 custodial parent or legal guardian with responsibility for health care decisions the potential risks and benefits of
27 the use of marijuana;
 - 28 (ii) indicates whether the minor's custodial parent or legal guardian will be obtaining marijuana or

- 1 marijuana products for the minor through the system of licensed dispensaries provided for in this chapter; and
- 2 (iii) the minor's custodial parent or legal guardian with responsibility for health care decisions:
- 3 (A) consents to the use of marijuana by the minor;
- 4 (B) agrees to control the acquisition of marijuana and the dosage and frequency of the use of
- 5 marijuana by the minor; and
- 6 (C) agrees that the minor will use only marijuana products and will not smoke marijuana;
- 7 (c) if the parent or guardian will be serving as the minor's cultivator, undergoes background checks in
- 8 accordance with subsection (3). The parent or legal guardian shall pay the costs of the background check and
- 9 may not obtain a license under this chapter if the parent or legal guardian does not meet the requirements set
- 10 forth in this chapter.
- 11 (d) pledges, on a form prescribed by the department, not to divert to any individual any marijuana
- 12 purchased for the minor's use in a marijuana product.
- 13 (3) A parent serving as a minor's cultivator shall submit fingerprints to facilitate a fingerprint and
- 14 background check by the department of justice and federal bureau of investigation upon the minor's initial
- 15 application for a registry identification card and every ~~3~~ 5 years after that. The department shall conduct a
- 16 name-based background check in years when a fingerprint background check is not required.
- 17 (4) An application for a registry identification card for a minor must be accompanied by the written
- 18 certification and accompanying statements required pursuant to [section ~~4&~~ 13] from a second physician in
- 19 addition to the minor's treating physician or referral physician, UNLESS THE MINOR'S TREATING PHYSICIAN OR
- 20 REFERRAL PHYSICIAN IS AN ONCOLOGIST, NEUROLOGIST, OR EPILEPTOLOGIST.
- 21 (5) An individual may not be a registered cardholder if the individual is in the custody of or under the
- 22 supervision of the department of corrections or a youth court.
- 23
- 24 **NEW SECTION. Section 13. Written certification -- accompanying statements.** (1) The written
- 25 certification provided by a physician must be made on a form prescribed by the department and signed and
- 26 dated by the physician. The written certification must:
- 27 (a) include the physician's name, license number, and office address and telephone number on file
- 28 with the board of medical examiners and the physician's business e-mail address, if any; and

21 ~~(h)~~(G) state that the physician has a reasonable degree of certainty that the patient's debilitating
22 medical condition would be alleviated by the use of marijuana and that, as a result, the patient would be likely to
23 benefit from the use of marijuana;

24 ~~(i)~~(H) confirm that the physician has explained the potential risks and benefits of the use of marijuana
25 to the patient;

26 ~~(j)~~(I) list restrictions on the patient's activities due to the use of marijuana;

27 ~~(k)~~(J) specify the time period for which the use of marijuana would be appropriate, up to a maximum
28 of 1 year;

1 ~~(H)~~(K) state that the physician will:

2 (i) continue to serve as the patient's treating physician or referral physician; and

3 (ii) monitor the patient's response to the use of marijuana and evaluate the efficacy of the treatment;

4 and

5 ~~(M)~~(L) contain an attestation that the information provided in the written certification and

6 accompanying statements is true and correct.

7 (3) A physician who is the second physician recommending marijuana for use by a minor shall submit:

8 (a) a statement initialed by the physician that the physician conducted a comprehensive review of the
9 minor's medical records as maintained by the treating physician or referral physician;

10 (b) a statement that in the physician's professional opinion, the potential benefits of the use of
11 marijuana would likely outweigh the health risks for the minor; and

12 (c) an attestation that the information provided in the written certification and accompanying
13 statements is true and correct.

14 (4) A physician who is providing written certification through the use of telemedicine:

15 (a) shall comply with the administrative rules adopted for telemedicine by the board of medical
16 examiners provided for in 2-15-1731; and

17 (b) may not use an audio-only visit unless the physician has first established a physician-patient
18 relationship through an in-person encounter.

19 (5) If the written certification states that marijuana should be used for less than 1 year, the department
20 shall issue a registry identification card that is valid for the period specified in the written certification.

22 **NEW SECTION. Section 14. Registry identification card to be exhibited on demand -- photo**

23 **identification required.** (1) A registered cardholder shall keep the individual's registry identification card in the
24 individual's immediate possession at all times. The registry identification card and a valid photo identification
25 must be displayed upon demand of a law enforcement officer, justice of the peace, or city or municipal judge.

26 (2) The department shall ensure that law enforcement officers have access to accurate and up-to-

20 (3) A law enforcement agency contacted by a health care facility shall respond by removing and
21 destroying the marijuana.

22 (4) A health care facility may not be charged for costs related to removal of the marijuana from the
23 facility's premises.

25 **NEW SECTION. Section 16. Legal protections -- allowable amounts.** (1) (a) A registered
26 cardholder who has elected to obtain marijuana and marijuana products through the system of licensed
27 cultivators, manufacturers, or dispensaries may:

28 (i) possess up to 1 ounce of usable marijuana; and

1 (ii) purchase a maximum of 5 ounces of usable marijuana a month and no more than 1 ounce of
2 usable marijuana a day.

3 (b) (i) A registered cardholder may petition the department for an exception to the monthly limit on

12 23] may not be arrested, prosecuted, or penalized in any manner or be denied any right or privilege, including
13 but not limited to civil penalty or disciplinary action by a professional licensing board or the department of labor
14 and industry, solely because:

15 (a) the person cultivates, manufactures, possesses, or transports marijuana in the amounts allowed
16 under this section; or

17 (b) the registered cardholder acquires or uses marijuana.

18 (3) A physician may not be arrested, prosecuted, or penalized in any manner or be denied any right or
19 privilege, including but not limited to civil penalty or disciplinary action by the board of medical examiners or the
20 department of labor and industry, solely for providing written certification for a patient with a debilitating medical
21 condition.

22 (4) Nothing in this section prevents the imposition of a civil penalty or a disciplinary action by a
23 professional licensing board or the department of labor and industry if:

24 (a) a registered cardholder's use of marijuana impairs the cardholder's job-related performance; or

25 (b) a physician violates the standard of care or other requirements of ~~sections 14 through 28~~ 9
26 THROUGH 23].

27 (5) (a) An individual may not be arrested or prosecuted for constructive possession, conspiracy as
28 provided in 45-4-102, or other provisions of law or any other offense solely for being in the presence or vicinity

1 of the use of marijuana and marijuana products as permitted under [~~sections 44 through 28~~ 9 THROUGH 23].

2 (b) This subsection (5) does not prevent the arrest or prosecution of an individual who is in the vicinity
3 of a registered cardholder's use of marijuana if the individual is in possession of or is using marijuana in excess
4 of the amounts otherwise provided in this chapter and is not a registered cardholder.

5 (6) Possession of or application for a registry identification card does not alone constitute probable
6 cause to search the person or individual or the property of the person or individual or otherwise subject the
7 person or individual or property of the person or individual possessing or applying for the card to inspection by
8 any governmental agency, including a law enforcement agency.

9 (7) The provisions of this section relating to protection from arrest or prosecution do not apply to an
10 individual unless the individual has obtained a registry identification card prior to an arrest or the filing of a
11 criminal charge. It is not a defense to a criminal charge that an individual obtains a registry identification card
12 after an arrest or the filing of a criminal charge.

13 (8) (a) A registered cardholder is presumed to be engaged in the use of marijuana as allowed by
14 [~~sections 44 through 28~~ 9 THROUGH 23] if the person:

15 (i) is in possession of a valid registry identification card; and

16 (ii) is in possession of an amount of marijuana that does not exceed the amount permitted under
17 [~~sections 44 through 28~~ 9 THROUGH 23].

18 (b) The presumption may be rebutted by evidence that the possession of marijuana was not for the
19 purpose of alleviating the symptoms or effects of a registered cardholder's debilitating medical condition and

22 **NEW SECTION. Section 17. Prohibitions on physician affiliation with licensees -- sanctions.** (1)

23 (a) A physician who provides written certifications may not:

24 (i) accept or solicit anything of value, including monetary remuneration, from a person licensed under
25 this chapter;

26 (ii) offer a discount or any other thing of value to a patient who uses or agrees to use a person licensed
27 under this chapter; or

28 (iii) examine a patient for the purposes of diagnosing a debilitating medical condition at a licensed

1 premises or a testing laboratory.

2 (b) Subsection (1)(a) does not prevent a physician from accepting a fee for providing medical care to
3 a person licensed under this chapter if the physician charges the individual the same fee that the physician
4 charges other patients for providing a similar level of medical care.

5 (2) A person licensed under this chapter may not:

6 (a) arrange for a physician to conduct a physical examination or review of medical records required
7 under [sections 44 through 28 9 THROUGH 23], either in the physician's office or at another location; or

8 (b) pay all or a portion of the costs for an individual to be seen by a physician for the purposes of
9 obtaining a written certification.

10 (3) If the department has cause to believe that a physician has violated this section, has violated a
11 provision of rules adopted pursuant to [sections 44 through 28 9 THROUGH 23], or has not met the standard of
12 care required under [sections 44 through 28 9 THROUGH 23], the department may refer the matter to the board
13 of medical examiners provided for in 2-15-1731 for review pursuant to 37-1-308.

14 (4) A violation of this section constitutes unprofessional conduct under 37-1-316. If the board of
15 medical examiners finds that a physician has violated this section, the board shall restrict the physician's
16 authority to provide written certification for the use of marijuana. The board of medical examiners shall notify the
17 department of the sanction.

18 (5) If the board of medical examiners believes a physician's practices may harm the public health,
19 safety, or welfare, the board may summarily restrict a physician's authority to provide written certification for the
20 use of marijuana for a debilitating medical condition.

21 (6) (a) If the department has reason to believe a person licensed under this chapter has violated this
22 section, the department shall refer the matter to the law enforcement entity and county attorney having
23 jurisdiction where the person licensed under this chapter is doing business.

24 (b) If a person licensed under this chapter is found to have violated the provisions of this section, the
25 department shall revoke the person's license. A person whose license has been revoked for a violation of this
26 section is prohibited from reapplying for licensure under this chapter.

27 (7) (a) A law enforcement entity or county attorney who investigates a suspected violation of this
28 section shall report the results of the investigation to the department.

1 (b) The department may receive the results of this investigation even if the information constitutes
2 confidential criminal justice information as defined in 44-5-103.

5 in hard-copy form must be destroyed and any electronic records in the youth court management information
