Written Statement: I'm a physician in MT. I urge you to vote no on SB 215 today. I am including a letter signed by over 150 healthcare providers throughout MT also urging you to vote no.

This bill would allow healthcare providers to deny necessary medical treatment. For example, a pharmacist could refuse to give a patient medicine to treat HIV, or refuse to give a patient their oral contraceptive pills. A counselor could refuse to see a child if that child happens to have two moms. A physician could refuse to treat a patient's abscess if they use IV drugs. Given our rural state, if healthcare providers refuse to provide their necessary services, many patients have no where else to go.

This bill would cause significant unintended harm to many Montanans.

Dear Senators and Representatives of the Montana legislature,

We, the undersigned healthcare providers, are deeply concerned about a number of bills currently in the Montana legislature that are discriminatory towards our LGBTQ+ patients and fellow community members. It is our duty to support and care for all people, and to speak out when we witness harmful discrimination of any sort, especially discrimination against vulnerable minority populations.

Research unequivocally shows that stigmatized and marginalized populations, such as our fellow Montanans who are LGBTQ+, suffer an increased number of mental and physical health disparities compared to individuals who are not LGBTQ+. Increased rates of suicide, cancer, substance abuse, and obesity are just a few of the health disparities that LGBTQ+ individuals often face. These increased health disparities are not inherent in being LGBTQ+. These health disparities are the result of the stigma, prejudice, and discrimination as well as the denial of civil and human rights that LGBTQ+ individuals face in so many areas of their lives.

When legislatures pass harmful bills that discriminate against LGBTQ+ individuals, the suicide rate increases even more. For example, when HB 2, the infamous “bathroom bill” in North Carolina passed, the number of calls to a suicide hotline for transgender individuals doubled. The passage of that bill led to a number of lives lost from suicide. Alternatively, passage of bills that decrease discrimination, such as marriage equality, significantly decreases suicide rates among LGBTQ+ individuals.

A number of bills in the Montana legislature right now would further increase the discrimination that our LGBTQ+ Montanans already face. Allowing businesses and medical providers to discriminate against LGBTQ+ patients, prohibiting transgender youth from playing on sports teams, prohibiting gender diverse Montanans from aligning their birth certificate with their identity, and interfering with the physician-patient relationship would all only further increase the stigma, prejudice, and discrimination that our LGBTQ+ Montanans already face.

We, as Montana healthcare providers, are deeply troubled. We are troubled by the implications of each discriminatory bill. We are also gravely concerned by the sheer number of anti-LGBTQ+ bills currently being discussed in our legislature. Our fellow LGBTQ+ Montanans are already experiencing harm simply by knowing these discussions are happening. We strongly urge you to oppose all bills that would further discriminate against our fellow LGBTQ+ Montanans.
