15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

17	NEW SECTION. Section 1. Short title purpose. (1) [Sections 1 through 12] may be cited as the
18	"Montana Pharmacy Benefit Manager Oversight Act".
19	(2) [Sections 1 through 12] establishes the standards and criteria for the licensure and regulation of
20	pharmacy benefit managers that provide claims processing services or other prescription drug or device
21	services for health benefit plans.
22	(3) The purpose of this act is to:
23	(a) promote, preserve, and protect the public health, safety, and welfare through regulation and
24	licensure of pharmacy benefit managers;
25	(b) provide for powers and duties of the commissioner in licensing and regulating pharmacy benefit
26	managers; and
27	(c) provide penalties for violations of [sections 1 through 12].

1	NEW SECTION. Section 2. Definitions. As used in [sections 1 through 12], the following definitions
2	apply:
3	(1) "Claims processing services" means the administrative services performed in connection with the

16	agreement to provide, deliver, arrange for, pay for, or reimburse any of the costs of health care services.
17	(b) The term includes:
18	(i) self-funded multiple employer welfare arrangements as defined in 33-35-103;
19	(ii) the state compensation insurance fund established in 39-71-2313; and
20	(iii) any other entity providing a plan of health insurance, health benefits, or health care services.
21	(6) "Manufacturer" has the meaning provided in 37-7-602.
22	(7) "Other prescription drug or device services" means services other than claims processing services
23	that are provided directly or indirectly, whether in connection with or separate from claims processing services,
24	including but not limited to:
25	(a) negotiating rebates, discounts, or other financial incentives and arrangements with manufacturers,
26	wholesale distributors, or other third parties;
27	(b) disbursing or distributing rebates;
28	(c) managing or participating in incentive programs or arrangements for pharmacist services;

1	(d) negotiating or entering into contractual arrangements with pharmacists, pharmacies, or both;
2	(e) developing and maintaining formularies;
3	(f) designing prescription drug benefit programs;
4	(g) advertising or promoting services; or
5	(h) administering prior authorization, step therapy, case management, or other utilization review
6	programs.
7	(8) "Pharmacist" has the meaning provided in 33-22-170.
8	(9) "Pharmacist services" means products, goods, and services or any combination of products,
9	goods, and services provided as part of the practice of pharmacy.
10	(10) "Pharmacy" means an established location, either physical or electronic, that is licensed by the
11	board of pharmacy pursuant to Title 37, chapter 7.
12	(11) (a) "Pharmacy benefit manager" means a person, including a wholly or partially owned or
13	controlled subsidiary of a pharmacy benefit manager, that provides claims processing services or other
14	prescription drug or device services, or both, to enrollees who are residents of this state, for health benefit
15	plans.
16	(b) The term does not include:
17	(i) a health care facility as defined in 50-5-101 that is licensed in this state;
18	(ii) a health care professional licensed under Title 37;
19	(iii) a consultant who provides advice only as to the selection or performance of a pharmacy benefit
20	manager; or
21	(iv) a health carrier to the extent that the carrier performs any claims processing and other prescription
22	drug or device services exclusively for its enrollees.
23	(12) "Plan sponsor" has the meaning provided in 33-10-202.
24	(13) (a) "Rebates" means all price concessions, however characterized, paid by a manufacturer to a
25	pharmacy benefit manager, including discounts and other remuneration or price concessions, that are based on
26	the actual or estimated utilization of a prescription drug.
27	(b) The term includes price concessions based on the effectiveness of a prescription drug as in a
28	value-based or performance-based contract.

1	(14) "Wholesale acquisition cost" has the meaning provided in 42 U.S.C. 1395w-3a.
2	(15) "Wholesale distributor" or "distributor" has the meaning provided in 37-7-602.
3	
4	NEW SECTION. Section 3. Licensing required. (1) A person may not perform an act or do business
5	in this state as a pharmacy benefit manager without a valid license issued under [sections 1 through 12] by the
6	commissioner.
7	(2) A license issued under [sections 1 through 12] is nontransferable.
8	(3) A pharmacy benefit manager shall apply to the commissioner on a form prescribed by the
9	commissioner. At a minimum, the application form must include the following information:
10	(a) the name, business address, and telephone number of the pharmacy benefit manager and the
11	name, address, and contact information for the principal contact person of the pharmacy benefit manager for
12	communications with the commissioner on licensure-related matters;
13	(b) the name and address of:
14	(i) all members of the pharmacy benefit manager's board of directors, board of trustees, executive
15	committee, or other governing board of committee;
16	(ii) the principal officers in the case of a corporation; or
17	(iii) the partners or members in the case of a partnership or association;
18	(c) proof of registration with the Montana secretary of state;
19	(d) a copy of the most recent fiscal yearend audited financial statement of the pharmacy benefit
20	manager;
21	(e) a list of all health carrier and plan sponsor clients in this state;
22	(f) a description of the projected number of enrollees to be administered by the pharmacy benefit
23	manager in this state on an annual basis for each health carrier client and plan sponsor client;
24	(g) a copy of the policies and procedures that demonstrate the pharmacy benefit manager has
25	established processes to comply with the requirements of 33-22-170 through 33-22-177 and 33-22-180
26	concerning maximum allowable costs lists, including the appeals process required under 33-22-173;
27	(h) a description of the pharmacy benefit manager's network service areas and pharmacy accessibility
28	in this state;

17	(7) 1	The commissioner shall grant or deny an initial application for a license within 60 days from the
18	date that a co	mpleted application and license fee is received.
19	(8) ((a) Unless surrendered, suspended, or revoked by the commissioner, a license issued under this
20	section is valid	d as long as the pharmacy benefit manager:
21	(i) co	ontinues to do business in this state;
22	(ii) re	emains in compliance with the provisions of [sections 1 through 12];
23	(iii) co	ompletes a renewal application on a form prescribed by the commissioner; and

1 (10) In lieu of denying an application for initial licensure or renewal of licensure, the commissioner may 2 allow the pharmacy benefit manager to submit a corrective action plan to cure or correct the deficiencies 3 identified in review of the application. 4 5 NEW SECTION. Section 4. Pharmacy benefit manager prohibited practices. (1) In any 6 participation contracts between a pharmacy benefit manager and pharmacies or pharmacists providing 7 prescription drug coverage, a pharmacy or pharmacist may not be prohibited, restricted, or penalized in any 8 way from disclosing to any enrollee any information the pharmacy or pharmacist considers appropriate 9 regarding: 10 (a) the decision of utilization reviewers or similar persons to authorize or deny drug coverage or 11 benefits; and 12 (b) the process that is used to authorize or deny drug coverage or benefits. 13 (2) (a) A pharmacy benefit manager contract with a participating pharmacy or pharmacist in this state 14 may not prohibit, restrict, or limit disclosure of information to the commissioner when the commissioner is 15 investigating or examining a complaint or conducting a review of a pharmacy benefit manager's compliance 16 with the requirements of [sections 1 through 12]. 17 (b) A pharmacy benefit manager may not terminate the contract of or penalize a pharmacy or 18 pharmacist for sharing any portion of the pharmacy benefit manager contract with the commissioner for 19 investigation of a complaint or a question regarding whether the contract complies with this part. 20 (c) Any examination or review under this section must follow the examination procedures and 21 requirements applicable to insurers under Title 33, chapter 1, part 4, including but not limited to the 22 confidentiality provisions of 33-1-409. 23 24 NEW SECTION. Section 5. Marketing and advertising. (1) A pharmacy benefit manager may not 25 cause or knowingly permit the use of an advertisement, promotion, solicitation, representation, proposal, or 26 offer that is untrue, deceptive, or misleading. 27 (2) The commissioner may not review or approve a pharmacy benefit manager's marketing or 28 advertising documents prior to use by the pharmacy benefit manager.

1 (3) The commissioner shall review complaints related to pharmacy benefit manager marketing and 2 advertising material to determine whether the materials violate the provisions of this section. 3 4 NEW SECTION. Section 6. Pharmacy benefit manager transparency to health carriers and plan 5 **sponsors.** (1) Beginning in the second quarter after the effective date of a contract between a pharmacy 6 benefit manager and a health carrier or plan sponsor, the pharmacy benefit manager shall disclose, within 45 7 days of a request of the health carrier or plan sponsor, the following information regarding prescription drug 8 benefits specific to the health carrier or plan sponsor: 9 (a) the aggregate wholesale acquisition costs from a manufacturer or wholesale distributor for each 10 therapeutic category of prescription drugs; 11 (b) the aggregate wholesale acquisition costs from a manufacturer or wholesale distributor for each 12 therapeutic category of prescription drugs available to enrollees of the health carrier or plan sponsor; 13 (c) the aggregate amount of rebates received by the pharmacy benefit manager by therapeutic 14 category of prescription drugs. The aggregate amount must include any utilization discounts the pharmacy 15 benefit manager receives from a manufacturer or wholesale distributor. 16 (d) any other fees received from a manufacturer or wholesale distributor and the reason for the fees; 17 (e) whether the pharmacy benefit manager has a contract, agreement, or other arrangement with a 18 manufacturer to exclusively dispense or provide a drug to enrollees of the health carrier or plan sponsor, and 19 the application of all consideration or economic benefits collected or received pursuant to the arrangement: 20 (f) prescription drug utilization information for enrollees of the health carrier or plan sponsor, including 21 but not limited to: 22 (i) the top 10 prescription drugs by average total spending for each enrollee; 23 (ii) the top 10 prescription drugs by average out-of-pocket spending for each enrollee; 24 (iii) the top 10 therapeutic classes of prescription drugs by total spending and volume; 25 (iv) the total number of pharmacy transactions; and 26 (v) the total number of rejected pharmacy transactions, including a breakdown of the number rejected 27 for the following reasons: (A) nonformulary status; 28

3	(g) deidentified claims-level information in electronic format that allows the health carrier or plan
4	sponsor to sort and analyze the following information for each claim:

7	assessments imposed on the pharmacy, including point-of-sale and retroactive charges;
8	(iii) any spread between the net amount paid to the pharmacy as described in subsection (1)(g)(ii) and
9	the amount charged to the health carrier or plan sponsor;
10	(iv) whether the pharmacy is or is not:
11	(A) under common control or ownership with the pharmacy benefit manager;
12	(B) a preferred pharmacy under the health benefit plan; or
13	(C) a mail-order pharmacy; and
14	(v) whether enrollees are required by the health plan to use the pharmacy;
15	(h) the aggregate amount of payments made by the pharmacy benefit manager on behalf of the
16	health carrier or plan sponsor to:
17	(i) pharmacies owned or controlled by the pharmacy benefit manager; and
18	(ii) pharmacies not owned or controlled by the pharmacy benefit manager; and
19	(i) the aggregate amount of the fees imposed on or collected from network pharmacies or other
20	assessments against network pharmacies, including point-of-sale fees and retroactive charges, and the amount
21	of fees passed on to the health carrier or plan sponsor pursuant to the contract with the health carrier or plan
22	sponsor.
23	(2) A health carrier or plan sponsor may request more detailed data from the pharmacy manager for
24	any aggregate data provided under this section, including information to verify the pharmacy benefit manager's
25	source of and reported amounts of rebates and fees.
26	(3) A pharmacy benefit manager may require a health carrier or plan sponsor to agree to a
27	nondisclosure agreement that specifies that the information reported under this section is proprietary
28	information. A pharmacy benefit manager requiring the use of a nondisclosure agreement is not required to

19	of a health carrier or plan sponsor that was not passed through to the health carrier or plan sponsor by the sum	
20	total dollar amount of all rebates and fees received from all sources, direct or indirect, for all enrollees of a	
21	health carrier or plan sponsor.	
22	(3) The commissioner may request more detailed information from a pharmacy benefit manager for	
23	any aggregate data reported under this section, including information to verify a pharmacy benefit manager's	
24	reported amounts of rebates and fees and their allocation to a health carrier or plan sponsor.	
25	(4) On the request of a pharmacy benefit manager, the commissioner may exempt from disclosure	
26	any part of the pharmacy benefit manager's submission that the commissioner determines to contain trade	
27	secrets as defined in 30-14-402.	
28	(5) (a) Information provided pursuant to $(1)(h)(iii)$ through $(1)(h)(v)$ is confidential and is not subject to
