17 NEW SECTION. **Section 1. Synthetic marijuana products prohibited -- restriction on sale of**
18 **marijuana products.** (1) A person may not manufacture, process, or offer for sale a synthetic marijuana
19 product.

20 (2) Products containing or consisting of cannabinoids produced and processed for any type of
21 consumption into a human body, whether marketed as containing or consisting of cannabinoids or not, that
22 exceed a THC concentration of 0.3% may only be sold by a manufacturer licensed under 16-12-222 or a
23 dispensary licensed under 16-12-224 unless the products are authorized as a drug by the United States food
24 and drug administration. Products under this section may not exceed the potency levels established in 16-12-
25 224.

26 ~~(3) Products containing a THC concentration of 0.3% or less sold by any person other than a~~
27 ~~licensed manufacturer under 16-12-222 or a licensed dispensary under 16-12-224 must contain at least a 20:1~~

13 human services, local sheriff departments, municipal police departments, A COUNTY ATTORNEY'S OFFICE, and the
14 department of revenue may inspect any business to investigate unlawful activity under [section 1(1)].

15 (3) (A) IF AN INVESTIGATION RESULTS IN REASONABLE CAUSE TO BELIEVE THAT A VIOLATION OF [SECTION
16 1] OCCURRED, THE INVESTIGATING AGENCY MAY ISSUE A CEASE AND DESIST ORDER TO BE SERVED PURSUANT TO RULE
17 4, M.R.CIV.P. THE ORDER IS EFFECTIVE UPON SERVICE. PROOF OF SERVICE CONSTITUTES NOTICE TO THE PERSON OF
18 THE EXISTENCE AND CONTENTS OF THE ORDER.

19 (B) THE INVESTIGATING AGENCY MAY ASSESS A PENALTY OF NOT MORE THAN \$1,000 PER DAY FOR EACH
20 DAY A CEASE AND DESIST ORDER ISSUED UNDER THIS SECTION IS VIOLATED. FIFTY PERCENT OF THE PENALTY MUST BE
21 DEPOSITED INTO THE HEALING AND ENDING ADDICTION THROUGH RECOVERY AND TREATMENT ACCOUNT UNDER 16-12-
22 122, AND THE REMAINDER MUST BE DEPOSITED IN THE MARIJUANA STATE SPECIAL REVENUE ACCOUNT UNDER 16-12-

- 6 related to synthetic marijuana products, including but not limited to:
- 7 (a) definitions of the term "impairing" in relation to cannabinoids, as well as definitions of the terms
- 8 "artificial cannabinoids" and "synthetically derived cannabinoids"; and
- 9 (b) recommendations on potential guidelines for safe methods of manufacturing, extracting, and
- 10 synthesizing cannabinoids, including the sale of synthetic marijuana products.
- 11 (5) The advisory committee shall compile findings and make recommendations in a report to the
- 12 economic affairs interim committee, in accordance with 5-11-210, regarding regulating synthetic marijuana

16 **"16-12-101. Short title -- purpose.** (1) This chapter may be cited as the "Montana Marijuana

- 19 (a) provide for legal possession and use of limited amounts of marijuana legal for adults 21 years
- 20 of age or older;
- 21 (b) provide for the licensure and regulation of the cultivation, manufacture, production, distribution,
- 22 transportation, and sale of marijuana and marijuana products;
- 23 (c) eliminate the illicit market for marijuana and marijuana products;
- 24 (d) prevent the manufacture and distribution of synthetic marijuana products;

2 (2) "Affiliate" means a person that directly, or indirectly through one or more intermediaries,
3 controls or is controlled by, or is under common control with, another person.

4 (3) "Beneficial owner of", "beneficial ownership of", or "beneficially owns an" is determined in
5 accordance with section 13(d) of the federal Securities and Exchange Act of 1934, as amended.

6 (4) "Canopy" means the total amount of square footage dedicated to live plant production at a
7 licensed premises consisting of the area of the floor, platform, or means of support or suspension of the plant.

8 (5) "Consumer" means a person 21 years of age or older who obtains or possesses marijuana or
9 marijuana products for personal use from a licensed dispensary but not for resale.

12 policies of a person, whether through the ownership of voting owner's interests, by contract, or otherwise.

14 (a) is a natural person, an entity that is organized under the laws of and for which its principal
15 place of business is located in one of the states or territories of the United States or District of Columbia, or a
16 publicly traded corporation, and:

17 (i) acting alone or acting in concert, owns or acquires beneficial ownership of 5% or more of the
18 owner's interest of a marijuana business;

19 (ii) is an affiliate that controls a marijuana business and includes, without limitation, any manager;

21 (iii) is otherwise in a position to control the marijuana business; or

22 (b) is a qualified institutional investor acting alone or acting in concert that owns or acquires
23 beneficial ownership of more than 15% of the owner's interest of a marijuana business.

25 (3) and to which an individual may be ordered by any court of competent jurisdiction.

14 products from one marijuana business to another marijuana business, or to and from a testing laboratory, and
15 to temporarily store the transported retail marijuana and retail marijuana products at its licensed premises, but
16 is not authorized to sell marijuana or marijuana products to consumers under any circumstances.

17 (26) "Mature marijuana plant" means a harvestable marijuana plant.

18 (27) "Medical marijuana" means marijuana or marijuana products that are for sale solely to a
19 cardholder who is registered under Title 16, chapter 12, part 5.

20 (28) "Medical marijuana dispensary" means the location from which a registered cardholder may
21 obtain marijuana or marijuana products.

22 (29) "Outdoor cultivation" means live plants growing in an area exposed to natural sunlight and
23 environmental conditions including variable temperature, precipitation, and wind.

24 (30) "Owner's interest" means the shares of stock in a corporation, a membership in a nonprofit
25 corporation, a membership interest in a limited liability company, the interest of a member in a cooperative or in
26 a limited cooperative association, a partnership interest in a limited partnership, a partnership interest in a
27 partnership, and the interest of a member in a limited partnership association.

15 concentration of not more than 0.3% on a dry weight basis.

16 (b) The term does not include synthetic cannabinoids.

17 (2) "Hemp crude" means a hemp derivative in a temporary state of not complying with the legal
18 definition of hemp, the amount of tetrahydrocannabinol, or the amount of tetrahydrocannabinolic acid that will
19 be further processed in order to comply.

20 (3) "Hemp derivatives" means all products that contain or are processed from, extracted from, or
21 manufactured from hemp.

22 (4) "Marijuana" means all plant material from the genus Cannabis containing tetrahydrocannabinol
23 (THC) or seeds of the genus capable of germination.
