15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

16  
17 NEW SECTION. Section 1. Purpose. The practices of social work, professional counseling, marriage  
18 and family therapy, addiction counseling, and behavioral health peer support in the state of Montana are  
19 professional behavioral health practices affecting the public health, safety, and welfare and are subject to  
20 regulation and control in the public interest. It is a matter of public interest and concern that the collective  
21 practices of these professions warrant and receive the confidence of the public and that only qualified persons  
22 be permitted to practice in the behavioral health field from within or outside of Montana and engage with  
23 behavioral health clients located within the state. [Sections 1 through 14] must be liberally construed to carry  
24 out these objectives and purposes.

26 NEW SECTION. Section 2. Definitions. As used in [sections 1 through 14], the following definitions  
27 apply:

1 (1) "Addiction" means the condition or state in which an individual is physiologically or  
2 psychologically dependent on alcohol or other drugs. The term includes chemical dependency as defined in 53-  
3 24-103.

4 (2) "Addiction counseling" means using the knowledge and skill necessary to provide the  
5 therapeutic process of addiction treatment.

6 (3) "Approved examination" means a standardized test or examination of behavioral health  
7 knowledge, skills, and abilities that is approved by the board.

8 (4) "Approved program" means a behavioral health educational program accredited or sponsored  
9 by an entity that is recognized at the national, regional, or state level and approved by the board.

10 (5) "Approved supervisor" means a supervisor determined by the board to meet standards  
11 established by the board for supervision of clinical services.

12 (6) "Baccalaureate social work" means the application of social work theory, knowledge, methods,  
13 ethics, and the professional use of self to restore or enhance social, psychosocial, or biopsychosocial  
14 functioning of individuals, couples, families, groups, organizations, and communities. Baccalaureate social work  
15 is generalist practice that includes assessment, planning, intervention, evaluation, case management,  
16 information and referral, ~~counseling~~, supervision, consultation, education, advocacy, community organization,  
17 research, and the development, implementation, and administration of policies, programs, and activities.

18 (7) "Behavioral health" means, FOR THE PURPOSES OF REGULATION AND LICENSURE UNDER THIS  
19 CHAPTER, the practices of social work, professional counseling, marriage and family therapy, addiction  
20 counseling, and peer support regulated under [sections 1 through 14].

21 (8) "Behavioral health disorder" is a diagnosis of:

22 (a) a mental disorder as defined in 53-21-102; or

23 (b) chemical dependency as defined in 53-24-103.

24 (9) "Behavioral health peer support" means the use of personal experience with a behavioral  
25 health disorder to provide support, mentoring, guidance, and advocacy to individuals with behavioral health  
26 disorders while under the supervision of a mental health professional in an amount, duration, and scope  
27 appropriate to the setting and the demonstrated competency and experience of the peer support specialist.

- 1 (10) "Board" means the board of behavioral health provided for in 2-15-1744.
- 2 (11) "Clinical professional counseling" means engaging in methods and techniques that include:
- 3 (a) counseling, which means the therapeutic process of:
- 4 (i) conducting assessments and diagnoses for the purpose of establishing treatment goals and
- 5 objectives; or
- 6 (ii) planning, implementing, and evaluating treatment plans that use treatment interventions to
- 7 facilitate human development and to identify and remediate mental, emotional, or behavioral disorders and
- 8 associated distresses that interfere with mental health;
- 9 (b) assessment, which means selecting, administering, scoring, and interpreting instruments,
- 10 including psychological tests, evaluations, and assessments, designed to assess an individual's aptitudes,
- 11 attitudes, abilities, achievement, interests, and personal characteristics and using nonstandardized methods
- 12 and techniques for understanding human behavior in relation to coping with, adapting to, or changing life
- 13 situations;
- 14 (c) counseling treatment intervention, which means those cognitive, affective, behavioral, and
- 15 systemic counseling strategies, techniques, and methods common to the behavioral sciences that are
- 16 specifically implemented in the context of a therapeutic relationship, including techniques to treat the perception
- 17 of chronic pain. Other treatment interventions include developmental counseling, guidance, and consulting to
- 18 facilitate normal growth and development, including educational and career development.
- 19 (d) referral, which means evaluating information to identify needs or problems of an individual and
- 20 to determine the advisability of referral to other specialists, informing the individual of the judgment, and
- 21 communicating as requested or considered appropriate with the referral sources.
- 22 (12) (a) "Clinical social work" means the application of professional social work knowledge, skills,
- 23 and values in the differential diagnosis and treatment of psychosocial function, disability, or impairment,
- 24 including emotional, mental, and behavioral disorders and the perception of chronic pain. Treatment includes a
- 25 plan based on a differential diagnosis. Treatment may include but is not limited to the provision of
- 26 psychotherapy AND COUNSELING to individuals, couples, families, and groups across the life span. A clinical
- 27 social work licensee may also provide the services of baccalaureate and master's social work.

3 (13) "Department" means the department of labor and industry provided for in 2-15-1701.

4 (14) "Licensee" means an individual licensed under [sections 1 through 14] to practice social work,  
5 clinical professional counseling, addiction counseling, or marriage and family therapy or certified to provide  
6 behavioral health peer support.

7 (15) "Marriage and family therapy" means the diagnosis and treatment of mental and emotional  
8 disorders within the context of interpersonal relationships, including marriage and family systems. Marriage and  
9 family therapy involves:

10 (a) the professional application of psychotherapeutic and family system theories and techniques,  
11 counseling, consultation, treatment planning, and supervision in the delivery of services to individuals, couples,  
12 and families;

13 (b) the provision of professional marriage and family therapy services to individuals, couples, and  
14 families, singly or in groups, either directly or through public or private organizations; and

15 (c) the performance of psychological testing, evaluation, and assessment if the licensee is  
16 qualified to administer testing and make evaluations pursuant to 37-17-104.

17 (16) "Master's social work" means the application of social work theory, knowledge, methods, and  
18 ethics and the professional use of self to restore or enhance social, psychosocial, or biopsychosocial  
19 functioning of individuals, couples, families, groups, organizations, and communities. Master's social work  
20 includes the application of specialized knowledge and advanced skills in the areas of assessment, treatment  
21 planning, implementation and evaluation, case management, information and referral, supervision, consultation,  
22 education, research, advocacy, community organization, and the development, implementation, and  
23 administration of policies, programs, and activities.

24 (17) "Mental health professional" means:

25 (a) a physician licensed under Title 37, chapter 3;

26 (b) an advanced practice registered nurse, as provided for in 37-8-202, with a clinical specialty in  
27 psychiatric mental health nursing;

6 (18) "Psychotherapy" means the use of psychosocial methods within a professional relationship to  
7 assist a person to achieve a better psychosocial adaptation and to modify internal and external conditions that  
8 affect individuals, groups, or families in respect to behavior, emotions, and thinking concerning their  
9 interpersonal processes.

10 (19) "Social work" means the professional practice directed toward helping people achieve more  
11 adequate, satisfying, and productive social adjustments. The practice of social work involves special knowledge  
12 of social resources, human capabilities, and the roles that individual motivation and social influences play in  
13 determining behavior and involves diagnoses and the application of social work techniques.

14 (20) "Supervised work experience" means work in a behavioral health field after receipt of the  
15 required degree and license but under:

- 16 (a) the supervision of an approved supervisor; and
- 17 (b) terms and conditions prescribed by the board by rule.

18

19 **NEW SECTION. Section 3. Duties of board.** The board:

20 (1) shall meet at least annually to perform the duties described in [sections 1 through 14];

21 (2) shall adopt rules to carry out the provisions of [sections 1 through 14], including but not limited  
22 to rules that set professional, practice, and ethical standards for licensees;

23 (3) may adopt rules governing the issuance of licenses of special competence in particular areas  
24 of practice as a clinical professional counselor. The board shall establish criteria for each particular area for  
25 which a license is issued.

26 (4) shall recommend prosecutions for violations of [sections 1 through 14] to the attorney general  
27 or the appropriate county attorney, or both.

2           NEW SECTION. Section 4. Fees. Each applicant for a license or certification shall, upon submitting  
3 an application to the board, pay an application fee set by the department.

4

5           NEW SECTION. Section 5. Background checks. (1) As a prerequisite to the issuance of a license,  
6 candidate license, or certification, the board shall require an applicant to submit fingerprints for the purposes of  
7 fingerprint checks by the Montana department of justice and the federal bureau of investigation as provided in  
8 37-1-307. The board shall require a criminal background check of applicants and shall determine the applicant's  
9 suitability for licensure as provided in 37-1-201 through 37-1-205 and 37-1-307.

10           (2)     (a) An applicant who has a history of criminal convictions has the opportunity, as provided in  
11 37-1-203, to demonstrate to the board that the applicant is sufficiently rehabilitated to warrant the public trust.

12           (b)     The board may deny the license or certification if the board determines the applicant is not  
13 sufficiently rehabilitated.

14

15           NEW SECTION. Section 6. Privileged communications -- exceptions. A licensee may not disclose  
16 any information the licensee acquires from clients consulting the licensee in a professional capacity except:

17           (1)     with the written consent of the client or, in the case of the client's death or mental incapacity,  
18 with the written consent of the client's personal representative or guardian;

19           (2)     when a communication that otherwise would be confidential reveals that the client or another  
20 person is contemplating the commission of a crime or the licensee's professional opinion reveals a threat of  
21 imminent harm to the client or others;

22           (3)     when the client is a minor and information acquired by the licensee indicates that the client was  
23 the victim of a crime, the licensee may be required to testify fully in relation to the information in any  
24 investigation, trial, or other legal proceeding in which the commission of that crime is the subject of inquiry;

25           (4)     when the client or the client's personal representative or guardian brings an action against a  
26 licensee for a claim arising out of the licensee-client relationship, the client is considered to have waived any  
27 privilege;

4 **NEW SECTION. Section 7. Immunity from disciplinary action -- exceptions.** (1) Except as  
5 provided in subsection (2), immunity from the disciplinary authority of the board for violations of 37-1-316 is  
6 granted to a licensee when any allegation of misconduct is based on testimony or opinions offered by the  
7 licensee with respect to judicial proceedings governed by Title 40, 41, or 42.

8 (2) This section does not apply to addiction counselors or behavioral health peer support  
9 specialists.

10

11 **NEW SECTION. Section 8. Exemptions from licensure.** The license and certification requirements  
12 of [sections 1 through 14] do not prohibit:

13 (1) a member of another profession from performing duties and services consistent with the  
14 individual's licensure or certification or, in the case of a qualified member of another profession who is not  
15 licensed or certified, from performing duties and services consistent with the person's training, as long as the  
16 person does not represent by title that the person is engaging in the practice of behavioral health IS LICENSED BY  
17 THE BOARD;

18 (2) an activity or service or use of an official title by a person employed by or acting as a volunteer  
19 for a federal, state, county, or municipal agency or an educational, research, or charitable institution that is a  
20 part of the duties of the office or position;

21 (3) an activity or service of an employee of a business establishment performed solely for the  
22 benefit of the establishment's employees; or

23 (4) an activity or service of a student, intern, or resident in behavioral health counseling pursuing a  
24 course of study at an accredited university or college or working in a generally recognized training program if  
25 the activity or service constitutes a part of a supervised course of study.

27 **NEW SECTION. Section 9. Candidates for licensure or certification.** (1) A person who has

17 (a) have a diagnosis from a mental health professional as having a behavioral health disorder;

18 (b) have received treatment for the diagnosed behavioral health disorder;

19 (c) be in recovery, as defined by board rule, from the behavioral health disorder; and

20 (d) have successfully completed an approved program in behavioral peer support, including an  
21 ethics portion, as defined by board rule. The board shall:

22 (i) provide a list of approved programs; and

23 (ii) approve content that is flexible, affordable, and inclusive of faith-based, cultural, and  
24 educational programs available from national, regional, and state agencies and organizations.

18 (a) a special education cooperative;

19 (b) the Montana school for the deaf and blind, as described in 20-8-101;

20 (c) the Montana youth challenge program, as established in 10-1-1401;

21 (d) a correctional facility, as defined in 41-5-103;

22 (e) a public school located on an Indian reservation; and

23 (f) a public school that, driving at a reasonable speed for the road surface, is located more than 20

26 (6) (a) "Quality educator" means a full-time equivalent educator, as reported to the superintendent

2 (b) there is no reason to deny the license under the laws of this state governing the profession or

4 (2) The license may be issued if the applicant affirms or states in the application that the applicant has  
5 requested verification from the state or states in which the person is licensed that the person is currently  
6 licensed and is not subject to pending charges or final disciplinary action for unprofessional conduct or
