4 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING LAWS RELATED TO MARIJUANA;
5 ADDING PRESCHOOLS TO THE DISTANCE REQUIREMENT FOR A LICENSED PREMISES; ALLOWING A
6 COMBINED-USE LICENSE TO INCREASE CANOPY TIERS; REVISING THE FEE STRUCTURE FOR
7 LICENSING OF DISPENSARIES; PROVIDING AN APPROPRIATION; AMENDING SECTIONS 16-12-102, 16-
8 12-201, 16-12-207, 16-12-223, 16-12-224, AND 16-12-225, MCA; AND PROVIDING AN IMMEDIATE
9 EFFECTIVE DATE EFFECTIVE DATES."

11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

13 **Section 1.** Section 16-12-102, MCA, is amended to read:

14 **"16-12-102. Definitions.** As used in this chapter, the following definitions apply:

15 (1) "Adult-use dispensary" means a licensed premises from which a person licensed by the
16 department may:

17 (a) obtain marijuana or marijuana products from a licensed cultivator, manufacturer, dispensary, or
18 other licensee approved under this chapter; and

19 (b) sell marijuana or marijuana products to registered cardholders, adults that are 21 years of age or
20 older, or both.

21 (2) "Affiliate" means a person that directly, or indirectly through one or more intermediaries, controls
22 or is controlled by, or is under common control with, another person.

23 (3) "Beneficial owner of", "beneficial ownership of", or "beneficially owns an" is determined in
24 accordance with section 13(d) of the federal Securities and Exchange Act of 1934, as amended.

25 (4) "Canopy" means the total amount of square footage dedicated to live plant production at a
26 licensed premises consisting of the area of the floor, platform, or means of support or suspension of the plant.

27 (5) "Consumer" means a person 21 years of age or older who obtains or possesses marijuana or

1 marijuana products for personal use from a licensed dispensary but not for resale.

2 (6) "Control", "controls", "controlled", "controlling", "controlled by", and "under common control with"
3 mean the possession, direct or indirect, of the power to direct or cause the direction of the management or
4 policies of a person, whether through the ownership of voting owner's interests, by contract, or otherwise.

5 (7) "Controlling beneficial owner" means a person that satisfies one or more of the following:

6 (a) is a natural person, an entity that is organized under the laws of and for which its principal place of
7 business is located in one of the states or territories of the United States or District of Columbia, or a publicly
8 traded corporation, and:

9 (i) acting alone or acting in concert, owns or acquires beneficial ownership of 5% or more of the
10 owner's interest of a marijuana business;

11 (ii) is an affiliate that controls a marijuana business and includes, without limitation, any manager; or

12 (iii) is otherwise in a position to control the marijuana business; or

13 (b) is a qualified institutional investor acting alone or acting in concert that owns or acquires beneficial
14 ownership of more than 15% of the owner's interest of a marijuana business.

15 (8) "Correctional facility or program" means a facility or program that is described in 53-1-202(2) or (3)
16 and to which an individual may be ordered by any court of competent jurisdiction.

17 (9) "Cultivator" means a person licensed by the department to:

18 (a) plant, cultivate, grow, harvest, and dry marijuana; and

19 (b) package and relabel marijuana produced at the location in a natural or naturally dried form that
20 has not been converted, concentrated, or compounded for sale through a licensed dispensary.

21 (10) "Debilitating medical condition" means:

22 (a) cancer, glaucoma, positive status for human immunodeficiency virus, or acquired immune
23 deficiency syndrome when the condition or disease results in symptoms that seriously and adversely affect the
24 patient's health status;

25 (b) cachexia or wasting syndrome;

26 (c) severe chronic pain that is a persistent pain of severe intensity that significantly interferes with
27 daily activities as documented by the patient's treating physician;

- 2 (e) epilepsy or an intractable seizure disorder;
- 3 (f) multiple sclerosis;
- 4 (g) Crohn's disease;
- 5 (h) painful peripheral neuropathy;
- 6 (i) a central nervous system disorder resulting in chronic, painful spasticity or muscle spasms;
- 7 (j) admittance into hospice care in accordance with rules adopted by the department; or

- 9 (11) "Department" means the department of revenue provided for in 2-15-1301.
- 10 (12) (a) "Employee" means an individual employed to do something for the benefit of an employer.
- 11 (b) The term includes a manager, agent, or director of a partnership, association, company,
- 12 corporation, limited liability company, or organization.
- 13 (c) The term does not include a third party with whom a licensee has a contractual relationship.
- 14 (13) (a) "Financial interest" means a legal or beneficial interest that entitles the holder, directly or
- 15 indirectly through a business, an investment, or a spouse, parent, or child relationship, to 5% or more of the net
- 16 profits or net worth of the entity in which the interest is held.
- 17 (b) The term does not include interest held by a bank or licensed lending institution or a security
- 18 interest, lien, or encumbrance but does include holders of private loans or convertible securities.
- 19 (14) "Former medical marijuana licensee" means a person that was licensed by or had an application
- 20 for licensure pending with the department of public health and human services to provide marijuana to
- 21 individuals with debilitating medical conditions on ~~November 3, 2020~~ April 27, 2021.
- 22 (15) (a) "Indoor cultivation facility" means an enclosed area used to grow live plants that is within a
- 23 permanent structure using artificial light exclusively or to supplement natural sunlight.
- 24 (b) The term may include:
- 25 (i) a greenhouse;
- 26 (ii) a hoop house; or
- 27 (iii) a similar structure that protects the plants from variable temperature, precipitation, and wind.

1 (16) "Licensed premises" means all locations related to, or associated with, a specific license that is
2 authorized under this chapter and includes all enclosed public and private areas at the location that are used in
3 the business operated pursuant to a license, including offices, kitchens, restrooms, and storerooms.

4 (17) "Licensee" means a person holding a state license issued pursuant to this chapter.

5 (18) "Local government" means a county, a consolidated government, or an incorporated city or town.

6 (19) "Manufacturer" means a person licensed by the department to convert or compound marijuana
7 into marijuana products, marijuana concentrates, or marijuana extracts and package, repack, label, or
8 relabel marijuana products as allowed under this chapter.

9 (20) (a) "Marijuana" means all plant material from the genus Cannabis containing
10 tetrahydrocannabinol (THC) or seeds of the genus capable of germination.

11 (b) The term does not include hemp, including any part of that plant, including the seeds and all
12 derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether growing or not, with a
13 delta-9 tetrahydrocannabinol concentration of not more than 0.3% on a dry weight basis, or commodities or
14 products manufactured with hemp, or any other ingredient combined with marijuana to prepare topical or oral
15 administrations, food, drink, or other products.

16 (c) The term does not include a drug approved by the United States food and drug administration
17 pursuant to section 505 of the Federal Food, Drug, and Cosmetic Act, 21 U.S.C. 301, et seq.

18 (21) "Marijuana business" means a cultivator, manufacturer, adult-use dispensary, medical marijuana
19 dispensary, combined-use marijuana licensee, testing laboratory, marijuana transporter, or any other business
20 or function that is licensed by the department under this chapter.

21 (22) "Marijuana concentrate" means any type of marijuana product consisting wholly or in part of the
22 resin extracted from any part of the marijuana plant.

23 (23) "Marijuana derivative" means any mixture or preparation of the dried leaves, flowers, resin, or
24 byproducts of the marijuana plant, including but not limited to marijuana concentrates and other marijuana
25 products.

26 (24) "Marijuana product" means a product that contains marijuana and is intended for use by a
27 consumer by a means other than smoking. The term includes but is not limited to edible products, ointments,

2 (25) "Marijuana transporter" means a person that is licensed to transport marijuana and marijuana
3 products from one marijuana business to another marijuana business, or to and from a testing laboratory, and
4 to temporarily store the transported retail marijuana and retail marijuana products at its licensed premises, but
5 is not authorized to sell marijuana or marijuana products to consumers under any circumstances.

6 (26) "Mature marijuana plant" means a harvestable marijuana plant.

7 (27) "Medical marijuana" means marijuana or marijuana products that are for sale solely to a
8 cardholder who is registered under Title 16, chapter 12, part 5.

9 (28) "Medical marijuana dispensary" means the location from which a registered cardholder may obtain
10 marijuana or marijuana products.

11 (29) "Outdoor cultivation" means live plants growing in an area exposed to natural sunlight and
12 environmental conditions including variable temperature, precipitation, and wind.

13 (30) "Owner's interest" means the shares of stock in a corporation, a membership in a nonprofit
14 corporation, a membership interest in a limited liability company, the interest of a member in a cooperative or in
15 a limited cooperative association, a partnership interest in a limited partnership, a partnership interest in a
16 partnership, and the interest of a member in a limited partnership association.

17 (31) "Paraphernalia" has the meaning provided for "drug paraphernalia" in 45-10-101.

18 (32) "Passive beneficial owner" means any person acquiring an owner's interest in a marijuana
19 business that is not otherwise a controlling beneficial owner or in control.

20 (33) "Person" means an individual, partnership, association, company, corporation, limited liability
21 company, or organization.

22 (34) "Qualified institutional investor" means:

23 (a) a bank or banking institution including any bank, trust company, member bank of the federal
24 reserve system, bank and trust company, stock savings bank, or mutual savings bank that is organized and
25 doing business under the laws of this state, any other state, or the laws of the United States;

26 (b) a bank holding company as defined in 32-1-109;

27 (c) a company organized as an insurance company whose primary and predominant business activity

9 intermediary holding company licensee that directly or indirectly owns 10% or more of a licensee;

10 (f) a state or federal government pension plan; or

11 (g) any other entity identified by rule by the department.

12 (35) "Registered cardholder" or "cardholder" means a Montana resident with a debilitating medical
13 condition who has received and maintains a valid registry identification card.

14 (36) "Registry identification card" means a document issued by the department pursuant to 16-12-503
15 that identifies an individual as a registered cardholder.

16 (37) (a) "Resident" means an individual who meets the requirements of 1-1-215.

17 (b) An individual is not considered a resident for the purposes of this chapter if the individual:

18 (i) claims residence in another state or country for any purpose; or

19 (ii) is an absentee property owner paying property tax on property in Montana.

20 (38) "Seedling" means a marijuana plant that has no flowers and is less than 12 inches in height and
21 12 inches in diameter.

22 (39) "State laboratory" means the laboratory operated by the department of public health and human
23 services to conduct environmental analyses.

24 (40) "Testing laboratory" means a qualified person, licensed under this chapter that:

25 (a) provides testing of representative samples of marijuana and marijuana products; and

26 (b) provides information regarding the chemical composition and potency of a sample, as well as the
27 presence of molds, pesticides, or other contaminants in a sample.

1 (41) (a) "Usable marijuana" means the dried leaves and flowers of the marijuana plant that are
2 appropriate for the use of marijuana by an individual.

3 (b) The term does not include the seeds, stalks, and roots of the plant. (Subsection (15)(b)(ii)
4 terminates October 1, 2023--sec. 117(1), Ch. 576, L. 2021.)"

6 **Section 2.** Section 16-12-201, MCA, is amended to read:

7 **"16-12-201. Licensing of cultivators, manufacturers, and dispensaries.** (1) (a) Between January
8 1, 2022, and June 30, 2023, the department may only accept applications from and issue licenses to former
9 medical marijuana licensees that were licensed by or had an application pending with the department of public
10 health and human services on ~~November 3, 2020~~ April 27, 2021, and are in good standing with the department
11 and in compliance with this chapter, rules adopted by the department, and any applicable local regulations or
12 ordinances as of January 1, 2022.

13 (b) The department shall begin accepting applications for and issuing licenses to cultivate,
14 manufacture, or sell marijuana or marijuana products to applicants who are not former medical marijuana
15 licensees under subsection (1)(a) on or after July 1, 2023.

16 (2) (a) The department shall adopt rules to govern the operation of former medical marijuana
17 licensees and facilitate the process of transitioning former medical marijuana licensees to the appropriate
18 license under this chapter with a minimum of disruption to business operations.

19 (b) Beginning January 1, 2022, a former medical marijuana licensee may sell marijuana and
20 marijuana products to registered cardholders at the medical tax rate set forth in 15-64-102 and to consumers at
21 the adult-use marijuana tax rate set forth in 15-64-102 under the licensee's existing license in a jurisdiction that
22 allows for the operation of marijuana businesses pursuant to 16-12-301 until the former medical marijuana
23 licensee's next license renewal date, by which time the former medical licensee must have applied for and
24 obtained the appropriate licensure under this chapter to continue operations, unless an extension of time is
25 granted by the department.

26 (c) (i) Except as provided in subsection (2)(c)(ii), for the purpose of this subsection (2), "appropriate
27 licensure" means a cultivator license, medical marijuana dispensary license, adult-use dispensary license, and,

1 if applicable, a manufacturer license.

2 (ii) A former medical marijuana licensee who sells marijuana and marijuana products exclusively to
3 registered cardholders is not required to obtain an adult-use dispensary license.

4 (3) The department may amend or issue licenses to provide for staggered expiration dates. The
5 department may provide for initial license terms of greater than 12 months but no more than 23 months in
6 adopting staggered expiration dates. Thereafter, licenses expire annually. License fees for the license term
7 implementing staggered license terms may be prorated by the department."

9 **Section 3.** Section 16-12-207, MCA, is amended to read:

10 **"16-12-207. Licensing as privilege -- criteria.** (1) A cultivator license, manufacturer license, adult-
11 use dispensary license, medical marijuana dispensary license, combined-use marijuana license, marijuana
12 transporter license, or any other license authorized under this chapter is a privilege that the state may grant to
13 an applicant and is not a right to which an applicant is entitled. In making a licensing decision, the department
14 shall consider:

15 (a) the qualifications of the applicant; and

16 (b) the suitability of the proposed licensed premises, including but not limited to cultivation centers,
17 dispensaries, and manufacturing facilities.

18 (2) The department may deny or revoke a license based on proof that the applicant made a false
19 statement in any part of the original application or renewal application.

20 (3) (a) The department shall deny a cultivator license, manufacturer license, adult-use dispensary
21 license, or medical marijuana license if the applicant's proposed licensed premises:

22 (i) is situated within a zone of a locality where an activity related to the use of marijuana conflicts
23 with an ordinance, a certified copy of which has been filed with the department;

24 (ii) is not approved by local building, health, or fire officials as provided for in this chapter; or

25 (iii) is within 500 feet of and on the same street as a building used exclusively as a church,

26 synagogue, or other place of worship, ~~or~~ as a school or postsecondary school other than a commercially

27 operated school, or as a child-care facility licensed or registered by the department of public health and human

1 services, unless the locality requires a greater distance. This distance must be measured in a straight line from
2 the center of the nearest entrance of the place of worship or school to the nearest entrance of the licensee's
3 premises. This subsection (3)(a)(iii) does not apply if the application is for license renewal and the licensed
4 premises was established before the church, synagogue, or other place of worship or school or postsecondary
5 school or child-care facility existed on the same street.

6 (b) For the purposes of this subsection (3), "school" ~~and "postsecondary school"~~ have the
7 meanings provided in 20-5-402 includes public and private preschools.

8 (c) The provisions of subsection (3)(a)(iii) apply to new license applications submitted on or after
9 [the effective date of this section].

10 (4) A licensee may not sell or otherwise transfer marijuana or marijuana products through a drive-
11 up window, except that a dispensary may hand-deliver marijuana or marijuana products to a registered
12 cardholder in a vehicle that is parked immediately outside the subject dispensary.

13 (5) A marijuana business may not dispense or otherwise sell marijuana or marijuana products from
14 a vending machine or allow such a vending machine to be installed at the interior or exterior of the premises.

15 (6) A marijuana business may not utilize the United States postal service or an alternative carrier
16 other than a licensed marijuana transporter to transport, distribute, ship, or otherwise deliver marijuana or
17 marijuana products.

18 (7) A marijuana business may not provide free marijuana or marijuana products or offer samples of
19 marijuana or marijuana products.

20 (8) Marijuana or a marijuana product may not be given as a prize, premium, or consideration for a
21 lottery, contest, game of chance, game of skill, or competition of any kind.

22 (9) (a) Except as provided in subsection (9)(c), an adult-use dispensary or medical marijuana
23 dispensary must have a single, secured entrance for patrons and shall implement strict security measures to
24 deter and prevent the theft of marijuana and unauthorized entrance in accordance with department rule.

25 (b) Except as provided in subsection (9)(c), a marijuana business that is not an adult-use
26 dispensary or medical marijuana dispensary must implement security measures in accordance with department
27 rule to deter and prevent the theft of marijuana and unauthorized entrance.

- 3 (10) Each marijuana business shall install a video monitoring system that must, at a minimum:
4 (a) allow for the transmission and storage, by digital means, of a video feed that displays the
5 interior and exterior of the cannabis establishment; and
6 (b) be capable of being recorded as prescribed by the department.
- 7 (11) An adult-use dispensary or medical marijuana dispensary may not operate between the hours
8 of 8 p.m. and 9 a.m. daily.
- 9 (12) A person under 21 years of age is not permitted inside a marijuana business unless the person

12 **Section 4.** Section 16-12-223, MCA, is amended to read:

13 **"16-12-223. Licensing of cultivators.** (1) (a) The department shall license cultivators according to a
14 tiered canopy system. Except as provided in subsection (6), all cultivation that is licensed under this chapter
15 may only occur at an indoor cultivation facility.

16 (b) Except as provided in subsection (6), the system ~~shall~~must include, at a minimum, the
17 following license types:

18 (i) A micro tier canopy license allows for a canopy of up to 250 square feet at one indoor
19 cultivation facility.

20 (ii) A tier 1 canopy license allows for a canopy of up to 1,000 square feet at one indoor cultivation
21 facility.

22 (iii) A tier 2 canopy license allows for a canopy of up to 2,500 square feet at up to two indoor
23 cultivation facilities.

24 (iv) A tier 3 canopy license allows for a canopy of up to 5,000 square feet at up to three indoor
25 cultivation facilities.

26 (v) A tier 4 canopy license allows for a canopy of up to 7,500 square feet at up to four indoor
27 cultivation facilities.

- 15 (6) A former medical marijuana licensee who engaged in outdoor cultivation before November 3,
16 2020, may continue to engage in outdoor cultivation."

18 **Section 5.** Section 16-12-224, MCA, is amended to read:

19 **"16-12-224. Licensing of dispensaries.** (1) Except as provided in 16-12-201(2), an applicant for a
20 dispensary license shall demonstrate that the local government approval provisions in 16-12-301 have been
21 satisfied in the jurisdiction where each proposed dispensary is located if the proposed dispensary would be
22 located in a county in which the majority of voters voted against approval of Initiative Measure No. 190 in the
23 November 3, 2020, general election.

24 (2) When evaluating an initial or renewal application, the department shall evaluate each proposed
25 dispensary for compliance with the provisions of 16-12-207 and 16-12-210.

26 (3) An adult-use dispensary licensee may operate at a shared location with a medical marijuana
27 dispensary if the adult-use dispensary and medical marijuana dispensary are owned by the same person.

1 (4) A medical marijuana dispensary is authorized to sell exclusively to registered cardholders
2 marijuana, marijuana products, and live marijuana plants.

3 (5) An adult-use dispensary is authorized to sell marijuana, marijuana products, and live marijuana
4 plants to consumers or registered cardholders.

5 (6) (a) The department shall charge a dispensary license fee for an initial application and at each
6 renewal.

7 (b) The dispensary license fee is \$5,000 for ~~each~~ the first location that a licensee operates as an
8 adult-use dispensary or a medical marijuana dispensary. The dispensary license fee increases cumulatively by
9 \$5,000 for each additional location under the same license.

10 (7) The department may adopt rules:

11 (a) for inspection of proposed dispensaries;

12 (b) for investigating owners or applicants for a determination of financial interest; and

13 (c) establishing or limiting the THC content of the marijuana or marijuana products that may be
14 sold at an adult-use dispensary or medical marijuana dispensary.

15 (8) (a) Marijuana and marijuana products sold at a dispensary are regulated and sold on the basis
16 of the concentration of THC in the products and not by weight.

17 (b) Except as provided in subsection (8)(c), for purposes of this chapter, a single package is limited
18 to:
