4 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING LAWS RELATED TO MARIJUANA;  
5 ADDING PRESCHOOLS TO THE DISTANCE REQUIREMENT FOR A LICENSED PREMISES; ALLOWING A  
6 COMBINED-USE LICENSE TO INCREASE CANOPY TIERS; REVISING THE FEE STRUCTURE FOR  
7 LICENSING OF DISPENSARIES; REQUIRING A REPORT TO THE BOARD OF MEDICAL EXAMINERS  
8 UNDER CERTAIN CONDITIONS; PROVIDING AN APPROPRIATION; AMENDING SECTIONS 16-12-102, 16-  
9 12-201, 16-12-207, 16-12-223, 16-12-224, AND 16-12-225, AND 16-12-509, MCA; AND PROVIDING AN  
10 IMMEDIATE EFFECTIVE DATE EFFECTIVE DATES."

12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

14 **Section 1.** Section 16-12-102, MCA, is amended to read:

15 **"16-12-102. Definitions.** As used in this chapter, the following definitions apply:

16 (1) "Adult-use dispensary" means a licensed premises from which a person licensed by the  
17 department may:

18 (a) obtain marijuana or marijuana products from a licensed cultivator, manufacturer, dispensary, or  
19 other licensee approved under this chapter; and

20 (b) sell marijuana or marijuana products to registered cardholders, adults that are 21 years of age or  
21 older, or both.

22 (2) "Affiliate" means a person that directly, or indirectly through one or more intermediaries, controls  
23 or is controlled by, or is under common control with, another person.

24 (3) "Beneficial owner of", "beneficial ownership of", or "beneficially owns an" is determined in  
25 accordance with section 13(d) of the federal Securities and Exchange Act of 1934, as amended.

26 (4) "Canopy" means the total amount of square footage dedicated to live plant production at a  
27 licensed premises consisting of the area of the floor, platform, or means of support or suspension of the plant.

- 1 (5) "Consumer" means a person 21 years of age or older who obtains or possesses marijuana or  
2 marijuana products for personal use from a licensed dispensary but not for resale.
- 3 (6) "Control", "controls", "controlled", "controlling", "controlled by", and "under common control with"  
4 mean the possession, direct or indirect, of the power to direct or cause the direction of the management or  
5 policies of a person, whether through the ownership of voting owner's interests, by contract, or otherwise.
- 6 (7) "Controlling beneficial owner" means a person that satisfies one or more of the following:  
7 (a) is a natural person, an entity that is organized under the laws of and for which its principal place of  
8 business is located in one of the states or territories of the United States or District of Columbia, or a publicly  
9 traded corporation, and:  
10 (i) acting alone or acting in concert, owns or acquires beneficial ownership of 5% or more of the  
11 owner's interest of a marijuana business;  
12 (ii) is an affiliate that controls a marijuana business and includes, without limitation, any manager; or  
13 (iii) is otherwise in a position to control the marijuana business; or  
14 (b) is a qualified institutional investor acting alone or acting in concert that owns or acquires beneficial  
15 ownership of more than 15% of the owner's interest of a marijuana business.
- 16 (8) "Correctional facility or program" means a facility or program that is described in 53-1-202(2) or (3)  
17 and to which an individual may be ordered by any court of competent jurisdiction.
- 18 (9) "Cultivator" means a person licensed by the department to:  
19 (a) plant, cultivate, grow, harvest, and dry marijuana; and  
20 (b) package and relabel marijuana produced at the location in a natural or naturally dried form that  
21 has not been converted, concentrated, or compounded for sale through a licensed dispensary.
- 22 (10) "Debilitating medical condition" means:  
23 (a) cancer, glaucoma, positive status for human immunodeficiency virus, or acquired immune  
24 deficiency syndrome when the condition or disease results in symptoms that seriously and adversely affect the  
25 patient's health status;  
26 (b) cachexia or wasting syndrome;  
27 (c) severe chronic pain that is a persistent pain of severe intensity that significantly interferes with

2 (d) intractable nausea or vomiting;

3 (e) epilepsy or an intractable seizure disorder;

4 (f) multiple sclerosis;

5 (g) Crohn's disease;

6 (h) painful peripheral neuropathy;

7 (i) a central nervous system disorder resulting in chronic, painful spasticity or muscle spasms;

8 (j) admittance into hospice care in accordance with rules adopted by the department; or

9 (k) posttraumatic stress disorder.

10 (11) "Department" means the department of revenue provided for in 2-15-1301.

11 (12) (a) "Employee" means an individual employed to do something for the benefit of an employer.

12 (b) The term includes a manager, agent, or director of a partnership, association, company,

13 corporation, limited liability company, or organization.

14 (c) The term does not include a third party with whom a licensee has a contractual relationship.

15 (13) (a) "Financial interest" means a legal or beneficial interest that entitles the holder, directly or  
16 indirectly through a business, an investment, or a spouse, parent, or child relationship, to 5% or more of the net  
17 profits or net worth of the entity in which the interest is held.

18 (b) The term does not include interest held by a bank or licensed lending institution or a security  
19 interest, lien, or encumbrance but does include holders of private loans or convertible securities.

20 (14) "Former medical marijuana licensee" means a person that was licensed by or had an application  
21 for licensure pending with the department of public health and human services to provide marijuana to  
22 individuals with debilitating medical conditions on ~~November 3, 2020~~ April 27, 2021.

23 (15) (a) "Indoor cultivation facility" means an enclosed area used to grow live plants that is within a  
24 permanent structure using artificial light exclusively or to supplement natural sunlight.

25 (b) The term may include:

26 (i) a greenhouse;

27 (ii) a hoop house; or

- 2 (16) "Licensed premises" means all locations related to, or associated with, a specific license that is
- 3 authorized under this chapter and includes all enclosed public and private areas at the location that are used in
- 4 the business operated pursuant to a license, including offices, kitchens, restrooms, and storerooms.
- 5 (17) "Licensee" means a person holding a state license issued pursuant to this chapter.
- 6 (18) "Local government" means a county, a consolidated government, or an incorporated city or town.
- 7 (19) "Manufacturer" means a person licensed by the department to convert or compound marijuana
- 8 into marijuana products, marijuana concentrates, or marijuana extracts and package, repackage, label, or
- 9 relabel marijuana products as allowed under this chapter.
- 10 (20) (a) "Marijuana" means all plant material from the genus Cannabis containing
- 11 tetrahydrocannabinol (THC) or seeds of the genus capable of germination.
- 12 (b) The term does not include hemp, including any part of that plant, including the seeds and all
- 13 derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether growing or not, with a
- 14 delta-9 tetrahydrocannabinol concentration of not more than 0.3% on a dry weight basis, or commodities or
- 15 products manufactured with hemp, or any other ingredient combined with marijuana to prepare topical or oral
- 16 administrations, food, drink, or other products.
- 17 (c) The term does not include a drug approved by the United States food and drug administration
- 18 pursuant to section 505 of the Federal Food, Drug, and Cosmetic Act, 21 U.S.C. 301, et seq.
- 19 (21) "Marijuana business" means a cultivator, manufacturer, adult-use dispensary, medical marijuana
- 20 dispensary, combined-use marijuana licensee, testing laboratory, marijuana transporter, or any other business
- 21 or function that is licensed by the department under this chapter.
- 22 (22) "Marijuana concentrate" means any type of marijuana product consisting wholly or in part of the
- 23 resin extracted from any part of the marijuana plant.
- 24 (23) "Marijuana derivative" means any mixture or preparation of the dried leaves, flowers, resin, or
- 25 byproducts of the marijuana plant, including but not limited to marijuana concentrates and other marijuana
- 26 products.
- 27 (24) "Marijuana product" means a product that contains marijuana and is intended for use by a

1 consumer by a means other than smoking. The term includes but is not limited to edible products, ointments,  
2 tinctures, marijuana derivatives, and marijuana concentrates.

3 (25) "Marijuana transporter" means a person that is licensed to transport marijuana and marijuana  
4 products from one marijuana business to another marijuana business, or to and from a testing laboratory, and  
5 to temporarily store the transported retail marijuana and retail marijuana products at its licensed premises, but  
6 is not authorized to sell marijuana or marijuana products to consumers under any circumstances.

7 (26) "Mature marijuana plant" means a harvestable marijuana plant.

8 (27) "Medical marijuana" means marijuana or marijuana products that are for sale solely to a  
9 cardholder who is registered under Title 16, chapter 12, part 5.

10 (28) "Medical marijuana dispensary" means the location from which a registered cardholder may obtain  
11 marijuana or marijuana products.

12 (29) "Outdoor cultivation" means live plants growing in an area exposed to natural sunlight and  
13 environmental conditions including variable temperature, precipitation, and wind.

14 (30) "Owner's interest" means the shares of stock in a corporation, a membership in a nonprofit  
15 corporation, a membership interest in a limited liability company, the interest of a member in a cooperative or in  
16 a limited cooperative association, a partnership interest in a limited partnership, a partnership interest in a  
17 partnership, and the interest of a member in a limited partnership association.

18 (31) "Paraphernalia" has the meaning provided for "drug paraphernalia" in 45-10-101.

19 (32) "Passive beneficial owner" means any person acquiring an owner's interest in a marijuana  
20 business that is not otherwise a controlling beneficial owner or in control.

21 (33) "Person" means an individual, partnership, association, company, corporation, limited liability  
22 company, or organization.

23 (34) "Qualified institutional investor" means:

24 (a) a bank or banking institution including any bank, trust company, member bank of the federal  
25 reserve system, bank and trust company, stock savings bank, or mutual savings bank that is organized and  
26 doing business under the laws of this state, any other state, or the laws of the United States;

27 (b) a bank holding company as defined in 32-1-109;

1 (c) a company organized as an insurance company whose primary and predominant business activity  
2 is the writing of insurance or the reinsuring of risks underwritten by insurance companies, and that is subject to  
3 regulation or oversight by the insurance department of the office of the state auditor or a similar agency of  
4 another state, or any receiver or similar official or any liquidating agent for such a company, in their capacity as  
5 such an insurance company;

6 (d) an investment company registered under section 8 of the federal Investment Company Act of  
7 1940, as amended;

8 (e) an employee benefit plan or pension fund subject to the federal Employee Retirement Income  
9 Security Act of 1974, excluding an employee benefit plan or pension fund sponsored by a licensee or an  
10 intermediary holding company licensee that directly or indirectly owns 10% or more of a licensee;

11 (f) a state or federal government pension plan; or

12 (g) any other entity identified by rule by the department.

13 (35) "Registered cardholder" or "cardholder" means a Montana resident with a debilitating medical  
14 condition who has received and maintains a valid registry identification card.

15 (36) "Registry identification card" means a document issued by the department pursuant to 16-12-503  
16 that identifies an individual as a registered cardholder.

17 (37) (a) "Resident" means an individual who meets the requirements of 1-1-215.

18 (b) An individual is not considered a resident for the purposes of this chapter if the individual:

19 (i) claims residence in another state or country for any purpose; or

20 (ii) is an absentee property owner paying property tax on property in Montana.

21 (38) "Seedling" means a marijuana plant that has no flowers and is less than 12 inches in height and  
22 12 inches in diameter.

23 (39) "State laboratory" means the laboratory operated by the department of public health and human  
24 services to conduct environmental analyses.

25 (40) "Testing laboratory" means a qualified person, licensed under this chapter that:

26 (a) provides testing of representative samples of marijuana and marijuana products; and

27 (b) provides information regarding the chemical composition and potency of a sample, as well as the

2 (41) (a) "Usable marijuana" means the dried leaves and flowers of the marijuana plant that are  
3 appropriate for the use of marijuana by an individual.

4 (b) The term does not include the seeds, stalks, and roots of the plant. (Subsection (15)(b)(ii)  
5 terminates October 1, 2023--sec. 117(1), Ch. 576, L. 2021.)"

7 **Section 2.** Section 16-12-201, MCA, is amended to read:

8 **"16-12-201. Licensing of cultivators, manufacturers, and dispensaries.** (1) (a) Between January  
9 1, 2022, and June 30, 2023, the department may only accept applications from and issue licenses to former  
10 medical marijuana licensees that were licensed by or had an application pending with the department of public  
11 health and human services on ~~November 3, 2020~~ April 27, 2021, and are in good standing with the department  
12 and in compliance with this chapter, rules adopted by the department, and any applicable local regulations or  
13 ordinances as of January 1, 2022.

14 (b) The department shall begin accepting applications for and issuing licenses to cultivate,  
15 manufacture, or sell marijuana or marijuana products to applicants who are not former medical marijuana  
16 licensees under subsection (1)(a) on or after July 1, 2023.

17 (2) (a) The department shall adopt rules to govern the operation of former medical marijuana  
18 licensees and facilitate the process of transitioning former medical marijuana licensees to the appropriate  
19 license under this chapter with a minimum of disruption to business operations.

20 (b) Beginning January 1, 2022, a former medical marijuana licensee may sell marijuana and  
21 marijuana products to registered cardholders at the medical tax rate set forth in 15-64-102 and to consumers at  
22 the adult-use marijuana tax rate set forth in 15-64-102 under the licensee's existing license in a jurisdiction that  
23 allows for the operation of marijuana businesses pursuant to 16-12-301 until the former medical marijuana  
24 licensee's next license renewal date, by which time the former medical licensee must have applied for and  
25 obtained the appropriate licensure under this chapter to continue operations, unless an extension of time is  
26 granted by the department.

27 (c) (i) Except as provided in subsection (2)(c)(ii), for the purpose of this subsection (2), "appropriate

3 (ii) A former medical marijuana licensee who sells marijuana and marijuana products exclusively to  
4 registered cardholders is not required to obtain an adult-use dispensary license.

5 (3) The department may amend or issue licenses to provide for staggered expiration dates. The  
6 department may provide for initial license terms of greater than 12 months but no more than 23 months in  
7 adopting staggered expiration dates. Thereafter, licenses expire annually. License fees for the license term  
8 implementing staggered license terms may be prorated by the department."

10 **Section 3.** Section 16-12-207, MCA, is amended to read:

11 **"16-12-207. Licensing as privilege -- criteria.** (1) A cultivator license, manufacturer license, adult-  
12 use dispensary license, medical marijuana dispensary license, combined-use marijuana license, marijuana  
13 transporter license, or any other license authorized under this chapter is a privilege that the state may grant to  
14 an applicant and is not a right to which an applicant is entitled. In making a licensing decision, the department  
15 shall consider:

16 (a) the qualifications of the applicant; and

17 (b) the suitability of the proposed licensed premises, including but not limited to cultivation centers,  
18 dispensaries, and manufacturing facilities.

19 (2) The department may deny or revoke a license based on proof that the applicant made a false  
20 statement in any part of the original application or renewal application.

21 (3) (a) The department shall deny a cultivator license, manufacturer license, adult-use dispensary  
22 license, or medical marijuana license if the applicant's proposed licensed premises:

23 (i) is situated within a zone of a locality where an activity related to the use of marijuana conflicts  
24 with an ordinance, a certified copy of which has been filed with the department;

25 (ii) is not approved by local building, health, or fire officials as provided for in this chapter; or

26 (iii) is within 500 feet of and on the same street as a building used exclusively as a church,  
27 synagogue, or other place of worship, ~~or~~ as a school or postsecondary school other than a commercially

1 operated school, or as a child-care facility licensed or registered by the department of public health and human

3 the center of the nearest entrance of the place of worship or school to the nearest entrance of the licensee's  
4 premises. This subsection (3)(a)(iii) does not apply if the application is for license renewal and the licensed

12 up window, except that a dispensary may hand-deliver marijuana or marijuana products to a registered  
13 cardholder in a vehicle that is parked immediately outside the subject dispensary.

14 (5) A marijuana business may not dispense or otherwise sell marijuana or marijuana products from  
15 a vending machine or allow such a vending machine to be installed at the interior or exterior of the premises.

16 (6) A marijuana business may not utilize the United States postal service or an alternative carrier  
17 other than a licensed marijuana transporter to transport, distribute, ship, or otherwise deliver marijuana or  
18 marijuana products.

19 (7) A marijuana business may not provide free marijuana or marijuana products or offer samples of  
20 marijuana or marijuana products.

21 (8) Marijuana or a marijuana product may not be given as a prize, premium, or consideration for a  
22 lottery, contest, game of chance, game of skill, or competition of any kind.

23 (9) (a) Except as provided in subsection (9)(c), an adult-use dispensary or medical marijuana  
24 dispensary must have a single, secured entrance for patrons and shall implement strict security measures to  
25 deter and prevent the theft of marijuana and unauthorized entrance in accordance with department rule.

26 (b) Except as provided in subsection (9)(c), a marijuana business that is not an adult-use  
27 dispensary or medical marijuana dispensary must implement security measures in accordance with department

1 rule to deter and prevent the theft of marijuana and unauthorized entrance.

2 (c) The provisions of this subsection (9) do not supersede any state or local requirements relating  
3 to minimum numbers of points of entry or exit or any state or local requirements relating to fire safety.

4 (10) Each marijuana business shall install a video monitoring system that must, at a minimum:

5 (a) allow for the transmission and storage, by digital means, of a video feed that displays the  
6 interior and exterior of the cannabis establishment; and

7 (b) be capable of being recorded as prescribed by the department.

8 (11) An adult-use dispensary or medical marijuana dispensary may not operate between the hours  
9 of 8 p.m. and 9 a.m. daily.

10 (12) A person under 21 years of age is not permitted inside a marijuana business unless the person  
11 is a registered cardholder."

13 **Section 4.** Section 16-12-223, MCA, is amended to read:

14 **"16-12-223. Licensing of cultivators.** (1) (a) The department shall license cultivators according to a  
15 tiered canopy system. Except as provided in subsection (6), all cultivation that is licensed under this chapter  
16 may only occur at an indoor cultivation facility.

17 (b) Except as provided in subsection (6), the system shall must include, at a minimum, the  
18 following license types:

19 (i) A micro tier canopy license allows for a canopy of up to 250 square feet at one indoor  
20 cultivation facility.

21 (ii) A tier 1 canopy license allows for a canopy of up to 1,000 square feet at one indoor cultivation  
22 facility.

23 (iii) A tier 2 canopy license allows for a canopy of up to 2,500 square feet at up to two indoor  
24 cultivation facilities.

25 (iv) A tier 3 canopy license allows for a canopy of up to 5,000 square feet at up to three indoor  
26 cultivation facilities.

27 (v) A tier 4 canopy license allows for a canopy of up to 7,500 square feet at up to four indoor

21 dispensary license shall demonstrate that the local government approval provisions in 16-12-301 have been  
22 satisfied in the jurisdiction where each proposed dispensary is located if the proposed dispensary would be  
23 located in a county in which the majority of voters voted against approval of Initiative Measure No. 190 in the  
24 November 3, 2020, general election.

25 (2) When evaluating an initial or renewal application, the department shall evaluate each proposed  
26 dispensary for compliance with the provisions of 16-12-207 and 16-12-210.
