4 A BILL FOR AN ACT ENTITLED: "AN ACT REVISING PHARMACIST PRESCRIBING AUTHORITY TO
5 ALLOW THE PRESCRIBING OF CERTAIN DRUGS OR DEVICES UNDER LIMITED CIRCUMSTANCES;
6 PROVIDING DEFINITIONS; AMENDING SECTIONS 37-2-101, 37-2-102, 37-2-103, 37-2-104, 37-2-108, 37-7-
7 101, AND 37-7-103, MCA."

9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10
11 NEW SECTION. Section 1. Pharmacist prescribing authority -- exception. (1) A pharmacist may
12 prescribe a drug or device for a legitimate medical purpose as allowed under this section for a person with
13 whom the pharmacist has a patient-prescriber relationship.

14 (2) A pharmacist shall establish the patient-prescriber relationship through a documented patient
15 evaluation that is adequate to:

- 16 (a) establish diagnoses, if the drug or device is being prescribed pursuant to subsection (3)(b); and
17 (b) identify underlying conditions and contraindications to the treatment.

18 (3) A pharmacist's prescribing authority is limited to drugs and devices that are prescribed for
19 conditions that:

- 20 (a) do not require a new diagnosis; or
21 (b) (i) are minor and generally self-limiting;
22 (ii) are diagnosed by or for which clinical decisions are made using a test that is waived under the
23 federal clinical laboratory improvement amendments of 1988; or
24 (iii) are patient emergencies.

25 (4) A pharmacist may:
26 (a) prescribe only the drugs or devices for which the pharmacist is educationally prepared and for
27 which competency has been achieved and maintained; and

1 (b) bill only for assessment services that were necessary, based on the pharmacist's professional
2 judgment, for the pharmacist's decision to prescribe a drug or device pursuant to this section.

3 (5) A pharmacist may not prescribe a controlled substance.

4 (6) A pharmacist prescribing a drug or device pursuant to this section shall:

5 (a) recognize the limits of the pharmacist's knowledge and experience and consult with and refer
6 to other health care providers as appropriate; and

7 (b) maintain documentation sufficient to justify the care provided, including but not limited to the:

8 (i) information collected as part of the patient record;

9 (ii) prescription record;

10 (iii) provider notification; and

11 (iv) follow-up care plan.

12 (7) This section does not apply to a pharmacist who is operating within a collaborative pharmacy
13 practice agreement.

23 (a) for use in the diagnosis, cure, mitigation, treatment, or prevention of disease in humans;

26 (5)(6) "Drug" has the meaning provided in 37-7-101.

16 other business entity.

17 ~~(12)~~(13)– _____ "Pharmacy" has the meaning provided in 37-7-101.

18 ~~(13)~~(14)– _____ "State" means the state of Montana or any political subdivision of the state."

20 **Section 3.** Section 37-2-102, MCA, is amended to read:

21 **"37-2-102. Practices declared unlawful between drug companies and medical practitioners --**

22 **exception.** (1) ~~It~~ Except as provided in subsection (2), it is unlawful:

23 ~~(1)~~(a) for a drug company to give or sell to a medical practitioner any legal or beneficial interest in the

24 company or in the income of the company with the intent or for the purpose of inducing the medical practitioner

25 to prescribe to patients the drugs of the company. The giving or selling of an interest by the company to a

26 medical practitioner without the interest first having been publicly offered to the general public is prima facie

27 evidence of the intent or purpose.

13 **"37-2-103. Practices declared unlawful between medical practitioners and pharmacies --**

14 **exceptions.** (1) It is unlawful for a medical practitioner other than a pharmacist to own, directly or indirectly, a
15 community pharmacy. This subsection does not prohibit a medical practitioner from dispensing a drug that the
16 medical practitioner is permitted to dispense under 37-2-104.

17 (2) It is unlawful for a medical practitioner, directly or indirectly, to solicit or to knowingly receive
18 from a community pharmacy or for a community pharmacy knowingly to pay or promise to pay to a medical
19 practitioner any rebate, refund, discount, commission, or other valuable consideration for, on account of, or
20 based upon income received or resulting from the sale or furnishing by the community pharmacy of drugs to
21 patients of a medical practitioner.

22 (3) Subsection (2) does not prohibit a pharmacy licensed under Title 37, chapter 7, from
23 undertaking activities allowed under Title 37, chapter 7."

25 **Section 5.** Section 37-2-104, MCA, is amended to read:

26 **"37-2-104. Dispensing of drugs by medical practitioners -- registration -- exceptions.** (1) Subject
27 to subsection (7), a medical practitioner may dispense drugs if the practitioner:

3 (2) Drugs dispensed by a medical practitioner must be:
4 (a) dispensed directly by the practitioner at the practitioner's office or place of practice;
5 (b) dispensed only to the practitioner's own patients; and
6 (c) necessary in the treatment of the condition for which the practitioner is attending the patient.
7 (3) Before dispensing a drug, a medical practitioner shall offer to give a patient the prescription in a
8 written, electronic, or facsimile form that the patient may choose to have filled by the practitioner or any
9 pharmacy.
10 (4) Except as otherwise provided in this section, a medical practitioner:
11 (a) may dispense only those drugs that the practitioner is allowed to prescribe under the

14 (b) may not dispense a controlled substance unless the practitioner is engaged in the practice of
15 pharmacy and is dispensing a controlled substance pursuant to Title 37, chapter 7.
16 (5) A medical practitioner dispensing drugs shall comply with and is subject to the provisions of this
17 part and the provisions of:
18 (a) Title 37, chapter 7, parts 4, 5, and 15;
19 (b) Title 50, chapter 31, parts 3 and 5;
20 (c) the labeling, storage, inspection, and recordkeeping requirements established by the board of
21 pharmacy; and
22 (d) all applicable federal laws and regulations.
23 (6) A medical practitioner registering with the board of pharmacy shall pay a fee established by the
24 board by rule. The fee must be paid at the time of registration and on each renewal of the practitioner's license.

5 practitioner;

7 pharmacy available to the patient;

23 this subsection (8)(h) must meet the labeling, storage, and recordkeeping requirements of the board of
24 pharmacy.
 - 25 (i) a medical practitioner from dispensing an opioid antagonist as provided in 50-32-605."

27 **Section 6.** Section 37-2-108, MCA, is amended to read:

1 **"37-2-108. (Temporary) Restriction on prescriptions for opioid-naive patients -- exceptions. (1)**

2 Except as provided in subsection (2), when a medical practitioner or a naturopathic physician authorized to
3 prescribe an opioid prescribes an opioid to an opioid-naive patient on an outpatient basis, the prescription may
4 not be for more than a 7-day supply.

5 (2) The restriction imposed under subsection (1) does not apply if:

6 (a) in the professional medical judgment of the medical practitioner or naturopathic physician, a
7 prescription for more than a 7-day supply is necessary to treat chronic pain, pain associated with cancer, or
8 pain experienced while the patient is in palliative care; or

9 (b) the opioid being prescribed is designed for the treatment of opioid abuse or dependence,
10 including but not limited to opioid agonists and opioid antagonists. (Terminates June 30, 2025--sec. 8, Ch. 89,
11 L. 2019.)"

13 **Section 7.** Section 37-7-101, MCA, is amended to read:

14 **"37-7-101. Definitions.** As used in this chapter, the following definitions apply:

15 (1) (a) "Administer" means the direct application of a drug to the body of a patient by injection,
16 inhalation, ingestion, or any other means.

17 (b) Except as provided in 37-7-105, the term does not include immunization by injection for
18 children under 18 years of age.

19 (2) "Board" means the board of pharmacy provided for in 2-15-1733.

20 (3) "Cancer drug" means a prescription drug used to treat:

21 (a) cancer or its side effects; or

22 (b) the side effects of a prescription drug used to treat cancer or its side effects.

23 (4) "Chemical" means medicinal or industrial substances, whether simple, compound, or obtained
24 through the process of the science and art of chemistry, whether of organic or inorganic origin.

25 (5) "Clinical pharmacist practitioner" means a licensed pharmacist in good standing who meets the
26 requirements specified in 37-7-306.

27 (6) "Collaborative pharmacy practice" means the practice of pharmacy by a pharmacist who has

1 agreed to work in conjunction with one or more prescribers, on a voluntary basis and under protocol, and who
2 may perform certain patient care functions under certain specified conditions or limitations authorized by the
3 prescriber.

4 (7) "Collaborative pharmacy practice agreement" means a written and signed agreement between
5 one or more pharmacists and one or more prescribers that provides for collaborative pharmacy practice for the
6 purpose of drug therapy management of patients.

7 (8) "Commercial purposes" means the ordinary purposes of trade, agriculture, industry, and
8 commerce, exclusive of the practices of medicine and pharmacy.

9 (9) "Compounding" means the preparation, mixing, assembling, packaging, or labeling of a drug or
10 device based on:

11 (a) a practitioner's prescription drug order;

12 (b) a professional practice relationship between a practitioner, pharmacist, and patient;

13 (c) research, instruction, or chemical analysis, but not for sale or dispensing; or

14 (d) the preparation of drugs or devices based on routine, regularly observed prescribing patterns.

15 (10) "Confidential patient information" means privileged information accessed by, maintained by, or
16 transmitted to a pharmacist in patient records or that is communicated to the patient as part of patient
17 counseling.

18 (11) "Controlled substance" means a substance designated in Schedules II through V of Title 50,
19 chapter 32, part 2.

20 (12) "Department" means the department of labor and industry provided for in Title 2, chapter 15,
21 part 17.

22 (13) "Device" has the same meaning as defined in 37-2-101.

23 (14) "Dispense" or "dispensing" means the interpretation, evaluation, and implementation of a
24 prescription drug order, including the preparation and delivery of a drug or device to a patient or patient's agent
25 in a suitable container appropriately labeled for administration to or use by a patient.

26 (15) "Distribute" or "distribution" means the sale, purchase, trade, delivery, handling, storage, or
27 receipt of a drug or device and does not include administering or dispensing a prescription drug, pursuant to

- 3 (16) "Drug" means a substance:
- 4 (a) recognized as a drug in any official compendium or supplement;
- 5 (b) intended for use in diagnosis, cure, mitigation, treatment, or prevention of disease in humans or
6 animals;
- 7 (c) other than food, intended to affect the structure or function of the body of humans or animals;
- 8 and
- 9 (d) intended for use as a component of a substance specified in subsection (16)(a), (16)(b), or
10 (16)(c).
- 11 (17) "Drug utilization review" means an evaluation of a prescription drug order and patient records
12 for duplication of therapy, interactions, proper utilization, and optimum therapeutic outcomes. The term includes
13 but is not limited to the following evaluations:
- 14 (a) known allergies;
- 15 (b) rational therapy contraindications;
- 16 (c) reasonable dose and route administration;
- 17 (d) reasonable directions for use;
- 18 (e) drug-drug interactions;
- 19 (f) drug-food interactions;
- 20 (g) drug-disease interactions; and
- 21 (h) adverse drug reactions.
- 22 (18) "Equivalent drug product" means a drug product that has the same established name, active
23 ingredient or ingredients, strength or concentration, dosage form, and route of administration and meets the
24 same standards as another drug product as determined by any official compendium or supplement. Equivalent
25 drug products may differ in shape, scoring, configuration, packaging, excipients, and expiration time.
- 26 (19) "FDA" means the United States food and drug administration.
- 27 (20) "Health care facility" has the meaning provided in 50-5-101.

3 less than 24 consecutive hours to a person not residing at or confined to the facility.

4 (b) The term includes an outpatient center for primary care and an outpatient center for surgical
5 services, as those terms are defined in 50-5-101, and a local public health agency as defined in 50-1-101.

6 (c) The term does not include a facility that provides routine health screenings, health education,
7 or immunizations.

8 (22) "Health information system" means one of the following systems used to compile and manage
9 patient health care information:

- 10 (a) an electronic health record system;
- 11 (b) a health information exchange approved by the board;
- 12 (c) a pharmacy dispensing system; or
- 13 (d) a system defined by the board by rule.

14 (23) "Hospital" has the meaning provided in 50-5-101.

15 (24) "Immunization-certified pharmacist" means a pharmacist who:

16 (a) has successfully completed an immunization delivery course of training that is approved by the
17 accreditation council for pharmacy education or by an authority approved by the board and that, at a minimum,
18 includes instruction in hands-on injection technique, clinical evaluation of indications and contraindications of
19 immunizations, storage and handling of immunizations, and documentation and reporting; and

20 (b) holds a current basic cardiopulmonary resuscitation certification issued by the American heart
21 association, the American red cross, or another recognized provider.

22 (25) "Intern" means:

23 (a) a person who is licensed by the state to engage in the practice of pharmacy while under the
24 personal supervision of a preceptor and who is satisfactorily progressing toward meeting the requirements for
25 licensure as a pharmacist;

26 (b) a graduate of an accredited college of pharmacy who is licensed by the state for the purpose of
27 obtaining practical experience as a requirement for licensure as a pharmacist;

- 13 Act, 21 U.S.C. 301 et seq.
- 14 (30) "Participant" means a physician's office, pharmacy, hospital, or health clinic that has elected to
- 15 voluntarily participate in the cancer drug repository program provided for in 37-7-1403 and that accepts donated
- 16 cancer drugs or devices under rules adopted by the board.
- 17 (31) "Patient counseling" means the communication by the pharmacist of information, as defined by
- 18 the rules of the board, to the patient or caregiver in order to ensure the proper use of drugs or devices.
- 19 (32) "Person" includes an individual, partnership, corporation, association, or other legal entity.
- 20 (33) "Pharmaceutical care" means the provision of drug therapy and other patient care services
- 21 intended to achieve outcomes related to the cure or prevention of a disease, elimination or reduction of a
- 22 patient's symptoms, or arresting or slowing of a disease process.
- 23 (34) "Pharmacist" means a person licensed by the state to engage in the practice of pharmacy and
- 24 who may affix to the person's name the term "R.Ph."
- 25 (35) "Pharmacy" means an established location, either physical or electronic, registered by the
- 26 board where drugs or devices are dispensed with pharmaceutical care or where pharmaceutical care is
- 27 provided.

3 (37) "Poison" means a substance that, when introduced into the system, either directly or by
4 absorption, produces violent, morbid, or fatal changes or that destroys living tissue with which it comes in
5 contact.

6 (38) "Practice of pharmacy" means:

7 (a) interpreting, evaluating, and implementing prescriber orders;

8 (b) administering drugs and devices pursuant to a collaborative practice agreement, except as

3 (43) "Prescription drug order" means an order from a prescriber for a drug or device that is
4 communicated directly or indirectly by the prescriber to the furnisher by means of a signed order, by electronic
5 transmission, in person, or by telephone. The order must include the name and address of the prescriber, the
6 prescriber's license classification, the name and address of the patient, the name, strength, and quantity of the
7 drug, drugs, or device prescribed, the directions for use, and the date of its issue. These stipulations apply to
8 written, oral, electronically transmitted, and telephoned prescriptions and orders derived from collaborative
9 pharmacy practice.

10 (44) "Provisional community pharmacy" means a pharmacy that has been approved by the board,
11 including but not limited to federally qualified health centers, as defined in 42 CFR 405.2401, where prescription
12 drugs are dispensed to appropriately screened, qualified patients.

13 (45) "Qualified patient" means a person who is uninsured, indigent, or has insufficient funds to
14 obtain needed prescription drugs or cancer drugs.

15 (46) "Registry" means the prescription drug registry provided for in 37-7-1502.

16 (47) "Utilization plan" means a plan under which a pharmacist may use the services of a pharmacy
17 technician in the practice of pharmacy to perform tasks that:

- 18 (a) do not require the exercise of the pharmacist's independent professional judgment; and
19 (b) are verified by the pharmacist.

20 (48) "Wholesale" means a sale for the purpose of resale."

24 **"37-7-103. Exemptions.** Subject only to 37-2-104, 37-7-401, and 37-7-402, this chapter does not:

- 25 (1) subject a medical practitioner, as defined in 37-2-101, who is not a pharmacist or a person who
26 is licensed in this state to practice veterinary medicine to inspection by the board, prevent the person from
27 compounding or using drugs, medicines, chemicals, or poisons in the person's practice, or prevent a medical
