20 **Section 1.** Section 5-11-222, MCA, is amended to read:

22 the legislature means a biennial report required by the legislature and filed in accordance with 5-11-210 on or

18 (ii) any metal or mineral, including a precious metal, or any gem or gemstone, whether
19 characterized as precious, semiprecious, or otherwise;

20 (iii) any fuel, whether liquid, gaseous, or otherwise;

21 (iv) foreign currency; and

22 (v) all other goods, articles, products, or items of any kind.

23 (b) Commodity does not include:

24 (i) a numismatic coin with a fair market value at least 15% higher than the value of the metal it
25 contains;

26 (ii) real property or any timber, agricultural, or livestock product grown or raised on real property
27 and offered and sold by the owner or lessee of the real property; or

28 (iii) any work of art offered or sold by an art dealer at public auction or offered or sold through a

1 private sale by the owner.

3 (5) "Commodity futures trading commission" means the independent regulatory agency

5 (6) (a) "Commodity investment contract" means any account, agreement, or contract for the
6 purchase or sale, primarily for speculation or investment purposes and not for use or consumption by the
7 offeree or purchaser, of one or more commodities, whether for immediate or subsequent delivery or whether
8 delivery is intended by the parties and whether characterized as a cash contract, deferred shipment or deferred
9 delivery contract, forward contract, futures contract, installment or margin contract, leverage contract, or
10 otherwise. Any commodity investment contract offered or sold, in the absence of evidence to the contrary, is
11 presumed to be offered or sold for speculation or investment purposes.

12 (b) A commodity investment contract does not include a contract or agreement that requires, and
13 under which the purchaser receives, within 28 calendar days after the payment in good funds of any portion of
14 the purchase price, physical delivery of the total amount of each commodity to be purchased under the contract
15 or agreement. The purchaser is not considered to have received physical delivery of the total amount of each
16 commodity to be purchased under the contract or agreement when the commodity or commodities are held as
17 collateral for a loan or are subject to a lien of any person when the loan or lien arises in connection with the
18 purchase of each commodity or commodities.

1 the Securities Act of 1933 or rules promulgated by the commissioner.

2 (10) "Financial exploitation" means:

3 (a) the wrongful or unauthorized taking, withholding, appropriation, or use of money, assets, or
4 property of a vulnerable person; or

5 (b) an act or omission taken by a person, including through the use of a power of attorney,
6 guardianship, or conservatorship of a vulnerable person, to:

7 (i) obtain control through deception, intimidation, fraud, menace, or undue influence over the
8 vulnerable person's money, assets, or property to deprive the vulnerable person of the ownership, use, benefit,
9 or possession of the vulnerable person's money, assets, or property; or

10 (ii) convert money, assets, or property of the vulnerable person to deprive the vulnerable person of
11 the ownership, use, benefit, or possession of the vulnerable person's money, assets, or property.

12 (11) "Guaranteed" means guaranteed as to payment of principal, interest, or dividends.

13 (12) (a) "Investment adviser" means a person who, for compensation, engages in the business of
14 advising others, either directly or through publications or writings, as to the value of securities or as to the
15 advisability of investing in, purchasing, or selling securities or who, for compensation and as a part of a regular
16 business, issues or promulgates analyses or reports concerning securities.

17 (b) The term includes a financial planner or other person who:

18 (i) as an integral component of other financially related services, provides the investment advisory
19 services described in subsection (12)(a) to others for compensation, as part of a business; or

20 (ii) represents to any person that the financial planner or other person provides the investment
21 advisory services described in subsection (12)(a) to others for compensation.

22 (c) The term does not include:

23 (i) an investment adviser representative;

24 (ii) a bank, savings institution, trust company, or insurance company;

25 (iii) a lawyer or accountant whose performance of these services is solely incidental to the practice

27 referral, or other remuneration as a result of the purchase or sale of securities by a client, does not recommend
28 the purchase or sale of specific securities, and does not have custody of client funds or securities for

2 (iv) a registered broker-dealer whose performance of services described in subsection (12)(a) is
3 solely incidental to the conduct of business and for which the broker-dealer does not receive special

5 (v) a publisher of any newspaper, news column, newsletter, news magazine, or business or
6 financial publication or service, whether communicated in hard copy form or by electronic means or otherwise,
7 that does not consist of the rendering of advice on the basis of the specific investment situation of each client;

8 (vi) a person whose advice, analyses, or reports relate only to securities exempted by 30-10-

10 (vii) an engineer or teacher whose performance of the services described in subsection (12)(a) is
11 solely incidental to the practice of the person's profession;

12 (viii) a federal covered adviser; or

13 (ix) other persons not within the intent of this subsection (12) as the commissioner may by rule or

15 (13) (a) "Investment adviser representative" means:

16 (i) any partner of, officer of, director of, or a person occupying a similar status or performing
17 similar functions, or other individual, except clerical or ministerial personnel, employed by or associated with an
18 investment adviser who:

19 (A) makes any recommendation or otherwise renders advice regarding securities to clients;

20 (B) manages accounts or portfolios of clients;

21 (C) solicits, offers, or negotiates for the sale of or sells investment advisory services; or

22 (D) supervises employees who perform any of the foregoing; and

23 (ii) with respect to a federal covered adviser, any person who is an investment adviser
24 representative with a place of business in this state as those terms are defined by the securities and exchange
25 commission under the Investment Advisers Act of 1940.

20 **"50-20-709. Reporting on chemical abortions.** (1) For the purpose of promoting maternal health
21 and adding to the sum of medical and public health knowledge through the compilation of relevant data, a
22 report of each chemical abortion performed must be made to the department on forms prescribed by the
23 department. The reports must be completed by the facility in which the abortion-inducing drug was provided,
24 signed by the qualified medical practitioner who provided the abortion-inducing drug, and transmitted to the
25 department within 15 days after each reporting month.

26 (2) A report must include, at a minimum, the following information:

27 (a) identification of the qualified medical practitioner who provided the abortion-inducing drug;

28 (b) whether the chemical abortion was completed at the facility in which the abortion-inducing drug

1 was provided or at an alternative location;

2 (c) the referring medical practitioner, agency, or service, if any;

3 (d) the pregnant woman's county, state, and country of residence;

4 (e) the pregnant woman's age and race;

5 (f) the number of previous pregnancies, number of live births, and number of previous abortions of
6 the pregnant woman;

7 (g) the probable gestational age of the unborn child as determined by both patient history and
8 ultrasound results used to confirm the gestational age. The report must include the date of the ultrasound and
9 gestational age determined on that date.

10 (h) the abortion-inducing drug or drugs used, the date each was provided to the pregnant woman,
11 and the reason for the abortion, if known;

12 (i) preexisting medical conditions of the pregnant woman that would complicate the pregnancy, if
13 any;

14 (j) whether the woman returned for a follow-up examination to determine completion of the
15 abortion procedure and to assess bleeding, the date and results of the follow-up examination, and what
16 reasonable efforts were made by the qualified medical practitioner to encourage the woman to return for a
17 follow-up examination if the woman did not;

18 (k) whether the woman suffered any complications and, if so, what specific complications arose
19 and what follow-up treatment was needed; and

20 (l) the amount billed to cover the treatment for specific complications, including whether the
21 treatment was billed to medicaid, private insurance, private pay, or another method, including charges for any
22 physician, hospital, emergency room, prescription or other drugs, laboratory tests, and other costs for treatment
23 rendered.

24 (3) Reports required under this section may not contain:

25 (a) the name of the pregnant woman;

26 (b) common identifiers, such as a social security number or driver's license number; or

27 (c) other information or identifiers that would make it possible to identify, in any manner or under
28 any circumstances, a pregnant woman who has obtained or seeks to obtain a chemical abortion.

1 (4) A qualified medical practitioner who provides an abortion-inducing drug to a pregnant woman
2 who knows that the woman experiences, during or after the use of the abortion-inducing drug, an adverse event
3 shall provide a written report of the adverse event within 3 days of the event to the United States food and drug
4 administration via the medwatch reporting system, to the department, and to the state board of medical
5 examiners.

6 (5) (a) A medical practitioner, qualified medical practitioner, associated medical practitioner, or
7 other health care provider who treats a woman, either contemporaneously to or at any time after a chemical
8 abortion, for an adverse event or complication related to a chemical abortion shall make a report of the adverse
9 event to the department on forms prescribed by the department. The reports must be completed by the facility
10 in which the adverse event or complication treatment was provided, signed by the medical practitioner, qualified
11 medical practitioner, associated medical practitioner, or other health care provider who treated the adverse
12 event or complication, and transmitted to the department within 15 days after each reporting month.

13 (b) The report must include, at a minimum:

14 (i) the information required under subsections (2)(a) through (2)(j) and (2)(l); and

15 (ii) information about the specific complications that arose, whether an emergency transfer was
16 required, and whether any followup treatment was needed, including whether additional drugs or medications
17 were provided in order to complete the abortion.

18 (6) The department shall ~~prepare~~ provide, in accordance with 5-11-210, a comprehensive annual
19 statistical report for the legislature based on the data gathered from reports under this section. The aggregated
20 data must also be made available to the public by the department in a downloadable format.

21 (7) The department shall summarize aggregate data from the reports required under this part and
22 submit the data to the U.S. centers for disease control and prevention for the purpose of inclusion in the annual
23 vital statistics report.

24 (8) Reports filed pursuant to this section must be deemed public records and must be available to
25 the public in accordance with the confidentiality and public records reporting laws of this state. Original copies
26 of all reports filed under this section must be available to the state board of medical examiners, state board of

15 the requirements of the federal REAL ID Act of 2005, Public Law 109-13, to each qualifying applicant.

16 (2) (a) When required to obtain a Montana driver's license or identification card, a person may
17 choose to apply for either a standard driver's license or identification card, or for a REAL ID-compliant driver's
18 license or REAL ID-compliant identification card.

19 (b) A person may not hold a valid standard driver's license or identification card and a valid REAL
20 ID-compliant driver's license or identification card at the same time.

21 (3) (a) A REAL ID-compliant driver's license issued pursuant to this section is subject to the other
22 requirements of obtaining, renewing, and using a standard driver's license issued pursuant to this chapter.

23 (b) A REAL ID-compliant identification card issued pursuant to this section is subject to the other
24 requirements of obtaining, renewing, and using a standard identification card issued pursuant to Title 61,
25 chapter 12, part 5, and this chapter.

26 (4) (a) In addition to the fees charged to apply for or renew a standard driver's license under 61-5-
27 111(6) and the fees charged to apply for a standard identification card under 61-12-504, the department may
28 charge the following additional fees:

1 (i)—for a person who is applying for a REAL ID-compliant driver's license or identification card during or
2 prior to a renewal period specified in 61-5-111(3)(c), the additional fee is \$25; and

3 (ii) ~~for a person who renews a standard driver's license or a standard identification card under 61-5-~~
4 ~~111 (3)(c) between June 1, 2017, through December 31, 2017, and is applying for a REAL ID-compliant driver's~~
5 ~~license or identification card between January 1, 2018, and June 30, 2018, the additional fee is \$25.~~

6 (b) The fees collected under this subsection (4) must be deposited in the state special revenue
7 fund to be used to fund the equipment and staffing necessary to provide REAL ID-compliant driver's licenses
8 and identification cards. (Void on occurrence of contingency--sec. 8, Ch. 443, L. 2017.)"

10 **Section 15.** Section 61-5-208, MCA, is amended to read:

11 **"61-5-208. Period of suspension or revocation -- limitation on issuance of probationary license**
12 **-- notation on driver's license.** (1) The department may not suspend or revoke a driver's license or privilege to
13 drive a motor vehicle on the public highways, except as permitted by law.

14 (2) (a) Except as provided in 44-4-1205 and 61-2-302 and except as otherwise provided in this
15 section, a person whose license or privilege to drive a motor vehicle on the public highways has been
16 suspended or revoked may not have the license, endorsement, or privilege renewed or restored until the
17 revocation or suspension period has been completed.

18 (b) Subject to 61-5-231 and except as provided in subsection (4) of this section:

19 (i) upon receiving a report of a person's conviction or forfeiture of bail or collateral not vacated for
20 a first offense of violating 61-8-1002, the department shall suspend the driver's license or driving privilege of the
21 person for a period of 6 months;

22 (ii) upon receiving a report of a person's conviction or forfeiture of bail or collateral not vacated for
23 a second offense of violating 61-8-1002 within the time period specified in ~~61-8-1002~~ 61-8-1011, the
24 department shall suspend the driver's license or driving privilege of the person for a period of 1 year and may
25 not issue a probationary license during the period of suspension unless the person completes at least 45 days
26 of the 1-year suspension and the report of conviction includes a recommendation from the court that a
27 probationary driver's license be issued subject to the requirements of 61-8-1010. If the 1-year suspension
28 period passes and the person has not completed chemical dependency treatment, as required under ~~61-8-1002~~

1 61-8-1009, the license suspension remains in effect until treatment is completed.

2 (iii) upon receiving a report of a person's conviction or forfeiture of bail or collateral not vacated for
3 a third or subsequent offense of violating 61-8-1002 within the time period specified in ~~61-8-1002~~ 61-8-1011,
4 the department shall suspend the driver's license or driving privilege of the person for a period of 1 year and
5 may not issue a probationary license during the period of suspension unless the person completes at least 90
6 days of the 1-year suspension and the report of conviction includes a recommendation from the court that a
7 probationary driver's license be issued subject to the requirements of 61-8-1010. If the 1-year suspension
8 period passes and the person has not completed chemical dependency treatment, as required under 61-8-
9 1002, the license suspension remains in effect until treatment is completed.

10 (3) (a) Except as provided in subsection (3)(b), the period of suspension or revocation for a person
11 convicted of any offense that makes mandatory the suspension or revocation of the person's driver's license
12 commences from the date of conviction or forfeiture of bail.

13 (b) A suspension commences from the last day of the prior suspension or revocation period if the
14 suspension is for a conviction of driving with a suspended or revoked license.

15 (4) If a person is convicted of a violation of 61-8-1002 while operating a commercial motor vehicle,
16 the department shall suspend the person's driver's license as provided in 61-8-802.

17 (5) (a) A driver's license that is issued after a license revocation to a person described in
18 subsection (5)(b) must be clearly marked with a notation that conveys the term of the person's probation
19 restrictions.

20 (b) The provisions of subsection (5)(a) apply to a license issued to a person for whom a court has
21 reported a felony conviction under 61-8-1008, the judgment for which has as a condition of probation that the
22 person may not operate a motor vehicle unless:

23 (i) operation is authorized by the person's probation officer; or

24 (ii) a motor vehicle operated by the person is equipped with an ignition interlock device."

26 **Section 16.** Section 69-3-904, MCA, is amended to read:

27 **"69-3-904. Commission review and determination of rate increases or decreases.** (1) When a
28 small telecommunications provider proposes a rate increase or decrease, the commission shall review and

1 determine the rates pursuant to the applicable procedures in this chapter if:

2 (a) the affected subscribers have successfully petitioned for commission review as described in
3 69-3-906;

4 (b) the small telecommunications provider requests the commission to review and determine the
5 rates; or

6 (c) by the 60th day following notice of the proposed increase or decrease, the consumer counsel
7 petitions the commission to review and determine the rates.

8 (2) An order of the commission issued under this section establishes the effective rate for the
9 regulated telecommunications services covered by the order. Rates established by commission order may not
10 be increased for a period of 6 months, except as ordered by the commission.

11 (3) The order of the commission is subject to review pursuant to part 4 of this chapter."

13 **Section 17.** Section 87-2-124, MCA, is amended to read:

14 **"87-2-124. Option to direct limited drawing refunds to block management program.** A person
15 who participates in a limited drawing but is not successful in the drawing may opt, upon application, to direct
16 that the refund the person is eligible to receive instead be deposited in the hunting access account established
17 in 87-1-290 and used for the purpose of funding the block management program established by administrative
18 rule pursuant to authority contained in ~~87-1-301 and 87-1-303~~ in 87-1-265."

20 **Section 18.** Section 87-6-415, MCA, is amended to read:

21 **"87-6-415. Failure to obtain landowner's permission for hunting.** (1) A person may not hunt or
22 attempt to hunt furbearers, game animals, migratory game birds, nongame wildlife, predatory animals, upland
23 game birds, or wolves on private property without first obtaining permission of the landowner, the lessee, or
24 their agents.

25 (2) A person who violates this section shall, upon conviction for a first offense, be fined not less
26 than \$135 or more than \$500.

27 (3) A person convicted of a second or subsequent offense of hunting on private property without
28 obtaining permission of the landowner within 5 years shall be fined not less than \$500 or more than \$1,000.

1 (4) In addition, the person, upon conviction under subsection (3) or forfeiture of bond or bail:
2 (a) shall forfeit any current hunting, fishing, or trapping license issued by this state and the
3 privilege to hunt, fish, or trap in this state or to use state lands, as defined in 77-1-101, for recreational purposes
4 for not less than 12 months or more than 3 years from the date of conviction or forfeiture [~~of bond or bail~~] of
5 bond or bail; and

6 (b) may be ordered to make restitution for property damage resulting from the violation in an
7 amount and manner to be set by the court. The court shall determine the manner and amount of restitution after
8 full consideration of the convicted person's ability to pay the restitution. Upon good cause shown by the
9 convicted person, the court may modify any previous order specifying the amount and manner of restitution.

10 Full payment of the amount of restitution ordered must be made prior to the release of state jurisdiction over the
11 person convicted.

12 (5) For the purposes of this section, the term "hunt" has the same meaning as provided in 87-6-
13 101 and includes entering private land to:

- 14 (a) retrieve wildlife; or
- 15 (b) access public land to hunt."

17 NEW SECTION. **Section 19. Directions to code commissioner.** (1) Wherever a reference to 5-11-
18 210 appears in legislation enacted by the 2023 legislature and requires a new report to the legislature, the code
19 commissioner is directed to include the report under the appropriate interim committee as listed in 5-11-222.

20 (2) Wherever a reference to 5-11-210 is repealed or stricken in legislation enacted by the 2023
21 legislature, the code commissioner is directed to strike that report from 5-11-222.
