Mr. Chair, Members of the Committee

My name is Ruth Rater R-A-T-E-R. I am a fully recovered Californian and grateful Montanan, residing in North Helena . A bit of Clarification – I moved to Montana so it would change me, not that I would change her.

I am an accountant, auditor, and procedure writer by profession. I fit the narrative that was spoken of by a previous person's testimony (Becky Stockton)

In February 2022 I signed up for and attended the bi-annual election judge training at my local elections office so that I could become an election judge and participate in the election process in my county. Training was completed and I was informed that I was eligible for participation in the 2022 Primary Election.

For the 2022 Primaries, I was notified that I was selected as a Chief judge for a precinct. I received correspondence that requested I reach out to the other members assigned to my precinct and ensure all were available for the sessions that they had signed up for at the training. I received a call from the other Chief Judge that was covering 2 precincts at that election site. He took the time to explain how everything worked, and what to expect. I showed up the day prior at the elections office to be issued the Chief Judge trolley that contained all that had been discussed at a Chief Judge training, which would be all of the ballots, security tags, instructions, registered voter logs for the assigned precinct. I showed up at 6am and we worked the polls as citizens came in and out throughout the day. We prepared the close out paperwork, which was very confusing and had many issues cross-referencing among the 3 sheets of paper we were working off of. Things like "for this tub write the blue security tag number" while on the second sheet it would reference red security tag for the same tub. I wish I had taken a picture. For a sequentially oriented-person such as myself it was very confusing and time consuming. We completed our close out and headed to the elections office to drop off the cast ballots at 11:00pm (3 hours after close of the polls) for the record, I had 100 electors come in, gratefully show their ID's and cast their vote. There was a form asking if anything could be improved on, to which I referenced the close out issues I found over the 3 sheets.

Other than a few hiccups, it was a very good experience and I felt personal pride in doing my very best to ensure all procedures were done properly and in a non-partisan fashion. My co-Chief Judge complemented me on doing very well. This was not only my first time as an election judge, but as a Chief judge as well.

Fast forward to October 2022 just prior to the General Election. I had been asking other prior judges who are known to me, whether anyone had seen the election judge assignments. I received by mail the week before the election via USPS the listing. I was shocked to find that I did not have either Chief Election Judge, or election judge, but was listed as an alternate. While looking over the entire listing, I noted that there were 4 Chief Judges that were covering 2 precincts and 1 Chief judge that was covering 3 precincts – the one with 3 happened to be the polling location that I worked at for Primaries and is also the polling location for my precinct. I reached out to our Elections Supervisor via email beginning 10/28/2022 asking what had (A) occurred to leave me off of active election judge positions. I sent 3 more requests on the same thread marked 2nd, 3rd, & 4th request to which I have never received a response.

As I was observing the ballot opening, batching, counting, and tabulation process on election day at our elections office, I went to my polling place to cast my vote. When the Chief Election Judge saw me, he came to speak to me asking "How can you be done already – polls are open until 8pm" I responded by stating that I had been removed from judgeship and marked "alternate" on the Judge Assignments. There were 2 forms – one in precinct order and one by (D) last name. Only on the forms by last name did I show as an alternate. He had assumed I had been assigned elsewhere. He said if he had know he would have requested me work as a judge at the polling place as it had been a very hectic day. This can compromise the election process and create an incredibly stressful event for a volunteer choosing to do their civic duty.

Why was I not assigned to be a judge when we had 6 precincts that did not have Chief Judges? I was never told personally. I was, however, told by another trusted chief judge that had heard directly from the Election Supervisor that they did not like a post I had made on facebook. Last (C) I checked, that is covered under my 1st Amendment Right. Just as I am able to be impartial at a jury trial, inspite of my personal beliefs, I am capable of being non-partisan during an election day. With this experience, I consider myself to have been disenfranchised of my right to being an Election Judge.

Please give bill SB385 a due pass to stop this from happening to others in the future.

I have a written testimony which includes all documentation which I have referred to here today. If I may submit?

Dear Mr. Fitzpatrick and Ms. Reeves, and Others this May Concern:

I am a resident of Montana and a registered voter. I am investigating disputes regarding elections, and I am specifically investigating a dispute regarding elections, election materials, and document retention, and systems, especially, but not perhaps entirely, as it relates to the 2020 election conducted in Montana and in your county. I am investigating these matters to determine whether to file a lawsuit. I may take other action. I understand that you may be allowed by statute to forever destroy these perhaps as soon as September 3, 2022. You are not required to destroy records on the earliest possible date. I am requesting you to retain the documents as herein described and take immediate action to secure all such records, including any and all electronic records, hard documents, and notes. I understand that citizens have requested similar records and you may have refused or been noncommittal. I will be commencing an action concerning this dispute, and, in that event, it is very likely that you are named as a defendant, at least in your official capacity with the government. I will represent myself pro se but reserve the right to hire an attorney. It seems unlikely that we will resolve this dispute and anticipate that litigation will commence shortly. As previously eluded to, the purpose of this letter is to notify you of your obligation to take reasonable steps to preserve and retain all hard copies and electronically stored information ("ESI"), as defined by Rule 34 of the Federal Rules of Civil Procedure and Montana Rules of Civil Procedure, relevant to this Action or because you are constitutionally or statutorily obligated to do so either by state or federal law.

To fulfill your preservation obligation, you must take reasonable steps to preserve all hard copy documents and ESI, including election related materials such as CVR and other materials in your possession or under your control that are relevant to this Action, including, but not limited to:

- a. suspending your data destruction and backup tape recycling policies;
- b. preserving relevant software, including legacy software (unless an exact copy or mirror image is made and stored) and hardware that is no longer in service but was in service during the relevant time period (2020 and 2021 election cycles and 2022 election cycle);
- c. retaining and preserving necessary information to access, review, and reconstruct (if necessary) relevant ESI, including identification codes and passwords, decryption applications, decompression software, reconstruction software, network access codes, manuals, and user instructions;
- d. retaining and preserving all ESI on county cell phones or other handheld devices, including on phones and devices where any county business is contained or ever conducted or ever used on county time, including personal cell phones or devices if used in any of the aforementioned ways or during work;
- e. retaining and preserving all metadata such as Facebook, Twitter, Linked or any other such platform on devices owned, maintained or controlled by the county, or reimbursed or paid for by the county, and personal devices owned by you or other county employees if the devices were ever used to conduct any county related business;
- f. retaining and preserving all relevant backup tapes or other storage media; and
- g. any other reasonable steps necessary to prevent the destruction, loss, override, or modification of relevant data, either intentionally or inadvertently, such as through modification of your document retention policy and systems.

All ESI must be preserved intact and without modification.

This above list is not exhaustive, and you must preserve all information that is potentially relevant to this Action currently in your possession or which you may subsequently discover or come to receive.

I believe that, among other information, the following information is relevant to the case and must be preserved:

2020, 2021 and 2022 election related material

The foregoing list is not exhaustive, and you must preserve all information relevant to this Action.

In addition, I believe that at least the following individuals possess, authored, or received relevant documents:

See the above list, as well as County Commissioners serving during the described election cycles.

The foregoing list is not exhaustive, and you must preserve all information relevant to this Action.

In addition, you must take reasonable steps to preserve all hard copy documents and ESI relevant to this Action that are not in your possession or custody but are in your control. For example, documents may be in the possession or custody of your office or within other government agencies, including non-party agencies and agents of the State:

As with documents in your possession or custody, all ESI in a non-party's possession or custody must be preserved intact and without modification.

Potentially relevant ESI may include:

a. active, archived, and deleted copies of ESI, such as emails, voicemails, text messages, instant messages (IMs), calendars, diaries, word processing files, spreadsheets, PDFs, JPEGs, PowerPoint presentations, posts other unknown document types, database files, temporary internet files, cookies, and .ZIP files, among others; and

b. the ESI's metadata, including the date it was created, the date it was last modified, and the name of the individual who created it and other metadata if potentially relevant whether stored online, offline, in a cloud-based server or in other electronic storage, or on any computers, handheld devices, tablets, cell phones, or other devices over which you have possession, custody, or control. This includes personal computers, handheld devices, tablets, cell phones, or other devices used in any way for county business or on county time.

I believe that relevant documents and information may exist in or at other locations and all such materials should be secured whether in your office, in the county courthouse, another government facility or in acquired private storage areas.

The foregoing list is not exhaustive, and you must preserve all information relevant to this Action.

Your failure to preserve relevant data may constitute spoliation of evidence, which may subject you to sanctions. I trust that you will preserve for the duration of this Action all relevant hard copy documents and ESI. In the event of a dispute arising out of your failure to preserve documents, I will rely on this letter in court as evidence of our request and notice of your preservation obligations.

I would like to meet with you to discuss discovery issues in this Action and hope to reach an agreement on a discovery plan covering, among other things, what information you must preserve. Please contact me at your earliest convenience by phone or email (see below). Meanwhile if you are confused as to the inclusion or scope of the records being requested you should merely preserve any and all such records. If you have defenses regarding the release of any such information requested and herein contained, you should make those arguments in a court of law rather than unilaterally make the decision to not produce or to destroy any information or material herein requested.

Per item number two, the Ballot Manifest Report or the Tabulator Batch Report, this report is sealed with the 2020 General Election material and would require a court order to unseal.
