Discussion on Policy on Harassment

- 02:01:38 Ms. Fox said that the subcommittee concluded that the Harassment Policy needed to come before the Legislative Council.
- 02:03:23 Sen. Thomas discussed the Wyoming's harassment policy. He said the Joint Rules should be amended so that it does reference the new policy.
- 02:04:56 Ms. Fox discussed the documents from NCSL on harassment, the draft Harassment Policy, and the House Staff Manual from the Clerk of the House.
- 02:06:48 Sen. Buttrey said that he had received the documents from NCSL and recommended a comprehensive review of them. He also recommended referencing the document as an appendix to the rules so that the Council could control any changes or updates to the document as needed.
- 02:08:11 Rep. Eck asked where in the Joint Rules is the reference to the sexual harassment policy.
- 02:08:25 Mr. Everts said it is 10-85 of the Joint Rules.
- 02:08:57 Rep. Eck said that changes will need to be made because there will be some conflict between what has been drafted and what is in the Joint Rules. She believes that having a statement regarding subsection (1) that it is not tolerated, and that a violation of the policy must reported, not necessarily putting in the whole process but just enough that there is clear direction.
- 02:09:42 Sen. Thomas asked Rep. Eck to make a motion to update 10-85 Joint Rules once the sexual harassment policy is adopted.

O2:10:07 Sen. Buttrey asked if Sen. Thomas is asking for a motion that would retain the first paragraph and some requirement to have to report it, and then add reference to whatever document we would come up for the harassment policy.

- O2:10:31 Rep. Eck moved to amend 10-85 of the Joint Rules to maintain the language in subsection (1) and to add language to reflect the updated harassment policy that will be adopted by the Legislative Council. The motion passed with Rep. Morigeau voting aye by proxy.

Discussion on 10-130. Bills -- sponsorship -- style -- format

- 02:12:27 Sen. Thomas referenced 10-130, and discussed what the Senate and the House does for co-sponsorship of a bill. He suggested putting something in the rules that says if a co-sponsor's signature can't be read and confirmed, then that co-sponsor will be left off the bill.
- 02:14:08 Rep. Eck commented on the importance of putting on the website who is cosponsoring a bill.
- Ms. Fox said that the signatures are sent to the Journal Clerk staff who makes any changes or corrections in the database so that it can be proofed and confirmed by the bills processing staff.

40-160. Enrolling

O2:34:48 Sen. Buttrey wanted to discuss Amendment 1 to 40-160 regarding enrolled bills and requiring them to go in a timely fashion to the governor and to the secretary of state for signatures. He asked if the subcommittee wanted to revisit that.

02:38:17 Mr. Everts discussed the flexibility of bills that are progressing through the session.

- O2:38:30 Sen. Buttrey said one of the reasons he was trying to make a change is that on line 1, page 32, it says a bill that has passed both house of the Legislature...and then it says "may". In reality because the word "may" is there, it doesn't have to do any of those things.
- O2:40:42 Sen. Buttrey discussed the five working days after the 90th Legislature day and that he is happy with that as long as that is a hard requirement. A bill has to be enrolled, clerically corrected, and delivered to the governor and secretary of state for signatures, but he isn't sure how to make them sign a bill.
- 02:40:55 Mr. Everts said that the journal provisions in terms of the signature of the presiding officers come into play as well.
- 02:40:57 Ms. Fox said that there is no way to enforce this rule if the Legislature is no longer in session.
- O2:41:05 Sen. Buttrey said he would be happy with the 5 working days after the Legislature sine die, and suggested making it "must" instead of "may" and putting in "by the 90th day, the bills must be a) enrolled; b) be clerically corrected; c) signed by the presiding officers; and d) be delivered to the governor or the secretary of the state by whatever day or by sine die, whether the bill is signed or not.

Mr. Everts said that the signature is something he needs to look into legally in terms of authentication by the presiding officers and also in conjunction with the journal requirements.

Sen. Buttrey asked for the ability to bring up this amendment up at the October meeting which would give Mr. Everts time to research.

Sen. Thomas thinks that is a good idea.
