Strategic Planning Retreat Barristers Bed and Breakfast August 13, 2015 Notes

The Legislative Council reconvened at 1:15 p.m.. At the strategic planning session, the members and staff broke into four groups:

Group 1 Legislators: Hunter, Bennett, Barrett, Driscoll, Hess

The first topic was to discuss each person's motivation and interests for either running for or working for the Legislature. Dale Gow

- enjoy working for you and made the choice to do so
- 75% of your staffers are introverts and we are not standoffish, understand your needs will help us, we are state employees and take your comments to heart

Joe Kolman

- we have respect for you as legislators and as candidates because we as staff are not going to do that
- once you are elected you will get hundreds of emails and phone calls. We understand the amount of work you do each day
- advocate for the institution is important. Let us be your eyes and ears, we try to keep you informed.
- we have 150 bosses and we need clear and defined directions. We provide the information, you as legislators are the deciders.

Sen. Driscoll asked if people who draft bills feel ownership. Joe Kolman said ownership is that we follow our bills whether they live or die. There is interest in how it changes. Todd Everts said that it is assumed that the bills that we draft will pass. That is our interest. That is the type of ownership that we have. Dave Bohyer said that when staff has a complicated bill, there is an

amount of pride in getting it done and done well. Susan Fox said that bills are like puzzles and when you have a challenging one, it is exciting to come up with a solution.

Sen. Barrett commented that in orientation legislators get too much information. After transmittal would be a good time for some training in money vs policy to say, here is the money spent and here are the policies so that everyone is on same page. Rep. Sesso said the idea of meeting right after transmittal is a good idea where we can do a sharing with sponsors of bills to talk about the status of the bills.

The Council members and staff divided up into three groups that were a combination of legislators and staff. The direction for the discussion was to think about how to provide ongoing leadership direction and foresight for:

- efficient operation & improvement of the Legislature
- establish personnel and pay policies
- educate the public
- foster public participation
- preserve the integrity of Legislative Branch as equal

Group 1: Rep. Hunter, Sen. Buttrey, Sen. Taylor, Sen. Driscoll, Susan Fox, Dave Bohyer, and Jen Simmons

- get rid of term limits
- training after transmittal
- committee chairs coordinate between senate and house during transmittal
- reach out to chambers, staff director, TVMT, finance comm
- set budget rules earlier because it helps
- council members appointed early and meet during session
- question for Council during session re budget, security, legal notes, caucus staff between session
- have presence between session
- consent calendar for interim comm bill
- staff can hand out list ahead of time
- more defined minority role
- make their committee appointments
- a video on how to run for office, some people don't get TVMT so do YouTube, school connections
- ethic classes
- veto overrides
- joint press conference especially for interim bill and consent agenda bills
- preserving integrity of branch, find way for legislator to rule over department admin rules as to the legislative intent

- post transmittal joint committee meetings linking policy committee of House and Senate and potentially budget committees
- spread out training post transmittal
- replacing computer stipends where each legislator is issued state standardized computer that is staff supported, with option to go paperless
- increasing legislative pay and improving agency oversight
- have a discussion on being realistic b/c new leadership on ideas and equal branch
- taking a look at majority and minority staffing for the interim

Blank note cards were distributed and the instructions were: list the top three topics based on importance and urgency and identify quick wins. A straw poll was taken and everyone shared the top two.

Sen. Facey: training after transmittal to expand what we have now and talk about budget; need to have minority and majority staff during the interim; Quick win: more support and resources for TVMT.

Dale Gow: legislative approval for DOA; Quick win: standardized computer system, improvement of TVMT and education.

Amy Carlson: spread out orientation, be on same platform with computers

Sen. Driscoll: communicate more effectively, more participation

Rep. Sesso: more constituent needs for everyone, have chance once a week to speak to constituents at home; post transmittal training, joint committee meetings

Susan Fox: TVMT, training or second chamber training; quick win is revenue and appropriation deadlines and council training on budget

Sen. Barrett: extra training after transmittal, need more agency oversight that leads to gaining equal branch status with the agencies, veto overrides are not being taken seriously, have a discussion on whether LC is getting its money's worth for TVMT

Gordy Higgins: discussion on TVMT regarding equipment; discuss in terms of what we can do in centralized services in budget: marketing, salaries, staffing issues and the nature of providing information to Council involving pay plan

Todd Everts: like the idea of standardized computers, legislator stipends, Session Systems Replacement; increase in legislator pay.

Rep. Hunter: TVMT, use of social media in terms of education, full disclosure of contract; improve agency oversight; Quick win: joint meeting, ethics training

Sen. Taylor: oversight of approval of Administrative Rules; committee chair; Quick win: post transmittal joint meetings and coordination between budget committee

Sen. Buttrey: equalize legislative branch power, oversight of administrative rules, veto overrides that we are giving up. Quick win: use of YouTube because he lives in an area where there is no TV, likes standardized computers

Dave Bohyer: revising calendar for orientation; extend reach of TVMT. Quick win: increase legislative branch budget and pay, liked post transmittal training

Sen. Bennett: TVMT, more programming; have session and interim meetings outside of Helena; having legal notes in committee folders; Quick win: YouTube

Rep. MacDonald: support joint committee meetings after transmittal, need to look at pay and hand it over to someone with credibility to set up formula and carry it forward (blue ribbon commission to look at term limits and the calendar); Quick win: support LC to get training in how to relate to budget, support pay plan

Staff compiled the top topics and quick wins into lists for discussion (see attached).

ROUNDTABLE DISCUSSION OF QUICK WINS

• Legislative Council training on budget and pay plan can be placed on the next agenda. Rep. MacDonald said response to a comment heard from staff, that even in LSD's pay plan and broadband is about the Council's authority in Legislature, they manage budget. LC should be brought up to speed each interim on what the LC role is.

Susan Fox talked about covering Programs 20 and 21, pay plan rules that 3 directors adopted. Council discusses budget at each meeting. In November, the Council can review existing budget, start building next biennium budget in February, and adopt budget in August for inclusion in the Governor's budget and HB 2.

• State issued computers in lieu of stipend Sen. Buttrey knows the challenges, saw IT struggling. You will run into some resistance if do all PCs, Apple users will be upset. The idea is as legislators, make it as efficient and cost-effective as possible.

Sen. Taylor talked about going paperless.

Sen. Buttrey said if state owns computer, what can you have on computer?

Todd Everts said need to look at it on a legal standpoint, what is duration for using that piece of equipment.

Susan Fox said interest from legal standpoint, use of equipment. This is an agenda item.

Rep. Bennett is resistant to this. Likes the idea that you get a little bit money to find something he likes, one size fits all is not good for him.

Sen. Facey thinks it is okay to say if your machine doesn't have software, you are responsible for getting it. If you go with Rep. Bennett's idea, put some parameters on it.

Dale Gow needs an understanding on what they can support.

Rep. MacDonald on going paperless and having a tablet to do committee work, still have IT account for additional work.

Sen. Taylor likes having a tablet on each legislator's desk, bills (paperless), and if you want more, bring in your own device.

Amy Carlson asked what advantage to legislator for being on same network as rest of employees.

Dale Gow said you are on guest network with unrestricted access to network. Giving one size fits all, don't really use 100% of the services; i.e., email.

Rep. Hunter would like Dale to come and present his ideas at a future meeting.

• Expand/extend training after transmittal Rep. Hunter spoke on training in orientation or during session.

Susan Fox said training has potential to split into smaller groups

• Educational videos on TVMT and YouTube Susan Fox said TVMT has multiple levels and is an agenda item. Production-distribution-multiple contracts-streaming (Granicus), how can we use it better is a good topic, if legislators can give us what you want to do.

Sen. Buttrey said look at it as a way to educate legislators on the process and use that as a training tool.

Sen. Barrett said that lobbyists pay for it and got into TVMT. We have a hot commodity and should reassess the contract. There is a way to get others to pay for it.

- Training throughout session, post transmittal training
- Legal notes in folders

Sen. Barrett said that is something LC needs to address

Todd Everts said that could be agenda item

- -- what Executive can and can't do versus role in finance committee

Joint press conference on interim bills

- -- goes with consent agenda, is this something of interest because it takes work to make it happen-after interim committee meeting, if something comes up, staff could write a summary for press that this is a concern of committee
- -- would have to be a majority yes vote, can't say have consensus unless everyone on committee voted
- -- as an element of honoring work that interim comm did. Consensus bill coming out of committee.
- -- at the end of interim, have a package of bills, don't always get coverage, could have press release regarding work of interim committee. Each comm does own press release.
- -- goes with TVMT, what are ways we can get information out.
- -- put on back burner
- -- in other states, legislative website is partisan. Can move positively in press releases on what

legislators are doing.

- -- do we want parties to have opportunity to show working together, working in good relationship. Is that a value to have concrete method to do that?
- -- take on form like Legislative Buzz--staff needs to work on getting news out

Partisan staff during interim:

-- roles, benefit considerations, implementation

Veto overrides

- -- if viable as branch of government, discussion needs to be had
- -- legislature is about relationships and if parties are working together. We are in this together issue and we can override veto.
- -- thinks it is politics
- -- if parties are polarized, will continue to happen. If bodies work together on big issues.
- -- change laws on voting, not voting on veto override
- -- partisan vs relationships. Product of term limits.
- -- two choices; continue to see our power or move down path and make fundamental changes and find way to get power back.
- -- can this be addressed with calendar?
- -- will have that discussion later on, propose calendar to new leadership

DISCUSSION ON TOP THREE TOPICS

The group narrowed the discussion to the top three topics and divided into three groups:

- 1. Expand/extend legislator training opportunities Hess, MacDonald, Facey, Taylor
- 2. TVMT Bennett, Driscoll, Simmons, Gow, DaSilva, Higgins, Fox
- 3. Legislative Oversight Buttrey, Everts, Barrett, Kolman, Hunter

<u>Expand/extend Legislator Training</u>: Use time after transmittal to focus on understanding the budget. Members of committees meet and presenters go into the room to explain the budget process. Schedule 3 hrs in morning to drill down into the different subjects and different committees. Talk about structuring Saturday training and start with bills; first week, order of business in AM: ethics classes; didn't talk about rules.

- -- didn't have anything for post transmittal. Training on what happens if your bill passed
- -- help prepare freshman going into different house.

TVMT/Broadcast Options:

- -- utilizing better than we are doing now. Blank spaces especially during interim. For amount of money should be using more
- -- ideas: 5-minute clips from legislators, more programming, FAQs segment of messages received on what's going on with Legislature and where to find that information; giving caucus time to do information forum, term limits, Back to School, historic perspectives on the Capitol

building,

- -- access (getting word out), financing options, video on navigating the Legislative Branch website.
- -- does the legislature charge anyone or entity for any of this. Not at this time, funding from lobbyist's fees. Charge other agencies a fee who use that service.
- -- Rep. Hunter said kind of service we get from cable companies. We could have some rule for providers to make sure we get service.

Legislative Oversight: What does it encompass?

- -- making presentation to LC on existing authority: Administrative Rule Authority, general agency oversight authority, and budget authority in terms of agency oversight. That will be beginning step in process and when you understand authority you can see what kinds of things you may want down the road. Agency oversight is kind of like a partnership.
- -- Linking policy and budget oversight together and making it more cohesive. Matrix chart on interim committee authority. Resurrect ability of authority of agencies.
- -- Division of administrative agency oversight, what should it be and how it can help them.
- -- Executive planning process (EPP) goes with agency oversight process in terms of budget. Have interim comm staff write updates on agency oversight and post that in addition to articles. Potentially look at interim committees need more authority, have communication between LC and interim committees on how they are addressing agency oversight, look at duties and rights.

Next Steps:

TVMT, Legislative Oversight first in November

Training and draft work plan in February

Get policy staff together and get proposals

Committee members like to have drafts or information out as soon as information is ready, but no later than two weeks before next meeting.
