# BRIEFING FROM THE CSG JUSTICE CENTER - Carl Reynolds, Senior Legal and Policy Advisor, Council of State Governments, Justice Center

00:03:47 Mr. Reynolds gave a presentation on the Justice Reinvestment Act. A copy of SB 224, which created the Commission on Sentencing, was provided to the committee. (Exhibit 1)

#### CHAMBER ACCESS POLICY

00:46:03 Ms. Fox discussed the Memorandum of Agreement between the Historical Society and the Legislative Branch. (Exhibit 4)

#### Committee discussion

- Rep. Essmann stated his preference to retain the language contained in the original draft Memorandum of Understanding and said he would like to change the language that no one gets on the rostrum without the explicit permission of either the President of the Senate and Speaker of the House.
- 00:51:28 Ms. Fox explained that the Memorandum of Understanding is to help the Historical Society when they conduct tours on the weekends and to preclude unauthorized activities in the chambers after hours.
- 00:52:04 Rep. MacDonald said that in reference to Rep. Essmann's comments, there is a definite need to protect that space when in session, but the people of Montana like having access to their capitol and she would like to preserve that.
- 00:52:47 Rep. Hunter discussed the practicality of having the Speaker or the President personally involved in all of the decisions.
- 00:54:44 Rep. Knudsen said that he is unclear as to when we would need to have authorization from either the Speaker of the House or the President of the Senate. He asked if the committee is talking about just coming on the floor or going up on the rostrum?

- 00:55:15 Ms. Fox said that the discussion is, should the approval for access to the chambers be granted by the Sergeant at Arms, by the Legislative Services Division's Facilities Coordinator, or by the Speaker and the President?
- 00:55:43 Rep. Knudsen said that he is comfortable having that level of access to the upper rostrum be approved by the Speaker and the President.

Hunter discussed the last sentence "If a tour group is accompanied, the members of the tour may sit in legislator chairs" which is speaking directly to the point that Marilyn Miller made, and that approval will be made by the presiding officers of the chambers rather than the Sergeant at Arms or the Facilities Coordinator.
