## **OPTIONS FOR 2017 SESSION CALENDAR**

There are five calendars for your consideration. Calendar 1 is based off of the initial 2015 Session calendar. The other four options are a combination of the first 2 or 3 Saturdays off, and a 4- or 5-day transmittal. Please concentrate on calendars 1 through 3, as calendars 4 and 5 present some issues from the appropriations perspective. The Saturday educational sessions on Calendar 1 have been moved to Fridays in the other calendars in the case where the Saturday is not a session day. The educational sessions can easily be moved no matter which calendar is chosen.

Calendar 4: Option B (first 2 Saturdays off,- 5-day transmittal)

- 5-day transmittal break (February 25 through March 1)
- Day 67 -- transmittal of appropriation and revenue bills (3rd reading only, can be done early) -- Monday, March 27
- Day 73 -- transmittal of amendments to general bills, Monday, April 3
- Easter Break -- Friday, April 14 through Monday, April 17 (8 session days left)
- Last Saturday, April 22, Leg Day 87
- Day 90 -- Wednesday, April 26, 2017

This calendar is not preferred as it creates transmittal dates on Mondays. House Appropriations meets the next day after transmittal break, and allowing enough time for the final bill preparation pushes the HB 2 House floor action into conflict with a Friday, St. Patrick's Day, and the weekend. This further pushes Senate Finance and Claims and Senate floor action later, leaving less time for conference committee.
