02:05:32 Ms. Fox discussed the document, "The Difficulty of Setting Legislator Pay" (Exhibit 10) and "Reducing the Size of the Legislature" (Exhibit 11).

02:16:54	Sen. Sales commented on changing the legislature to comprise of 80 members in the House and 40 members in the Senate.
02:19:21	Rep Berglee said that the argument that you will get against it is that you will lose representation, especially in the rural areas.
02:22:56	Rep. Eck asked about statute or constitutional requirements regarding decreasing the number of seats, how that would affect the political breakdown of districts, and how that breakdown would be determined.
02:25:09	Sen. Sales asked about redistricting that was done in the past, if the districts were getting bigger or staying stagnant.
02:26:41	Sen. Sales discussed advantages for larger districts with a large population that would help with the selection of those districts and have less gerrymandering occurring.

02:31:48	Ms. Fox said that calculations regarding health insurance were not done. She said it was hard to have much economy of scale, and with term limits there needs to be some institutional memory to operate and that would take more analysis.
02:32:34	Sen. Facey said that he would like to consider the questions of size and compensation separately. He said that if we look at compensation, we came across a big roadblock last session and the roadblock was the veto.
02:35:45	Sen. Pomnichowski commented on the redistricting and apportionment commission being the only body with the power to set the size of the legislature. She would like more information before questions are asked to which there are already answers.
02:37:41	Sen. Thomas discussed moving forward on reducing the size of the legislature. His opinion is that it is actually in the constitution to delegate straight to the legislature with that decision.
02:41:03	Mr. Everts presented background information on Greg Petesch's memo and Mr. Everts' legal review that was on Sen. Priest's bill in 2015, and the attorney general's interpretation of the constitution that determined that the legislature didn't have the ability to reduce the size of the district. He also discussed an attorney general opinion that interpreted the constitution to say that a senator's

	term of office can't be shortened. If you go forward with this, there may be a risk that someone, a sitting legislator, who may be impacted by this, who could use
02:43:12	those attorney general opinions to impede progress on what you are trying to do. Ms. Fox said that what she intended in that transition was to make sure that no senator's term would be shortened and that it would be good to delve into that more because most of those opinions were done in 1973.
02:44:01	Rep Knudsen asked if the committee wanted to move forward on reducing the size of the legislature, and if so, he would not be in support of this.
02:45:53	Sen. Sesso asked what action needs to be taken to give the legislature a chance to pass a law to accommodate a change.
