1. Introduction

The Environmental Quality Council (EQC) is a seventeen member bipartisan interim committee of the Montana Legislature. The EQC has agreed on a work plan for the 2001-2002 interim between legislative sessions and has appointed a seven person Energy Policy Subcommittee to address policy issues. This work plan sets forth the Subcommittee's strategy for fulfilling its responsibilities during the 2001-2002 interim.

The work plan includes the following sections:

Basic background information, goals, and tasks are outlined for the energy policy topic. The work plan includes a projected subcommittee timeline. The purpose of the workplan is to provide a basic framework that will assist the subcommittee and staff in conducting its work and producing tangible results given the time and resources available to the subcommittee. The work plan is a flexible document. The Subcommittee will refine goals and tasks as information is gathered and evaluated. Key decision making points are highlighted in the timeline and under each topic. The Subcommittee will make recommendations to the full EQC for any actions that it feels need to be taken such as proposed legislation, recommendations for agency action, and/or development of educational materials.

2. Work Plan Process Steps

The EQC and its subcommittees generally follow five common steps to ensure a

successful interim:

- 1. Subcommittee/EQC Training and Information Gathering
- 2. Information/Issue Analysis
- 3. Subcommittee Findings and Conclusions (if any)
- 4. Subcommittee Recommendations (if any)
- 5. Full EQC Adoption or Modification of any Subcommittee Recommendations

At the heart of any successful EQC interim activity is a constant and active solicitation by the EQC of public, regulated community, and agency comment and involvement.

3. Energy Policy Development

Background information

The Council may, as the need arises, maintain a continual process to develop the components of a comprehensive state energy policy. The Council is also required to review and evaluate the Montana Department of Environmental Quality (DEQ) research reports on renewable energy sources and development programs. The Council expended a significant amount of effort in the 1993-94 interim in developing a state-wide energy policy statement. The 1995 Legislature enacted the EQC's recommendations. During the 1995-96 interim the EQC assigned a broad-based working group of stakeholders to make recommendations on transportation energy policy and on alternative transportation fuels. Again, the 1997 Legislature adopted the EQC's recommendations. Since that time, there has been little activity in terms of energy policy development. The EQC monitored and received updates on electric industry restructuring during the 1997-98 and 1999-2000 interims. EQC staff also staffed the Transition Advisory Committee on Electric Industry Restructuring during the 1997-98 and 1999-2000 interims.

During the 2001 Legislative Session, energy issues took center stage. Policy issues involving high electricity costs, consumer protection, utility financial stability, environmental issues, and Montana's evolving landscape of electric industry restructuring converged. Fifty bills were introduced and hotly debated and scrutinized. The Legislature passed a package of bills that, in general, created tax incentives for energy production, exempted certain the energy facilities from the siting process, modified the MEPA review process, extended the transition dates for customer choice, created a state power authority, extended the universal system benefits program, defined the cost recovery process for the

default supplier, and set up a process for the default supplier to procure electricity.

These energy issues have created a groundswell of interest among legislators and the public across the State of Montana. In May of 2001, the EQC, under its energy policy statutory authority, assigned a 7 person subcommittee to evaluate energy policy issues. The Subcommittee met briefly for an organizational meeting. The members of the Subcommittee expressed a great interest in obtaining base line information on the energy situation in Montana. The Subcommittee directed staff to develop a draft work plan with potential draft goals and tasks. Those draft goals and tasks are set out below.

Subcommittee Goals

- ? Develop an understanding of energy law, demand, supply, litigation, transmission, conservation, and price within Montana and the Northwest Region.
- ? Develop an easy to understand handbook on Montana energy law.
- ? Develop a state of the state report on the energy picture (supply, demand, transmission, conservation, and price) in Montana for the 2003 Legislature.
- ? Determine if existing Montana energy policy statement is adequate.
- ? Develop an understanding of Montana rural electric cooperatives.

Energy Policy Subcommittee Tasks

- 1. Gather information on energy laws and policies in Montana.
 - a. Staff review of historical EQC involvement in energy policy development.
 - b. Staff memorandum on the statutory responsibilities of the EQC and the Transition Advisory Committee.
 - c. Staff presentation on the electric industry restructuring laws.
 - d. Staff summary of selected energy legislation enacted during the 2001 Legislative session.
 - e. Staff overview of the various players involved in energy policy development and implementation in Montana.
