SJR 35: Health Care Reform

Review of Study Activities and Proposals

Prepared for the Children, Families, Health, and Human Services Interim Committee June 2010

Background

The Children, Families, Health, and Human Services Interim Committee began the Senate Joint Resolution 35 study of health care in the summer of 2009 as Congress was wading into the debate about how best to reform the nation's health insurance and health care systems. At the time, many national observers were predicting quick action by Congress on legislation that was likely to require many changes at the state level. As a result, the Children and Families Committee adopted a study plan that focused the majority of the Committee's study time on:

- · monitoring health care changes at the federal level;
- reviewing health care reforms proposed by other groups; and
- evaluating Montana's primary care system and ways to strengthen it.

As the Committee continued its study into the fall of 2009, it became clear that quick congressional action was unlikely — a development that made it more difficult for both the Committee, state agencies, and Montana-based health care groups to predict what state action might be needed and to develop proposals for action at the state level.

SJR 35 Study Activities

The following table lists the study activities identified in SJR 35 and by Committee members when they approved the SJR 35 study plan in June 2009. It also contains a corresponding list of presentations and materials provided to the Committee for each study activity. Items in bold-faced type indicate a formal committee action related to a study activity.
