Summary of Medical Marijuana Work Group Session June 9, 2010

The Medical Marijuana Work Group formed at the direction of the Children, Families, Health, and Human Services Interim Committee focused on finalizing recommendations for the Committee during its third meeting. No additional meetings are scheduled at this time.

The following list contains recommendations by the work group. The ideas for the recommendations generally were raised and discussed either during work group meetings, by state agency representatives, or during the public comment period of the April 27th Committee meeting. The recommendations will be forwarded to the Committee for consideration at its June 28 meeting.

The table below groups the idea by the level of support it received: full support, majority support, split support, or minority support. The work group agreed to forward to the committee any idea that had any level of support. The recommendations will be discussed in more detail in a report to be presented to the Committee on June 28.

The Role of a Regulatory Board

Participants thought some of the ideas proposed by work group members or by other stakeholders may be more appropriately addressed by a regulatory board, if one is created. These ideas included:

- establishing specific educational and/or ethical requirements for caregivers to obtain licensure
- establishing limits on the amount of marijuana a patient may receive in a given time period
- determining the provisions for inspection of caregiver operations;
- establishing how caregiver-to-caregiver sales would be handled and monitored to ensure that the amount of marijuana involved did not exceed allowable per-patient limits;
