00:00:00 Sen. McGee called the meeting to order at 9:05 a.m. The secretary took the roll. (Attachment #3) The committee and staff introduced themselves.

<u>ADMINISTRATION MATTERS - Leanne Heisel, Lead Researcher, LSD</u> Leanne Heisel, Research Analyst, LSD, gave an overview of the committee's budget and guidelines.

# **ELG Budget Overview**

Ms. Heisel informed the committee that the budget is set at \$42,500 for this interim. This meeting is using last interim's budget because it fell on June 30, 2009, which is the last day of the state's fiscal year.

# **ELG** questions and comments

- 00:24:42 Rep. Lake asked if proxy votes need to be specific to each issue or will the committee allow a blanket form. Ms. Heisel informed the committee that the blanket form has been the standard procedure in past committees.
- O0:28:42 Rep. Lake asked about the committee requesting agency legislation if a specific committee member's name would be on agency legislation, and if a two-thirds vote is required. Ms. Heisel said it is a majority vote of the committee if it wants to request agency legislation. She noted that with legislation there isn't any opportunity for a minority report, but it can be incorporated in the committee's final report. When the committee's name is on the legislation it doesn't mean that each member endorses that piece of legislation, it is only to start the drafting and preintroduction process.
- 00:31:21 Rep. Arntzen asked about a formal report at the end of the interim, and wanted to know what legislative committees receive the report. Ms. Heisel said it depends on who wants to receive it, but the final report is available for both individuals and committees.
- O0:32:41 Sen. Hawks asked if there has been a change in the influence of the interim committee reports to the legislature. Ms. Heisel replied no.

00:34:06 Sen. McGee wanted to know what constitutes a subcommittee. Ms. Heisel explained that a subcommittee is a formal entity of a committee and should have the same rules as a committee, such as staff support, public notice, minutes, etc. Working groups are more informal, but require the same preparation and support as subcommittees.
