00:00:15 Rep. Grinde called the Education and Local Government Interim Committee to order at 9:30 a.m. The secretary called the roll. Attachment #3.

#### Motion

00:01:49 Rep. Lake made a motion to approve the ELG subcommittee minutes of Legislative Resolutions, dated June 9, 2010. The motion **passed**.

#### Review agenda

00:02:23 Ms. Kurtz reviewed the agenda. (Attachment #2) A handout was discussed regarding WUI boundaries for Montana by Bob Harrington, Department of Natural Resources and Conservation (DNRC). (Exhibit 1)

- 00:07:14 Ms. Kurtz distributed a handout that gives an update of key points regarding Wildland Urban Interface (WUI). **(Exhibit 2)**
- 00:17:48 Dave Cook discussed rulemaking for construction techniques that is on hold per request of the ELG committee. He gave an update of SB 51, its process and efforts of the department meeting with the stakeholders. He said the department

has moved forward with the MEPA process, but the final version has not been filed at the committee's request.

## **ELG comments and questions**

- 00:20:53 Rep. Lake talked about the department developing building codes to be placed in "best practices" instead of being in the department's codes.
- 00:26:32 Mr. Mead talked about the role that DNRC is taking regarding the WUI, and how they have worked with the local communities. He distributed handouts of maps showing updates of the WUI, and explained each one:
  - Community Wildfire Protection Plans. (Exhibit 3)
  - Wildland Urban Interface. (Exhibit 4)
  - Montana Wildland Urban Interface. (Exhibit 5)
- The committee and Mr. Mead discussed guidelines and best practices of the WUI map drafted by DNRC and solutions in response to fires. There was discussion about having trigger points when WUI rules change. Ms. Kurtz said the Montana Codes Annotated (MCA), state that counties update the WUI map every five years.

## **Public comment**

- O0:54:55 Susanna Pyron, Florence, said that state and federal lands take a more active part in mitigating fire proof land. She said fires that start on state and federal lands should be considered more important than private land.
- 00:57:50 Susie Fogg, Ravalli County, talked about County Commissioners greatest interest is taking away private property rights.
- 01:02:25 Niki Sardot, Ravalli County, distributed a handout about WUI with suggested language change. **(Exhibit 6)**
- 01:04:22 Ed Greef, Ravalli County, talked about best practices, local control, and protection of private property owners.
- 01:05:17 Richard Van Auken, Teton County Fire Chief, explained why the WUI was started. He said the WUI determines what is urban and what is rural, and it establishes mitigation for grants.
- 01:07:17 Harold Blattie, Executive Director, Montana Association of Counties (MACo), talked about:
  - building codes,
  - how counties handle guidelines on an individual basis,
  - land use attorneys on deed restrictions,
  - development of central water storage, and
  - expending resources on protecting people in the WUI.
- 01:13:10 Dustin Stewart, Montana Building Industry Association, talked about construction building code techniques and unintended consequences from SB 51. He stated that SB 51 is not a working solution.

- O1:16:47 The committee members talked about WUI rules being guidelines or regulatory. Mr. Blattie said that he cannot call WUI rules regulatory, because no one can enforce them. He said the guidelines are a list for subdivision developers to go by. Each county has different interpretations, and the reason for need of consistency.
- 01:24:42 Sen. Hawks explained why the implementation of SB 51 was delayed. Ms. Kurtz talked about guidelines for best practices, and said that ELG has oversight in this subject area.
- 02:01:47 Ms. Kurtz gave an overview of DLI rules for construction techniques on fire mitigation. **(Exhibit 7)** She questioned if DLI should re-do the hearing process because of "reasonable necessity".

O2:28:42 Cher Justio, Historic Preservation, gave an update of the historic preservation that is taking place throughout Montana. She talked about budget constraints and having to confine the responsibilities to the local areas.

- 03:09:59 Marsha Davis, County Superintendent of Schools in Lewis and Clark County, noted that the bill does not reflect the correct dates for setting levies. She said all school district levies should be set for the first Tuesday of September.

Ms. Cathy Swift and Dr. Mary Sheehy Moe, Two-Year Colleges, addressed their concerns regarding timelines. 05:35:09 Sen. Vote 05:41:04 The motion is to approve bill draft, LC 9995, as a committee bill that will include language "with provision when districts cross county lines". The motion passed. Sen.
