COMMITTEE ACTION

- The EQC adopted the Work Plan, including: .3 FTE to study biomass; studying fire suppression issues at .15 FTE; studying the recreation tourism enhancement program at .03 FTE; .1 FTE for water policy; .40 FTE for agency oversight; .4 FTE for statutory duties; and .2 FTE for recycling and solid waste; 02 FTE for petroleum release; and .2 FTE for publications.
- The EQC approved the proposed EQC meeting dates.
- The EQC will write a letter to the Department of Commerce (DOC) expressing a desire not to fund a study of biomass, but to fund pilot projects.

CALL TO ORDER AND ROLL CALL

<u>AGENDA</u>

00:00:01 Rep. Vincent, Chairman of the Environmental Quality Council (EQC), called the meeting to order at 8:30 a.m. The secretary noted the roll (Attachment 3).

QUESTIONS FROM THE EQC MEMBERS TO THE AGENCIES

- 00:00:45 Rep. French recalled a large amount of federal stimulus money was given to the U.S. Department of Agriculture for development of fuels. Chad Lee, Business Development office, Department of Agriculture, commented.
- 00:03:46 Upon request from Sen. Keane, Tom Kaiserski, DOC, explained DOC's biomass energy study.

00:06:44 Rep. Dickenson addressed the installation of biomass energy boilers and asked Mr. Kaiserski whether he envisioned working with Fuels to Schools or moving to another pilot project. Mr. Kaiserski responded. Rep. Dickenson asked Mr. Kaiserski whether he agreed a feasibility study would not be as valuable as a project on the ground. Mr. Kaiserski could not specifically respond. 00:08:54 Rep. French wanted to know how much of the \$475,000 would be used for administrative expenses. Mr. Kaiserski responded. 00:09:58 Barbara Smith, Legislative Fiscal Division, clarified the \$475,000 in HB 645 is not federal funds but consists of freed up general fund dollars. CONTINUE REVIEW AND DISCUSSION OF WORK PLAN (INCLUDING PUBLIC COMMENT) 00:11:29 Chairman Vincent submitted and reviewed his outline for the Work Plan (EXHIBIT 1). 00:23:29 Ms. Nowakowski provided an explanation of the environmental permitting process and provided an overview of guidelines for a visual guide to Montana's permitting process. 00:26:54 Chairman Vincent continued reviewing the Work Plan Matrix. 00:28:23 Rep. Dickenson reviewed her outline for the Work Plan Matrix (**EXHIBIT 2**). 00:36:20 Ms. Conradi stated she believed the state Superfund laws could be an area addressed under agency oversight. Ms. Conradi believed new issues were emerging at the Whitefish/Kalispell Superfund sites. Ms. Smith clarified FTE numbers do not include her time. 00:40:38 00:41:11 Rep. French addressed HJR 1 and stated she places a lot of importance on biomass. Rep. French suggested .35 or .40 be allocated to biomass. 00:42:29 Mr. Cebull suggested time allocations could be adjusted. 00:43:17 Chairman Vincent emphasized the connectivity between biomass and fire suppression. 00:44:00 Mr. Cebull asked whether the studies could be considered as a group. 00:44:34 Sen. Shockley agreed fire suppression and biomass fit together; however, Sen. Shockley suggested the other two studies should stand alone. Mr. Cebull provided clarification. 00:45:26 Rep. Wilmer commented on the allocation of staff time.

- O0:46:51 Sen. Shockley identified two aspects for recycling: the desire to recycle and the money to do it. Sen. Shockley commented that, currently, commodity prices do not encourage recycling.
- O0:47:41 Sen. Keane thought there may be a better use for the FTE, and efforts would need to be implemented on the local government level.
- 00:48:28 Rep. Dickenson disagreed and emphasized the amount of money saved in landfill costs. Rep. Dickenson believed the state had a role in recycling and that there are currently opportunities to move forward.
- 00:51:22 Chairman Vincent addressed rural recycling.
- 00:51:35 Rep. Wilmer agreed the current market is volatile and thought the current economic conditions should not be taken as indicative of long-term trends. Rep. Wilmer favored doing the study.
- 00:52:59 Sen. Shockley wondered if the work on recycling could be postponed until the end of the interim. Mr. Everts responded and Rep. Wilmer provided clarification.

- 00:55:07 Chairman Vincent asked Mr. Volesky if there was a time line for the Public Land Public Wildlife group. Mr. Volesky responded.
- O0:56:22 Rep. Dickenson wondered whether .03 was adequate to review the pros and cons of block management. Ms. Stockwell responded. Chairman Vincent suggested looking at ways to enhance access on private lands after 2012. Ms Stockwell recalled Rep. McChesney's bill for the community hunting enhancement program and suggested, if time allowed, looking at tourism and recreational access as well.
- 01:00:12 Mr. Cebull moved to adopt the work plan and include studying biomass at .3 FTE; studying fire suppression issues at .15 FTE; and studying the recreation tourism enhancement program at .03 FTE as presented by Chairman Vincent. The motion carried unanimously by voice vote.
- 01:01:43 Rep. Dickenson moved to allocate .20 FTE for recycling and solid waste. Rep. Wilmer asked whether the allocation of hours could be adjusted. Mr. Everts agreed.
- O1:02:50 Sen. Hamlett commented studies could help find better ways to handle trash. Rep. Dickenson's motion carried by roll call vote.

Water Policy

01:05:32 Mr. Cebull identified nitrates as a quality issue and a large issue and asked whether Chairman Vincent intended for the issue to be addressed by the EQC. Chairman Vincent agreed.

01:06:33 Mr. Cebull moved to allocate .1 FTE to water policy. The motion carried unanimously by voice vote.

Statutory Duties

01:07:13	Rep. French moved to allocate .5 FTE to general statutory duties.
01:07:34	Mr. Cebull asked whether the EQC was required to stay with 1.84 FTEs.
01:08:09	Rep. French commented that agency oversight could be reduced.
01:08:45	Sen. Keane stated he did not want to reduce agency oversight since he viewed agency oversight as one of the EQC's major roles. Rep. French withdrew her motion. Sen. Keane moved to adopt .4 FTE for statutory duties.
01:09:56	Rep. Dickenson asked about the possibility of eliminating participation in environmental meetings and the requirement that permit applicants present Montana Environmental Policy Act (MEPA) concerns to the EQC.
01:10:24	Mr. Everts reiterated that staff receives agendas for every meeting and attendance could be flexible.
01:11:45	Chairman Vincent suggested looking at the EQC's statutory obligations.
01:12:22	Rep. Wilmer requested clarification that the motion included the two items "at the discretion of the staff" and "the use of their time within the framework of a target of .4." Chairman Vincent agreed those two items were part of the motion. The motion carried unanimously by voice vote.

01:43:10	Joe Maurier, Director, FWP, introduced FWP staff and the issues surrounding wolf delisting and wolf management.	
01:45:02	Ken McDonald, Chief of Wildlife, FWP, provided background information on the Montana Gray Wolf Program (EXHIBIT 5); Gray Wolf Delisted, Frequently Asked Questions (EXHIBIT 6); Fact Sheet: Montana Wolf Delisted, May 4, 2009	

(**EXHIBIT 7**); Montana State Law and Administrative Rules for Gray Wolves as a Species in Need of Management (**EXHIBIT 8**).

01:54:25 Martha Williams, Attorney, FWP, represented FWP in the litigation regarding reclassification and delisting of the wolf, and updated the EQC about future litigation.

02:00:32	Sen. Shockley asked for an explanation on the quota. Ms. Williams explained.
02:01:37	Mr. Cebull asked Ms. Williams to identify the plaintiffs and who met with FWP. Mr. Cebull also wanted to know what would satisfy the plaintiffs. Ms. Williams responded.
02:03:55	Sen. Ripley requested a breakdown of where the \$1 million used to manage the wolf population would come from. Mr. McDonald responded. Rep. Ripley asked whether it was true the program would cost \$1 million. Mr. McDonald responded. Rep. Ripley was curious about the population objective and how the total population would be controlled in order to meet the objective. Mr. McDonald responded.

02:18:46	Chairman Vincent asked whether there is precedent because the grizzly bear is still allowed to be hunted, even though grizzly bears are endangered. Ms. Williams responded.
02:20:30	Chairman Vincent had questions regarding the map that depicts viable packs of wolves and was curious about the number of wolves FWP claims are in Lincoln County. Ms. Sime provided clarification.
02:22:10	Sen. Shockley addressed wolves killing domestic dogs and the distinction between threatening to kill and attacking. Sen. Shockley believed the statute should be cleaned up.
