BUSINESS STANDARDS DIVISION OVERVIEW

What we do?

Boards' Responsibilities

Protect the health, safety, and welfare of the public through licensing

- Set standards for the profession
- Grant or deny licenses
- Discipline licensees

Division Responsibilities

Establish and provide all of the administrative, legal, and technical services needed by the boards to conduct their business.

Board Staffing

- Program Manager oversees the functions of the boards
- Application Specialist processes applications and renewals
- Executive Director Board of Outfitters, Board of Medical Examiners and Board of Realty Regulation, Board of Pharmacy
- Bureau Chief
- Compliance Specialist processes all complaints
- Inspectors/Investigators
- Attorneys prosecuting attorney & board counsel

How are costs allocated?

Direct Costs – expenses directly attributed to a board/program

- Staff assigned to the board
- Legal costs
- Operating Expenses, i.e. travel, board member per diem, administrative rule making costs, printing and mailing costs, etc.

Indirect Costs – expenses that affect all boards/program as a whole

- Division Administrative Staff Administrator, deputy, receptionist
- Rent
- Telephone Equipment
- General Supplies
- IT staff and support
- Fixed Costs costs charged by other departments that support the boards, i.e. ITSD, SABHRS, etc.
- Indirect costs are allocated based on time distribution

FEES

Fees set by the Boards

- Initial licensing
- Reciprocity
- Renewals
- Applications
- Inspections
- Audits
- Examination
- Endorsements & Specialties

Standardized fees set by the Department

- License verifications
- Duplicate Licenses
- Late penalty fees*
- Licensee Lists

- Fees are required to be set commensurate with costs
- Boards need to generate enough revenue to cover both their direct and indirect costs
- Fees are adopted by Administrative Rule
- Cash Balances cannot exceed 200% of annual appropriation
 - ARM 24.101.301 allows a board to rebate fees should their cash balance exceed 200%

Unlicensed Practice

The Department is required by statute (MCA 37-1-317) to investigate complaints or other information received regarding unlicensed practice.

The complaint goes to the full board in closed session for action. Board action is limited to:

- -Cease and desist
- -If cease and desist fails the department may go to court to seek an injunction, or
- refer matter to the county attorney for prosecution.

The Electrical Board and Plumbing Board have authority to cite and fine for failure to display a license or proof of licensure.

- These fines are deposited in the general fund.
- -\$100 for first offense
- -\$250 for 2nd offense
- -\$500 for third or any subsequent offense

It is the licensees who are burdened with the costs associated with unlicensed practice complaints.
