LANDER COONEY, CEO, COMMUNITY HEALTH PARTNERS

Lander Cooney has led Community Health Partners, a Federally Qualified Community Health Center serving Park and Gallatin Counties, as CEO since October 2010 and previously directed the Livingston Clinic site, beginning in February 2006. Ms. Cooney has been integral in the organization's electronic medical record implementation and development of the organization-wide measurement initiative that guides its Patient-Centered Medical Home transformation work. Under her leadership, Community Health Partners continues to grow and be recognized for excellence in patient-centered care, measurement and attention to quality, staff engagement, and health literacy advances.
