- The committee decided to track funding of the retirement systems both at 100% and 107%, and at 30 years and 40 years, for comparison purposes.

- 00:03:28 Ms. Scurr said that both PERS' and TRS' actuaries told Ms. Minnehan and Mr. Senn what the costs would be, and that discussion would not be reflected in the June 12 minutes.

- 00:33:44 REP. INGRAHAM asked about the history of the dispersion of tobacco funds and why there was so much disparity between Glendive and Columbia Falls. **Sen.**Lewis said Columbia Falls had the base amount of cigarette tax money and when Glendive was built, they received the leftover money.
- 00:35:06 SEN. JENT asked about the total state funds going to Columbia Falls. **Mr. Johnson** referred to the chart showing Cigarette Tax Funding and said that Columbia Falls receives about \$2 million per year.

- 00:36:29 SEN. JENT asked what the state gets back from the Veterans' Administration.

  Mr. Johnson discussed the reimbursement from the Veterans' Administration on a per resident per day basis, but that is not a refund.
- 00:39:09 SEN. JENT asked about workers' compensation insurance for Columbia Falls.

  Mr. Johnson said that the Department is working on ways to reduce the costs of workers' compensation insurance.
- 00:39:43 SEN. JENT said that most of the cost containment has to do with administrative expenses and not direct patient care expenses. **Mr. Johnson** said that the direct care are expenses could be reduced while not reducing quality care.
- 00:41:36 REP. BLYTON asked why the costs for service is higher for the residents at Columbia Falls who require less assistance. **Mr. Johnson** said that the residents at a veterans' home versus those at a retirement home might require different levels of care and might be more expensive to run.

INGRAHAM asked if the terms of the contract deals just with the clinic in Helena or is there a contingency that addresses developing more clinics throughout the state. **Ms. Olson** said that the contract envisions that the Department will try to open as many clinics as possible throughout the state.
- LCsa03 Provide that expenditures and alternatives for providing state employee group benefits be subject to legislative appropriation and approval 01:12:20 Ms. Scurr gave an overview of LCsa03 (Exhibit 4).

01:18:38 Russ Hill, Administrator, Department of Administration, discussed the unintended consequences if LCsa03 becomes a bill.

#### Committee questions

- 01:21:49 REP. INGRAHAM asked Mr. Hill if he believes that the Legislature would not be supportive of any programs. **Mr. Hill** said that he can't say how future legislatures would act on a proposal brought before them, but the issue of a time delay is a significant.
- O1:23:19 SEN. LEWIS asked what was meant by "The department shall, prior to implementation of any alternative to conventional insurance...." **Ms. Scurr** said that the words "alternative to a conventional insurance" has to do with the fact that the state is self-insured.
- O1:24:39 SEN. JENT said that the committee is looking for legislative oversight and at the same time coming up with an appropriation for health care. One of the things that the committee could do is define the available alternative to the employee benefits group.
- 01:26:07 SEN. LEWIS said that if the committee took out "any alternative must be

approved by the legislature prior to implementation....", the assumption would be that unless the clinic could show that in fact they were going to reduce costs by starting the clinic, they couldn't go ahead.

01:29:34 SEN. JENT said that oversight is in 17-7-501, MCA. He referred the committee to subsection (e), and said that other state employee group benefits plan cost is inclusive. If there are any other costs, it has to go through the process.

# REPORT OF THE JOINT SUBCOMMITTEE ON THE GOVERNOR'S PENSION PROPOSAL

O4:00:34 SEN. JENT and SEN. ARTHUN reported on the Joint Subcommittee's July 26, 2012, meeting (Exhibit 7). SEN. ARTHUN said that there is concern about how big an impact the Governor's proposal would be on local governments. SEN. JENT discussed the actuarial figures and the letters from the actuaries to PERS and TRS regarding the Governor's proposals.

- O4:13:06 SEN. LEWIS asked Sen. Jent about the numbers in the Governor's proposals.

  Sen. Jent discussed the Governor's numbers in PERS. He agreed that the committee should not only consider the PERS number but also consider what is owed for those in the local government sector.
- 04:15:07 SEN. ARTHUN asked Sen. Lewis about the funding mechanism. **Sen. Lewis** said that local governments do not see this as their obligation because it is a state-run system.
- 04:15:55 REP. INGRAHAM asked about the 1% increase for employer and employee.

  Sen. Arthun suggested looking at the rate of return and the way the economy is going. Sen. Jent said that 70% of the pension benefits is being funded by investments. There needs to be a greater contribution from the employees and employers.

ARTHUN asked Mr. Niss to discuss the legal implications of the 1% increase in the employer contribution. **Mr. Niss** said that in reading the Governor's proposal initially, a trip wire mechanism to send that 1% contribution increase back down would help the constitutionality of the legislation.
