O0:10:42 Sen. Arthun **moved** to allow proxy voting by committee members. The motion **passed** unanimously by voice vote.

Rep. Ingraham requested that a form for proxy votes be given to the committee.

#### AGENCY INTRODUCTION AND OVERVIEW

# ► Teachers' Retirement System - David Senn, Executive Director

00:12:33 Mr. Senn gave an overview of the Teachers' Retirement System (Exhibit 1).

#### Questions

- O0:23:44 Sen. Arthun asked when was the last time an infusion of funds was put into the TRS. Mr. Senn said that an infusion of funds was made during the 2005 Special Session and again in 2007.
- O0:25:32 Sen. Jent asked how much contributions would increase with a 2% increase (to a total contribution of 19.11%). Mr. Senn said that each percentage point of salary is worth about \$8 million, so it is roughly \$16 million the first year.
- 00:26:55 Sen. Jent asked if it would be possible to have a bill making the actuarially required contribution part of the budget. Mr. Senn said that if the Teachers' Retirement Board had the authority to move the contribution rate down as the system becomes actuarially sound, legislative action would not be required.
- O0:27:46 Sen. Lewis asked about the Governmental Accounting Standard Board (GASB) changes that are being considered, one of them changing the period to amortize the unfunded liability to the average years remaining of work life rather than just using 30 years. Mr. Senn said that the changes would require putting the unfunded liabilities in the financial statements. The changes would also require amortizing unfunded liabilities over the remaining working years of working members. If increasing benefits for retirees, there would be a shorter amortization period.
- O0:35:24 Rep. Bennett said that it seems that the vast majority of the bills that dealt with pensions in the last session followed the "pay more, work longer, get less" strategy. He asked if there are programs or ways to deal with the pension problem that don't put the burden on new hires. Mr. Senn said that is a concern of the Teachers' Retirement Board and that is why they are looking at what is happening in other states.

# Department of Administration - Sheryl Olson, Deputy Director

00:37:17 Ms. Olson gave an overview of the activities of the Department of Administration. She distributed a handout on the Department's major accomplishments for 2009-2011, but did not discuss it.

# Public Employees' Retirement System - Patricia Davis, Member Services Bureau Chief

00:44:32 Ms. Davis gave an overview of the Montana Public Employees' Retirement Board (Exhibit 2).

#### Questions

00:57:22 Rep. Ingraham asked if there have been any changes as to how they are investing the state's money. Ms. Davis said that the Board of Investments invests those funds on the state's behalf and she believes that there have not been any changes in the allocation of the funds.

#### Board of Veterans' Affairs - Joe Foster, Administrator

00:59:30 Mr. Foster discussed the Board of Veterans' Affairs, the Veterans' Cemetery Program, and the economic impact of agency work effort (Exhibit 3).

#### Department of Military Affairs - Brigadier General John Walsh, Director

01:05:52 Brigadier General Walsh gave an update on the activities of the Department of Military Affairs and what they want to accomplish in the next biennium.
