Board of Investments and Montana State Fund Board Comparisons

The Board of Investments directs Montana's unified investment program for public funds, public retirement system, and the Montana State Fund assets as well as investments of surplus funds for local governments. The unified investment program's market value on Feb. 28, 2014 was \$15.46 billion.

The Montana State Fund Board is responsible for running the statutorily created nonprofit, independent public corporation known as the State Compensation Insurance Fund, also called Montana State Fund or State Fund. The book value of investments at fiscal year end on June 30, 2013, was reported at \$1.21 billion, not including the State Fund headquarters building in Helena, which has been paid for and now is being depreciated. State Fund listed total assets on June 30, 2013, as \$1.63 billion, which includes the building, receivables, and "other" assets valued at \$59.5 million. While the building was being built, one memo reported its value at \$24.8 million.

In sum, both operations deal with a lot of money. They also rely on professional staff that handle overall operations and report to the respective boards. A recent performance audit by the Legislative Audit Division raised a question of whether board members on the Board of Investments ought to be required to have more of a financial background than the current requirements under 2-15-1808, MCA. To help Economic Affairs Committee members better understand the appointment process and the requirements of each board, both of which report to the Economic Affairs Committee, the following Table may help by providing comparisons.
