TO PROTEST YOUR TAX:

- 1. Pay the current tax in full.
- 2. Attach a letter stating why you are protesting and the amount you feel is in error.
- 3. Proceed with legal action within 90 days.

TO APPEAL YOUR VALUATION:

- 1. You MUST HAVE FILED your appeal prior to the first Monday of June in any tax year.
- You CANNOT appeal your valuation at time

If you are low income, elderly, a veteran, or had a large increase in your property taxes due to reappraisal, you may qualify for tax assistance. Contact the DOR at (406) 222-4919 for more

You or your agent have the right to be present when your property is appraised or audited. If you wish to make an appointment for the next tax year, call (406) 222-4919 or write your local Department of Revenue office.

MOBILE HOMES: Mobile home taxes may be paid in two installments, the first installment on or before date due as shown on front and the second installment on or before date due shown. If the first and second installments are not paid on said dates, payments are considered delinquent. A 2% penalty together with interest, which accrues at the rate of 5/6 or 1% per month, must be assessed from the date of delinquency until the payment is actually received in accordance with 15-16-102, M.C.A.

REAL ESTATE TAXES: In accordance with 15-16-102(5), M.C.A., a taxpayer may pay current year taxes without paying delinquent taxes. The county treasurer shall accept a partial payment equal to the delinquent taxes, including penalty and interest, for one or more full tax years if taxes for both halves of the current tax year have been paid. Payment of taxes for delinquent taxes must be applied to the taxes that have been delinquent the longest. The payment of taxes for the current tax year is not a redemption of the property tax lien for any delinquent tax year. WARNING! DELINQUENT TAXES WILL BE SUBJECT TO TAX LIEN PURCHASES, AS PRESCRIBED BY LAW. THESE ASSIGNMENTS ARE AVAILABLE TO THE PUBLIC. If the first and second installments are not paid on said dates, payments are considered delinquent. A 2% penalty together with interest, which accrues at the rate of 5/6 or 1% per month, must be assessed from the date of delinquency until the payment is actually received in accordance with

PERSONAL PROPERTY TAXES: Personal property taxes are due and payable within 30 days from this notice. Unless paid on or before due date the taxes become delinquent and a 2% penalty is added with interest. The rate of 5/6 of 1% per month interest will be charged until the taxes are paid. When delinquent, the County Treasurer is required by 15-16-17(1), M.C.A., to turn tax over to the County Sheriff for collection.

PLEASE MAKE CHECK PAYABLE TO PARK COUNTY TREASURER. Taxes paid by check are subject to the clearance of the check. Credit card payments are acceptable online only: www.ParkCounty.org.
