#### **Board Members:**

The board consists of 20 members --11 voting members who must be confirmed by the senate, and 9 nonvoting ex officio members. The governor appoints 19 members. The tribal governments may appoint 1 member. Terms are 4-years and staggered. A board member may serve mo more than 2 terms. Members are not compensated, except for travel, meals, and lodging expenses. The board must meet at least 3 times a year. The board hires its own staff, including an administrator, who serves as the board secretary and represents the board in all communications with the governor. (See Section 2-15-1205, MCA.)

#### Voting members:

- 5 regional representatives, must be honorably discharged veterans;
- 1 member at large, must be honorably discharged veteran;
- 1 tribal member, who must be an honorably discharged veteran; and
- 3 members with training, education, or experience related to veterans' issues, including but not limited to health and medical care, mental health care, chemical or drug dependency, homelessness, or job training and placement.

### Nonvoting members:

- 1 representative of the office of state director of Indian affairs;
- 1 representative from the department of public health and human services;
- 1 representative of the United States department of veterans affairs;
- 1 representative of the veterans' employment and training service office in the United States department of labor;
- 1 representative of the state administration and veterans' affairs interim committee;
- 3 members, one representing each house and senate member of Montana's congressional delegation; and
- the director of the department of military affairs.

The tribal leaders of the eight tribal councils in Montana may appoint 1 voting member who is affiliated with a Montana tribe and is an honorably discharged veteran. If a tribal member is not appointed by the Montana tribal leaders, the governor shall choose this member by lot from a pool of names submitted by the eight tribal councils in the state, with each tribal council submitting one name.

- Receive donations for State Veterans Cemeteries.
- Represent the State of Montana as a member of the National Association of State Directors of Veterans Affairs.

- a quarterly newsletter, which may be printed or electronically distributed by e-mail or by posting it to an appropriate website.
