- Statewide candidates, all statewide and local ballot issue committees and incidental committees. (approximately 2,436 compliance inspections in 2012)

#### **KAREN**

- Municipal, School, PAC's and Party Committees
- (2013 = 712 candidates of which 76 were "C"box status and required to report. Approximately 304 compliance inspections. In 2012 there were 261 independent committees, or 1,305 compliance inspections).
- Assists with Lobbyists and Principal registration and reporting
- Answer and route phone calls and mail
- Scan and upload all submitted forms to Filenet

#### **CERTIFICATION OF CANDIDATES**

#### Statewide and State District

- Open filing period is Jan to March of the election year.
- Within 5 days of filing every state candidate has to file two forms.
- Verify that the candidates have filed their required paperwork.
- Once verified a letter is sent to the SOS notifying her/him of the non-compliant candidates.

All non complaints candidates are held off the ballot.

2012 – 409 candidates were certified, 3 were held off the ballot.

### County, Municipal, and School

- Filing periods vary
- COPP has to work closely with all 56 county election administrators or the 21 third class school districts for confirmation that both COPP and their office has all of the required forms.
- Letter sent to COPP requesting certification
- Lastly, a letter is sent in response that certifies all compliant candidates.
- 2012 426 local candidates were certified.

#### **COMPLIANCE INSPECTIONS**

#### Financial Disclosure Reports (Form C-5 and Form C-6):

- Every statement and report submitted to COPP must be inspected within 20 days. (13-37-121(1), MCA)
- Any errors or omissions result in contacting the treasurer via email, letter, or telephone if necessary. Minor corrections can be made by the staff. Most corrections are made by amending the report.
- Failure to file a required report can result in a candidate either being held off a ballot or an election certificate being withheld.

#### **BUSINESS DISCLOSURE STATEMENT (FORM D-1)**

- Type of business which currently engaged or formerly engaged in
- Past employment or present employment where benefits are received.
- Business, partnerships, corporations, trusts in which an interest is held
- Entities in which the candidate is an officer or director
- Real property
- Every statewide and state district candidate (minus judiciary) is required to file a D-1. Department heads and holdover Senators are required to file a D-1 each even-numbered year.
- Available on the COPP website

## MULTIPLE PUBLIC EMPLOYMENT DISCLOSURE STATEMENT (FORM E-1)

All public officers, legislators, and public employees who are employed by more than one public employer for overlapping periods of time are required to file a Form E-1 (MCA, 2-2-104)

#### Reported Information

- 1. Name and address
- 2. Date of multiple employment
- 3. Title(s) or descriptions of each overlapping position
- 4. Amounts paid by each employer

LOBBYISTS AND PRINCIPALS

#### LOBBYISTS AND PRINCIPAL REGISTRATION

- ☐ L-1 Lobbyist License Application
- □ L-2 Principal Authorization Statement
- □ L-5 Lobbyist Financial Disclosure
  - □ January and Post session reports are required for every principal, plus a session year end and non-session year end when applicable
  - □Late reporting results in a \$50 per day penalty up to \$2500

Each application and report is required to be inspected within 10 days.

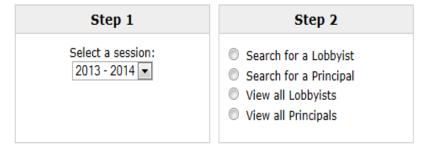
