# **ADJUDICATION UPDATE (85-2-281, MCA)**

O0:08:36 John Peterson, Water Adjudication Bureau chief, Department of Natural Resources and Conservation (DNRC), gave an update on the adjudication progress report, Exhibit 2.

00:10:35 Russ McElyea, chief water judge, Montana Water Court, gave an update on the number of decrees issued by the Water Court in 2013 and 2014, Exhibit 3.

#### Public comment None

- 00:16:54 Rep. Connell asked about the purpose and need for modifications to SB 355 (2013) and if the goals of the bill are being achieved. Mr. McElyea said the changes being proposed will improve elements of the bill to make it work better for claimants and the court. He said the bill is working well.
- 00:21:30 Rep. Connell asked if the proposed modifications to SB 355 will be ready for the WPIC to review before the 2015 Legislative session. Mr. McElyea said the proposed modifications will be ready in time.
- 00:22:35 Sen. Hamlett asked how many years the aerial photographs, used to exam claims, date back to and if there is one for every year. Mr. McElyea said the earliest photographs date back to the 1930s. He said he did not think photographs were taken every year.
- O0:24:27 Sen. Hamlett asked if aerial photographs taken during periods of drought will have an adverse impact on water rights going forward. Mr. McElyea said there is room for debate on the interpretation of what aerial photographs portray and how the information should be used.
- 00:26:33 Sen. Hamlett asked if the use of aerial photographs will extend the adjudication process. Mr. McElyea said it will.
- 00:27:10 Sen. Hamlett commented on the use of aerial photography.
- 00:28:17 Sen. Vincent asked when the Water Court foresees enforceable decrees in all of the river basins. Mr. McElyea explained the prerequisites that are required under the statute before the court can have an enforceable decree.

- 00:29:37 Sen. Vincent asked how long the process will take. Mr. McElyea said the degree of speed is variable in each basin, but they are scheduled to issue the last decree by 2020.
- 00:32:10 Sen. Fielder asked if any level of temporary, preliminary, or final decree marks the beginning of the litigation process. Mr. McElyea said the commencement of the process is one of the two temporary decrees and the closure of the process is the final decree.
- 00:32:54 Sen. Fielder asked why the summary reports are pending on the Crow, Blackfeet and Flathead reservations. Mr. McElyea explained why the adjudication process is pending.

Mr. Peterson said the Bitterroot is delayed because of the number of claims and their complexity. He also explained the reason for the pending reports on the Crow and Blackfeet reservations.

# ANNUAL REPORT FROM CLARK FORK BASIN TASK FORCE (85-2-350, MCA)

00:38:29 Holly Franz, representing PPL Montana on the Clark Fork Basin Task Force, gave an update from the Clark Fork Basin Task Force, Exhibit 4.

- 00:53:28 Sen. Hamlett asked if reestablishing a wetland affects a water right downstream.

  Ms. Franz said it depends on the way the wetland is established.
- 00:55:2 Sen. Hamlett asked if a senior water right holder can make a call on a dam. Ms. Franz said that a dam has to be filled in priority.
- 00:57:06 Sen. Hamlett asked if once water is stored, the basic ownership and control of the water changes. Ms. Franz said the water is considered differently.

- 00:57:58 Sen. Hamlett asked if the state of Montana can make a call on stored water. Ms. Franz said that the state does not have any special priority and can only make a call according to the priority of its water right.
- 00:58:31 Rep. Connell asked if the task force quantified their hopes or expectations of what they would be able to achieve in regards to "natural system health." Ms. Franz said they did not.
- 00:59:51 Rep. Williams asked if the recommendation under "natural system health" topic, that the task force or the DNRC should propose legislation to enable the permanent change of an existing water right to instream use, assumes that the transfers would need to contribute to "natural system health," or is the recommendation to allow anyone to convert the water right to instream flow. Ms. Franz said that the recommendation was not to make any change to the instream flow statutes except to treat them like all other water right changes.

Ms. Franz said there is a recommendation for forest and vegetation management to encourage greater water yields.

#### PROPOSED FEDERAL ADMINISTRATIVE RULE: DEFINITION OF "WATERS OF THE U.S."

- 02:00:26 Karen Hamilton, chief, Aquatic Resource Protection and Accountability Unit, EPA, introduced the presentation on the proposed revisions to the definition of "Waters of the U.S." under the Clean Water Act (CWA), Exhibit 8.
- 02:03:51 Julia McCarthy, environmental/life scientist, EPA, via phone, gave a PowerPoint presentation, Exhibit 9, on changes to the definition of "Waters of the U.S." under the CWA.
- O2:37:19 John Tubbs, director, DNRC, discussed the proposed rule and the impact in Montana.

- 02:47:34 Rep. Connell asked if developing access roads for silviculture and agriculture activities is exempt under the CWA. Ms. McCarthy said there is an exemption for construction or maintenance of farm, forest and temporary mining roads.
- 02:49:40 Rep. Connell asked if temporary roads applies to roads developed for silviculture and agriculture. Ms. McCarthy said that temporary only applies to the construction and maintenance of mining roads.
- 02:50:45 Sen. Fielder asked if there are other Supreme Court rulings, other than the ones that were mentioned, that were contrary to the proposed definition. Ms. McCarthy said only the three supreme court rulings mentioned dealt directly with the interpretation and definition of "Waters of the U.S."

02:51:23 Sen. Fielder asked about any type of assessment or disclosure of anticipated adverse impacts that the rule change may have on socioeconomic conditions. Ms. McCarthy said an economic analysis was done as part of the rulemaking and concluded that the benefits of the proposed rule outweighed the costs twoto-one. 02:52:34 Rep. Williams asked about the effective date of the current rule. Ms. McMarthy said the current existing regulatory definition goes back to the late1970s. 02:53:40 Rep. Williams asked about jurisdiction and roles of the EPA and the Army Corps of Engineers. Ms. McCarthy said the rule is a joint rule by the EPA and the Corps and explained how the program works. 02:56:15 Rep. Williams asked about exemptions for a ditch when its diversion lies within a riparian area. Ms. McCarthy said if there is a diversion structure in the stream, and the ditch is not contributing flow, the ditch would be exempt regardless of whether the structure for the diversion was in the stream. 02:58:22 Rep. Williams said waste would be prohibited from being discharged into that ditch without a permit. Ms. McCarthy agreed. 02:58:44 Rep. Williams asked for clarification between bed, banks and ordinary high water marks and an erosional feature. Ms. McCarthy said there are different characteristics that the Corps uses to indicate where a ordinary high water mark exists and where it doesn't. 03:02:13 Rep. Williams asked if having a ditch that is jurisdictional protects the state from unpermitted discharges. Mr. Tubbs said that a state-based permit regulating the discharge would add protection to the ditch owner. 03:03:42 Sen. Hamlett asked how intermittent and ephemeral streams fit into the proposed rule. Ms. McCarthy said that intermittent and ephemeral streams that have a permanent channel formed would be considered tributaries under the definition of "Waters of the U.S." and protected under the CWA. 03:04:54 Sen. Hamlettt asked if springs would be regulated under the CWA. Ms. McCarthy said the groundwater that feeds the spring is not jurisdictional, but once the spring comes to the surface it becomes a surface water and may meet the definition of "Waters of the U.S." 03:05:59 Sen. Hamlett asked about EPA regulations on diminishing return flows because of the changes in irrigation projects from flood irrigation into pivot irrigation. Ms. McCarthy said return flows from agriculture are exempt under the CWA. 03:07:04 Sen. Hamlett asked if water that is taken out of a stream and put into an

irrigation project, then returned back into the stream, is regulated as "Waters of the U.S." Ms. McCarthy said it depends on whether there is water in the channel.

03:08:03 Sen. Hamlett asked if the reason for the proposed rule is because the Congress will not change the rule. Ms. McCarthy said that without a new law coming out of Congress, updating the regulation is the best thing the EPA can do to provide consistency and clarity on "Waters of the U.S." 03:08:55 Sen. Hamlett said since the EPA is part of the executive branch of government, if the rule passes and is implemented, the only way the rule can be changed is for Congress to act and pass a law. Ms. McCarthy agreed. 03:09:32 Sen. Hamlett asked what would happen if the administration of the executive branch did not want the rule change. Ms. Hamilton said if the proposed rule was not finalized, the EPA will continue to follow the existing rule. 03:11:02 Sen. Hamlett commented that the proposed rule in being driven by special interests and if the proposed rule goes forward it will give the federal government more control over water in the state. 03:14:51 Sen. Vincent asked who was involved in drafting the rule. Ms. Hamilton said the EPA was responsible for drafting the revisions and she had a list of organizations that asked for the revisions. 03:15:44 Sen. Vincent requested a copy of the list of organizations requesting the revisions, Exhibit 10. 03:15:51 Sen. Vincent asked if EPA Region 8 participated in the rule process. Ms. Hamilton said that Region 8 was not involved in the process. Sen. Vincent asked if Region 8 asked anyone in the Washington D.C. headquarters if they would consult with states impacted by the proposed rules. Ms. Hamilton said they consulted with state organizations. 03:16:51 Sen. Vincent commented that states were not consulted or given an opportunity to participate in the rulemaking process. 03:17:55 Sen. Vincent asked for clarification regarding narrowing of what is considered U. S. waters." Ms. McCarthy said she was referring to the historic scope of the CWA and the regulations that were drafted in the late 1970s. 03:21:33 Sen. Vincent asked about dredge and fill and the practical application of the new law in obtaining a jurisdictional determination from the Corps in a timely manner. Ms. McCarthy said the proposed rule is intended to eliminate delays and improve the way the program operates. 03:26:08 Sen. Vincent said that tributaries and streams would be considered a significant nexus under the new rule and would need to comply with 404(b)(1) requirements. Ms. Hamilton said that if a permit were needed for minimal activities the Corps has permits for simple types of activities.

06:15:54 Rep. Connell asked if there has been any consideration for extending the comment period on the BMPs. Mr. Johnston said he was unaware of a formal extension, but would find out. 06:17:31 Rep. Connell said he believes the issue is significant to Montana, as a headwater state, and said he did not believe people have had an opportunity to look at the BMPs in detail. 06:18:30 Rep. Connell said he was concerned about establishing a national protocol to consider issues across a diverse landscape. Mr. Johnston said the core BMPs are general and non-prescriptive. 06:20:54 Rep. Connell said the grading system used in the Forest Service proposal is reversed from the one used by Montana. He also said the policy does not do fair deference to the state's efforts on water quality, BMPs, and stream side management. Mr. Johnston said he did not know what went into the grading system on a national level. Hamlett commented on how new rules from one federal agency will affect the state's working relationship with other federal agencies. 06:30:49 Sen. Vincent asked how the regional directives will guide site specific BMPs differently. Mr. Johnston said the site specific BMPs are choices to select from to meet the national BMPs and said he did not expect what is used in Montana to change. 06:32:25 Mr. Johnston discussed the structure of directives, federal register proposals, and legal authorities.

She asked if anything that would be inconsistent, the UMO would dictate, and all other state law would apply. Ms. Hornbein said the UMO provides that within the exterior boundaries of the Flathead Indian Reservation, to the extent that there are conflicting provisions of state laws relating to water use, the UMO applies rather than those provisions. 10:26:57 Rep. Williams asked how individual is defined in the Compact. Ms. Hornbein said individual is not defined in the Compact. 10:27:44 Rep. Williams asked about the assertions that the FJBC has not been contacted and irrigators have not been asked to participate in meetings. Ms. Hornbein said there has not been a lot of formal public information during the last 6-9 months. She said they are willing to meet informally with any interested group. 10:30:01 Rep. Williams asked if there have been any problems with other boards on the reservation. Ms. Lund said other boards are working well. 10:32:46 Rep. Williams asked if the Montana attorney general has made a commitment to represent water users if there is not a compact and the tribes go to court. Mr. Metropoulos said he did not know of any commitment made by the attorney general. 10:35:04 Rep. Connell asked about off-reservation flows and calls made on the Lower Clark Fork and Swan rivers and the duration. Mr. Peterson said an analysis was done by Andrew Brummond, water rights/streamflow specialist, Region 4, Department of Fish, Wildlife, and Parks. 10:37:54 Sen. Hamlett asked about the length of the appointment for the governor's representatives on the UMO. Mr. Metropoulos said they are appointed for a three-year term. 10:39:04 Sen. Hamlett asked if the tribe also appoints representatives for the same length of time. Mr. Metropoulos said they do. 10:39:39 Sen. Hamlett asked if the governor's appointees have to be approved by the Legislature. Mr. Metropoulos said they do not. 10:39:59 Sen. Hamlett asked if there could be political consequences as a result of the governor's appointees. Mr. Metropoulos said there could be. 10:40:53 Sen. Fielder asked what it means that the UMO will allow exclusive jurisdiction over the meaning and interpretation of the Compact and ordinance. Mr. Metropoulos said he does not know what exclusive jurisdiction means or if it will be binding in court.

10:42:43 Sen. Fielder asked if the volume of water is to fulfill the purpose of the reservation. Mr. Metropoulos said no, that the irrigators have been told they will not lose any irrigation water, and the modeling that is the basis of the water use agreement shows that, but it is not evident and has not been proven. 10:43:49 Sen. Fielder asked what water is the volume of water. Mr. Metropoulos said, under the Water Use Agreement, it is the water that will be delivered to the irrigators for irrigation. 10:44:09 Sen. Fielder asked Mr. Metropoulos how he interprets water ownership under the Compact. Mr. Metropoulos said water ownership is not addressed in the Compact, but under the Montana state Constitution the state owns the water. 10:45:56 Sen. Hamlett asked Mr. Metropoulos if he represents irrigation districts on the reservation. Mr. Metropoulos said he represents all three irrigation districts on the reservation and the central operating agency which is the FJBC. 10:46:23 Sen. Hamlett asked if the irrigation districts have applied for and been given a state water right. Mr. Metropoulos said both the FJBC and the Bureau of Indian Affairs (BIA) filed for state-based water right claims, but adjudication has not yet reached the Flathead Reservation. 10:47:29 Sen. Hamlett asked if either the FJBC or the BIA applied for a water right with the state of Montana. Mr. Metropoulos said the Bureau of Reclamation did the first filing for the project in 1910, as did many of the landowners. 10:48:57 Sen. Hamlett said that someone did file for a water right that is recognized in Montana. Mr. Metropoulos agreed. 10:49:21 Sen. Hamlett said in many cases, when a water right is filed by a ditch company or an irrigation project, individuals do not have a water right, but a right of use. Mr. Metropoulos said that is one of the controversies. He said the FJBC believes they own the water right in trust, as a fiduciary, for the individual landowners, but some landowners assert that they own the entire water right. 10:50:15 Sen. Hamlett commented that there are water rights already in place. 10:51:09 Sen. Vincent commented on how water is managed elsewhere. 10:52:03 Sen. Hamlett said the issue may be, since this is an irrigation project with federal money involved, the rights or shares cannot be sold away from the land. Sen. Vincent said, within the Compact, the rights cannot be marketed off the project. 10:52:53 Mr. Metropoulos said the question is whether the landowner has an entitlement, which is a property right to receive the water, or a license. He said as the Water Use Agreement is written now, the language is much more in the nature of a license rather than a property right.

10:53:25 Sen. Vincent said the amendment in 1908 to the 1904 Allotment Act opened up the Flathead Indian Reservation, and the Department of Interior set out a process by which the landowner would make payments to pay for the cost of the infrastructure in delivering the water and after making the payments they had a user right to that water. He said the WPIC needs to look at that issue. 10:54:21 Sen. Hamlett said there is a difference between a use right and a water right, but the end result should be that you get the water. 10:54:39 Rep. Williams said it is unusual that the Flathead Indian Irrigation Project (FIIP) does not have an operation plan. 10:55:39 Sen. Vincent said it will be better to have a discussion once there is more information from the MBMG on looking at the water model and verifying some of the water volumes to determine whether or not the people who have a user right will get the water that has been promised. 10:56:06 Sen. Stewart-Peregoy commented on user rights and water rights. 11:02:14 Sen. Hamlett said the UMO is a way for both the tribe and the state to have a say. 11:04:32 Sen. Vincent commented on the points that were made and testimony given during the meeting. He said the WPIC should look at the treaty rights, which are federal reserved rights, and how congressional actions have changed a lot of what the treaties mean in order to determine if the Compact is fair for all parties. 11:09:05 Sen. Vincent asked Ms. Swaney to clarify a statement she made during her testimony. Ms. Swaney explained the comment that she made.
