UPDATE FROM CSKT COMPACT TECHNICAL WORKING GROUP

00:01:01	Jason Mohr, Research Analyst, Legislative Services Division (LSD), provided information on the members of the Confederated Salish and Kootenai (CSKT) Compact technical working group. He said that the working group has met twice and provided the dates for additional meetings that have been scheduled.
00:04:51	Sen. Hamlett asked if any members of the public were present. Mr. Mohr said the members of the public that were present at the two work group meetings.
00:05:43	Sen. Hamlett asked if any of the working group members are present at the meeting today. Mr. Mohr said that John Metesh, Director and State Geologist, Montana Bureau of Mines and Geology (MBMG) is present.
00:05:58	Mr. Metesh gave an update on the work group meetings.
00:12:27	Rep. O'Neil left the meeting.
00:12:42	Sen. Hamlett asked if Bill Greiman, Engineer, Reserved Water Rights Compact Commission (RWRCC), will be available for the June 12 meeting. Mr. Metesh said he will be present.

00:13:36	Sen. Fielder asked about addressing the issue of surface water data quality. Mr. Metesh said they will use the data, but will not get into the data validation process.
00:15:38	Sen. Fielder asked if Kate Vandemoer has participated with the working group. Mr. Metesh said that she has not. Sen. Fielder suggested she be included.
00:16:30	Rep. Connell said that in the preliminary information that has been reviewed nothing has been uncovered that is in conflict with data in the compact. He asked that the WPIC be advised of any issues that may arise that conflicts with some basis of the discussion that has occurred between the state, the tribes, and the federal government.
00:17:53	Sen. Stewart Peregoy asked if the CSKT reports will be utilized by the work group. Mr. Metesh said they will be used.
00:19:33	Sen. Hamlett asked about the amount of material that is available for review. Mr. Metesh said that he would rather have more material than less.
00:20:57	Sen. Stewart-Peregoy asked if any of the work group meetings are scheduled to be held on the CSKT Reservation. Mr. Metesh said they are not.
00:21:58	Mr. Mohr said that the tribe will be presenting to the working work on June 12 and gave a schedule for additional work group meetings.
00:22:50	Sen. Hamlett said that all meetings are noticed to the public. Mr. Mohr agreed.
00:23:36	Sen. Hamlett said that the amount of information that is available is beneficial to everyone.
00:24:06	Sen. Fielder asked when the next WPIC meeting is scheduled. Mr. Mohr said that the meeting is scheduled for August 7.
00:24:30	Sen. Hamlett asked Mr. Metesh if he had any additional information. Mr. Metesh said he did not.
00:24:45	Sen. Hamlett asked if there are an adequate number of stream gauges to collect data in the area. Mr. Metesh said they have a considerable amount of data.

00:32:43	Sen. Hamlett asked if the date for the last WPIC meeting can be changed. Mr. Mohr said that the meeting date can be changed or a meeting can be added.
