COMMITTEE ACTIONS

The committee heard presentations related to its House Bill 422 study of children's mental health outcomes and Senate Joint Resolution 22 study of guardianship and Alzheimer's disease. As part of their agency oversight duties, the members also heard several presentations related to the Child and Family Services Division of the Department of Public Health and Human Services.

The committee:

- adopted a resolution asking Governor Bullock to appoint a legislator to the Protect Montana Kids Commission, which is reviewing laws and practices related to child abuse and neglect cases;
- decided against renewing the objection to MAR Notice No. 37-728 that was filed after a majority of the committee notified the chairman on Jan. 8 that they objected to the rule;
- decided against including performance-based reimbursement options in any pilot project that it develops for children's mental health outcomes as part of the HB 422 study;
- agreed that the HB 422 study should focus on outcomes related to whether children in the mental health system are in school, at home, and out of trouble; and
- for the SJR 22 study, requested additional information on training and certification for guardians, on reducing conflicts of interest involving guardians, and on the "Working Interdisciplinary Networks of Guardianship Stakeholders" (WINGS) project that has been adopted for use in other states.
