Greetings, Economic Affairs Interim Committee Members,

Here is an update to the administrative rules report before our meeting next week. Today, the Secretary of State will publish the 2016 Administrative Register Issue #7. Importantly, this notice contains a new proposed rule on dry needling. Here are the proposed rules to be published:

State Fund:

MAR Notice Number: 2-55-47

Subject: Amendment of rules pertaining to the individual loss sensitive dividend distribution plan.

<u>Summary:</u> The proposed amendment to 2.55.502 seeks to allow retrospectively rated policies to participate in the general

dividend.

Notes/Hearing: State Fund does not anticipate a public hearing on the matter. It proposes to adopt the rule on May 13, 2016.

Agriculture:

MAR Notice Number: 4-16-231

Subject: Adoption of rules pertaining to pesticide certification and training fees.

<u>Summary:</u> The proposed rule seeks to set fees for its pesticide study manuals, pesticide applicator training courses, initial pesticide applicator training courses, and fall pesticide core and category-specific training courses. The rule also sets fees for collection fees. The department anticipates that the average fee per individual or organization has typically been between \$19 and \$25.

Notes/Hearing: The department proposes to hold a public hearing on April 29, 2016.

Department of Commerce: MAR Notice Number: 8-94-142

<u>Subject:</u> Adoption of rules pertaining to the administration of the 2018 Biennium Federal Community Development Block Grant (CDBG) Program.

<u>Summary:</u> The proposed rule seeks to incorporate by reference the 2017-2018 Application and Administrative Guidelines for Housing, Public Facilities and Economic Development Planning Grants as rules for the administration of the 2017-2018 CDBG Program.

Notes/Hearing: The department proposes to hold a public hearing on April 28, 2016.

Department of Labor and Industry: MAR Notice Number: 24-177-33

Subject: Amendment and adoption of rules pertaining to dry needling.

<u>Summary:</u> The proposed amendment to 24.177.2105 fixes a numbering error in the rule. The proposed rule seeks to allow dry needling. The proposed rule also requires licensed physical therapists to be able to demonstrate that they have completed training in dry needling that meets certain American Physical Therapy Association guidelines. The rule prohibits a licensed physical therapist from delegating the task.

Notes/Hearing: The department proposes to hold a public hearing on May 5, 2016.
