Possible Legislative Changes:

1. Dependent Neglect Cases:

- a. Change procedure for when an attorney is assigned for a parent in a child abuse and neglect case (especially in the case of putative parents or absentee parents).
- b. Change the procedure for Dependent Neglect cases so that OPD is not involved in early stages or involved in different process to speed resolution of cases.
- c. What changes can be made structurally to make the representation of children in Dependent and Neglect cases independent from representation of parents?

2. Misdemeanor Cases:

- a. Change the procedure for misdemeanor cases so that OPD is not involved in early stages or involved in a different process to speed resolution of cases.
- b. What misdemeanor offenses should have penalties changed?

3. Eligibility

a. Change the procedure for eligibility determination to ensure only the appropriate individuals eligible for services receive them.

4. Organizational Changes:

- a. Change the structure of OPD to improve management of resources and accountability for performance.
- b. What has to be done structurally, administratively, and legislatively to create an Executive Director for the OPD and make head of Trial Division, Appellate Division and Conflict Division Managers?
- c. What changes can be made structurally and legislatively to make Appellate Division separate, financially and duties, from the other divisions (this is especially important in states where a direct appeal is permitted for ineffective assistance of counsel like Montana)?
- d. How to improve functioning of the Conflict (and contract) system (management, attorney competence, bill review, etc.) and the role of the Legislature in making this happen (or utilizing Administrative Rules).
- e. Change the size and duties of the Public Defender Commission.

5. Employee Performance:

- a. Provide the design of and implementation plan for an "Evidence-Based Performance System" for the OPD.
- b. What changes should be made to require specific training to practice in certain areas?
