DATE: July 20, 2015

This memorandum provides the results of the poll of possible study topics. A staff recommendation is included on the second page of the memorandum.

Poll Results

The committee requested that a poll be conducted to determine interest in 13 study topics proposed by committee members and staff. The results include rankings from all 12 committee members. The following table summarizes the results and is sorted with the top-ranked study topics appearing first.

Staff Recommendation

The following recommendation is based on the rankings by committee members, available committee time, and staff workload.

Recommendation: Undertake the three highest ranked studies with the full committee participating in all studies.

The following are the reasons for making the above recommendation:

- The proposed work plan allocates 18 hours of committee time to study committee-requested topics and emerging issues. The three studies included in the recommendation are conservatively estimated for 20 hours of committee time. The committee schedule can be expanded to 2-day meetings as needed to accommodate the three recommended studies.
- The top three studies are recommended because every committee member ranked these studies. Also, there is a clear delineation between the top three studies and the studies that ranked fourth and below. The top ranked study is within 9 points of the third ranked study. The third-ranked study received 23 more points than the fourth ranked study, which received 17 more points than the fifth ranked study.
- The recommendation is for the full committee to undertake all studies (rather than use of subcommittees) because these topics had broad support in the poll and study by the full committee allows for participation by all members.

Next Steps

Staff will prepare study plans for review and adoption at the next regular meeting. Staff will also present background information on each topic at the next meeting as that is generally part of the first phase of a study.
