RE: Montana school district use of permissive and voted levies

This report provides information on the uses of permissive and voted levies for FY 2016 school districts general funds and seven special revenue funds: transportation fund, bus depreciation reserve fund, tuition fund technology fund, flexibility fund technology fund flexibility fund, debt service fund building reserve fund. ### School budgets and sources of revenue

The tables that follow summarize school district budgeted mills budgeted for FY 2016 for 244 elementary, 102 high school districts, and 58 K-12 school districts (404 total districts), non-operating school districts were not included in the data. Mills levied by each district are organized by Office of Public Instruction (OPI) school size classification and by fund. Each fund is designated a (P) for permissive or (V) for voted levy.


School districts are required to budget, at a minimum, at the BASE budget and are encouraged to budget between the BASE and Max budget. The table below summarizes how Montana school districts are budgeted for FY 2016.

Sources of funding for the general fund BASE budget include local non-levy revenue, local district tax levies, the revenue from the guarantee account, which is statutorily appropriated for BASE aid and the state general fund. The state general fund is divided into revenue from the statewide 95 mills and the balance of state general fund required for the state's share of BASE Aid.

The following chart shows the proportion of the district budget funded by these sources.

### Least Levied Fund – Flexibility Fund

None of the 404 districts levy for the flexibility fund. The flexibility account is for receipt of the state flexibility payment as well as other revenue. The flexibility payment is an appropriation from the legislature and that appropriation limits the ability of districts to levy for this fund. A district may levy up to 25% of the allocation from the legislative appropriation (20-9-544, MCA). The last legislative appropriation was in 2003, therefore districts have not been able to levy for this fund since then.

### Most levied fund – General Fund

392 School districts use permissive levies to fund the general fund BASE budget, 12 districts do not levy to fund the BASE budget. Of the 12 districts that do not levy for the BASE seven districts levy for the over BASE budget. Most of these school districts receive sufficient oil, gas or coal revenues to support the BASE budget. Dupuyer elementary is able to fund the BASE budget with a combination HB124 block grants and direct state aid (DSA).

Of the 404 districts, only three have no levies for any fund, Lambert Elementary, Lambert High School (Richland County) and Westby K-12 (Sheridan County). All three receive oil and other non-levy revenues sufficient to fund the general fund BASE and over BASE budget as well as all other budgeted funds. All three districts fund above 97% of the maximum general fund budget.

The state levies 95 mills for equalization on all property owners statewide, this revenue is available for distribution to school districts from the state general fund.

## Elementary Districts

Elementary districts levy on average 68.56 mills for the general fund, 50% of all elementary mills between about 38.0 and 85.5 mills. Melrose Elem (Silver Bow County) has the highest general fund mill of all elementary school districts at 197.5 mills and one of the lowest value per mill at \$281/Mill Melrose uses a permissive mill of 26.1 to fund the base budget and 171.4 voter approved mill to fund the over BASE budget.

Elementary districts have an average mill value of \$8,698 mills, 50% of districts have mill values between \$1,555 and \$10,250/mill. The district with the lowest mill value is Yellowstone Academy at \$10/mill; Billings Elem has the highest mill value in the state at \$194,588/mill.

## High School Districts

High School Districts levy on average 45.5 mills for the general fund, 50% of all elementary mill between about 31.9 and 57.2 mills. Havre Elementary (Hill County) has the highest general fund mill of all high school districts at 110.0 mills and value per mill of \$19,844/Mill, which is near the average for High School Districts. Havre uses a permissive mill of 34.86 to fund the BASE budget and 75.14 voter approved mill to fund the over BASE budget.

High School districts have an average mill value of \$19,793 mills, 50% of districts have mill values between \$4,400 and \$15,806/mill. The district with the lowest mill value is Rocky Boy HS (Hill County) at \$150/mill; Billings HS has the highest mill value in the state at \$264,034/mill.

## K-12 School Districts

K-12 School Districts levy on average 144.9 mills for the general fund, 50% of all elementary mill between about 84.4 and 139.9 mills. Roy K-12 Schools (Fergus County) has the highest general fund mill of any school district in the state at 253.4 mills and value per mill of \$842/Mill, which is below the average for K-12 districts School Districts. Roy K-12 uses a permissive mill of 63.31 to fund the BASE budget and 190.05 voter approved mill to fund the over BASE budget.

K-12 districts have an average mill value of \$7,600 mills, 50% of districts have mill values between \$2,544 and \$9,687/mill. The district with the lowest mill value is Heart Butte K-12 Schools (Pondera County) at \$66/mill; Ennis K-12 Schools has the highest mill value in the state at \$69,247/mill.
