- 06:20:00 Rep. Williams asked if Montana is fortunate because it is one of the few states that has a state Corps office and a lot of decisions are made closer to home. Mr. Ryan said it is and that every state in the Corps district has a state program office. He said a lot of the simple nationwide permitting that occurs is done in the Montana office, but for 404 permits, like the one for the Montanore Mine project, are done in Omaha.

06:21:23 Rep. Williams said that whatever happens with the WOTUS rule Montana's mandate to protect clean water is geographically more extensive than the proposed rule. Mr. North agreed. She said wetlands are also considered state waters, but it is unclear if dredge or fill material deposited into a wetland would be considered waste under the current statutes and that is why it may need to be clarified if the state takes over 404 permitting. Mr. North said that is an issue. 06:25:06 Rep. Williams asked Mr. North about adjacent water, and if it is included into federal jurisdiction, if Montana already has a responsibility to protect it under current state law. Mr. North said Montana is required by law to protect the quality of that water, but doesn't have the authority to regulate dredge and fill. 06:26:52 Sen. Hamlett said the reason he brought the bill was because if the rule is changed a lot of the 310 permitting will cease to exist because the federal government's reach will go farther up the stream and require 404 permits. 06:27:49 Sen. Vincent asked if the WPIC has made any recommendations. Sen. Hamlett said there hasn't been any recommendations for legislation. He said the committee needs to make a motion to submit the report for public comment. Sen. Vincent said he recommends discussing potential legislation at the meeting tomorrow. 06:28:58 Sen. Vincent said if adjacent water is included into federal jurisdiction it will put a federal nexus on land where there previously was no dredge-and-fill requirement and it will be administered by the federal government. He said he would like to consider looking at contingent legislation if the WOTUS rule is passed. 06:32:51 Rep. Z. Brown said a next step could be to encourage DEQ to apply for federal grants available to states that are considering state assumption. 06:33:35 Sen. Vincent asked about federal grants. Mr. Mohr said the next time states can apply for the grants is in 2018. He discussed other options for the WPIC to consider. 06:34:52 Sen. Hamlett said a discussion about legislation can be done at the meeting tomorrow, and the committee needs to decide if the report should be submitted for public comment. 06:35:31 Sen. Stewart Peregoy said she is concerned about the cost for state assumption of the program. 06:37:40 Rep. Williams said that in order to get meaningful public comment the report needs to include information on the fee that the state will charge and how that compares to streamlining and speeding up the process. She asked if staff could give a cost estimate. Mr. Mohr said that he could submit it into the Corps to see if they can give a breakdown. Rep. Williams said the WPIC may want to include recommendations for potential direction in the report. Sen. Hamlett asked Mr. Mohr if cost estimates are on the high or low side. Mr. 06:41:16 Mohr said the estimates are conservative on both sides. 06:42:15 Sen. Hamlett said he recommends contacting the states that have assumed the 404 permits to find out what they charge. He said if the federal government changes the rule it will change 310 permits and there will be more 404 permits. He said the state needs to determine its best option. 06:44:02 Rep. Williams said she recommends that the WPIC release the report for public comment and include four options for the public to comment on. Sen. Hamlett and Sen. Vincent agreed. 06:47:07 Mr. Mohr said he can draft the options into committee recommendations.
