Mr. Woolard said it does not and that MSU is charged for its water on a monthly basis. Rep. Williams asked Mr. Woolard about the graph showing per capita per use 01:37:46 per day and how it is trending, what kind of goal is set, and how it is benchmarked. Mr. Woolard explained the city's goals and objectives. Sen. Williams asked Mr. Woolard about water conservation. Mr. Woolard said 01:40:58 people have been very receptive to water conservation efforts and the city has saved millions of gallons of water in just a couple of years. Sen. Vincent asked Ms. Evans about Farmer's Canal and how prepared it is to 01:41:28 move forward when decrees become enforceable. 01:43:16 Sen. Vincent asked Ms. Evans if changes need to be made to the current laws on mitigation banking. 01:46:29 Sen. 	clerks and recorders office never receives water right ownership transfer
	information and that the county assessor is not part of their office. (Exhibit 5)
02:42:45	Rocky Haralson, regional manager, Property Assessment Division, Department
	of Revenue (DOR), said the DOR has authority for assessment purposes and is
	responsible for all of the valuations of real and personal property. He said as a
	result the county assessor does not have any assigned duties and there is only
	one elected county assessor in the state.
02:44:30	Mr. Haralson said that John Morrow and Mark Olson from the DOR are present

- 02:44:30 Mr. Haralson said that John Morrow and Mark Olson from the DOR are present and available to answer questions.
- 02:44:51 Mr. Haralson discussed the issue that 40 percent of water rights transfer certificates are submitted without processing.
- 02:46:06 Mr. Haralson discussed the issue that counties are inconsistent in sending real estate transfers to the DOR with some taking up to six months.
- 02:48:01 Mr. Haralson discussed the issue that the system has not been automated.
- 02:48:51 Mr. Haralson discussed whether there is a way to make the county downloads more consistent, how much would it cost, and would the counties be willing and able to comply.

Mr. Davis said one of the goals of the working group is to find a way to make the process work better. 03:01:28 Rep. Williams asked Mr. Davis about the information available on the realty transfer certificate. 03:02:08 Rep. Williams asked Mr. Davis about putting more information on one form. 03:03:14 Rep. Williams asked Ms. Stoll if she wanted to add any additional information. Ms. Stoll said that two forms are used, the realty transfer certificate that goes to the clerk and recorders office, and the water right ownership form. She said there needs to be additional public education so that new owners know they have the obligation to submit the forms and pay the required fees to the DNRC. Sen. Hamlett asked Ms. Stoll about the legal requirement when property is sold 03:05:11 in the state and what happens with the deed. Ms. Stoll said she did not know, but said the deed needs to be filed. 03:05:39 Sen. Hamlett requested that staff find out about the statute and what is required 03:06:23 Sen. Hamlett said that because water rights can either be transferred or sold separate from pieces of property, they are not always recorded on the deed. Ms. Stoll agreed. 03:07:43 Mr. Davis said if the water right is severed from the land it would not be transferred with the real property. He said if the deed is silent and there is a water right associated with it, the water right, by law, transfers with the land. Ms. Stoll said there may be cases when a water right does not always transfer 03:08:42 with the land when a deed is silent. 03:09:53 Sen. Hamlett asked Mr. Haralson about the legal requirement when real property is sold and the deed. Mr. Haralson said realty transfer certificates must be completed and filed along with the deed at the county clerk and recorder's office. Sen. Hamlett asked if there is a time limit for filing the deed. Mr. Haralson said 03:11:04 there is not.
