The timeline below shows how the committee could focus its attention on one study topic at a time, assuming that the committee will want to spend more time on some studies than on others.



## HJR 20 Study: Health Care Price Transparency

HJR 20 asks for a study of health care price transparency. The table below shows the study activities listed in the resolution and the staff estimates of the amount of committee time required to fully carry out each task. *Additional decision points related to a potential subcommittee are listed on Page 5.*

# **HJR 17: Prescription Drug Pricing**

HJR 17 asks for a study of prescription drug pricing and its effects on Montanans. The table below shows the study activities listed in the resolution and the staff estimates of the amount of committee time required to fully carry out each task.

## HJR 24: Services for Developmentally Disabled Adults

HJR 24 asks that the committee study services available to developmentally disabled adults and whether improvements could be made in service delivery or payment. The table below shows the study activities listed in the resolution and the staff estimates of the amount of committee time required to fully carry out each task.

#### Potential Subcommittee for HJR 20

The Legislative Council on June 6 agreed to set aside additional funding from its Emerging Issues account to help cover the costs of a subcommittee for HJR 20. Council members encouraged the Children and Families Committee to form a subcommittee that could include members of the public as well as members of the Economic Affairs Interim Committee.

If the Committee decides to form a subcommittee for the HJR 20 study, members should discuss and decide the following questions:

- 1. How many Committee members will be on the subcommittee and who will chair it?
- 2. Should the subcommittee include members of the public? If so:
  - a. How many public members should be included?
  - b. Which stakeholders should they represent?
  - c. How will they be selected?
  - d. Will they be voting members?
  - e. Will they be paid for time and travel costs?
- 3. What study tasks will be delegated to the subcommittee?
- 4. Does the full Committee want any of the information or presentations prepared for the subcommittee to be presented to the full Committee, as well, for its own education or assessment?
- 5. How many meetings should the subcommittee have? (The number will depend on the funding available and may impact the number of meetings the full Committee may have.)
- 6. When should the subcommittee complete its work?
- 7. How frequently would the Committee like to receive reports about the subcommittee's activities?

Subcommittee meetings are subject to the same public notice and open meetings requirements as regular Committee meetings. In addition, minutes must be kept for subcommittee meetings.

The *Rules, Procedures, and Guidelines for Interim Committees* adopted by the Legislative Council sets out procedures for subcommittees on Pages 3 and 4. Key provisions include:

- The presiding officer has authority to establish temporary or standing subcommittees.
- The subcommittee presiding officer shall:
  - work closely with the committee staff to set research priorities; and
  - make periodic reports and recommendations to the full Committee.
- A subcommittee recommendation is a recommendation to the full Committee. Only the full Committee may take an action to implement a subcommittee recommendation.
