#### **COMMITTEE ACTIONS**

The committee reviewed additional research for its House Joint Resolution 24 study of community services for adults with developmental disabilities, heard an update on the medical marijuana program, and received information on the economic impact of Medicaid expansion in Montana.

The committee requested that several HJR 24-related bills be drafted for review and public comment in June. The bills would:

- require use of a nationally recognized assessment tool known as the Supports Intensity
   Scale in determining the level of support a developmentally disabled individual needs;
- create a regional crisis response program based on the model developed in New Mexico:
- index DD provider rates to the Consumer Price Index and raise direct-care worker wages by 75 cents an hour every six months;
- direct the Department of Public Health and Human Services to review regulatory and administrative requirements to eliminate unnecessary duplication, oversight, and inconsistencies where possible; and
- increase flexibility in use of funding by requiring DPHHS to use a base daily or monthly
  rate for some services and by placing unspent general fund appropriated to match
  federal Medicaid funding for DD services into a special revenue account that could be
  used for a variety of purposes.

The committee also asked for a bill draft to eliminate the advisory committee created under the Medicaid expansion law.

The committee decided to make its June meeting a two-day meeting; members will meet June 21-22 in Helena.
