Please accept these comments as a direct reflection of where the funding for AIS should come from.

The Cooperative's of Montana stood tall when the need for a call went out to help stop the AIS issue and once again the hydro power users are asked to pay for an issue that they did not create. The plan to stop the spread was quite frankly only effective about 1/3 of the time (due to the number of hours spent checking and cleaning boats).

The fact is very simple, AIS was imported from boats that were let onto the waters of Montana. The cost of fixing the dams that create power from that water are going to incur additional cost that will be the burden of the cooperative member (that did not cause the problem). So, in effect, AIS collection of funds and then fixing the equipment needed to generate power after the AIS takes hold at the dam, is going to create a double taxation to the cooperative members.

The entire burden the AIS situation should lay solely with the those that created the issue, watercraft and recreational users. 100% of the funding should come for the cause causer, not the people that now have to deal with the issue after the fact and pay twice for an AIS issue.

Please add my letter to what I hope is a growing list of concerned citizens asking that the legislature keep their word on excluding hydropower from AIS funding going forward.

I was there as a concerned citizen in the last session as the legislature struggled to come up with funding for this necessary government function. I agreed that we, electric coops with 50% or more of our power from hydro generation, would initially support funding to prevent the spread of AIS that adversely affect our electric generation, irrigation, recreation and property values.

But only the first two years.....not as an ongoing program. Flathead Electric Cooperative voluntarily donated \$35,000.00 each year for two years prior to legislative action to expand the timeline of inspection stations. We recognize the timeliness and the necessity of this activity. But it's wrong to force some electric utilities to collect taxes that benefit the entire population of the state and the country.

The legislature agreed to sunset this hydro funding mechanism in 2019 and it should keep it's word. The broader the tax base for this necessary function, the better. It should NOT be on the backs of a subset of electric utility members when it benefits everyone.

In response, legislative leadership stated on the record in the committee and in both the House and Senate floor deliberations that they recognized the AIS hydropower fee was intended only as a bridge to the next legislative session with the expectation that funding mechanism would be set. Legislative leaders made a commitment that they would allow the hydropower fee to sunset in 2019 as scheduled under current state law.

Fall River appreciates that the currently EQC proposal honors the commitment previously mentioned. Hydropower is not a cost causer when it comes to infestations of AIS.



Thank you for the opportunity to comment on the proposed funding for the Aquatic Invasive Species issue. This is an important issue for Montana. I am proud of the effort electric cooperatives have made to this point, in order to address this issue in a timely manner. However, as electric co-ops are not for profit, increasing costs can only be remedied by increased rates to our members.

When the original AIS hydropower fee was introduced during the 2017 legislative session, electric co-ops, with the knowledge of the state's budget shortfall, did not oppose. In fact, we stepped up and helped get the AIS program rolling. Additionally, even though my co-op falls well below the 50% hydropower threshold, we voluntarily helped pay the fee through our power supplier (Central Montana Electric Power Cooperative) as we felt strongly it was right to act "cooperatively" in addressing this issue. The legislative leadership in committee and during the House and Senate deliberations acknowledged our efforts and recognized that the electric co-op fees were to be used as only bridge financing until the next legislative session. The leaders committed to letting the hydropower fee sunset in 2019.

Thank You for honoring that commitment in your proposal. Simply put, hydropower is not a cost causer when it comes to infestations of Aquatic Invasive Species. Dear Environmental Quality Council:

Western Montana G&T and its member utilities appreciate the opportunity to comment on the proposal for a new funding structure for Montana's Aquatic Invasive Species program. The hydroelectric fees imposed on us during the 2017 legislative session were difficult to understand given the fact that our members don't own or operate hydroelectric facilities that would be impacted by AIS. We own and operate distribution systems and deliver power purchased through the Bonneville Power Administration that also does not own or operate any hydroelectric facilities. The actual federal owner and operator of facilities that could be impacted by AIS are the U.S. Army Corps of Engineers and the Bureau of Reclamation. We do understand that the state was facing a budget shortfall in 2017 and it was a difficult decision on who would get harmed to fund this emerging priority.


We are very mindful of the difficulty of setting rates and fees and live through these challenges on a regular basis. Our BPA rates have increased at nearly double the rate of inflation over the last decade driving BPA rates quickly up to levels that threaten financial viability and competitiveness. The funding sources proposed by EQC appear to be based on cost causation principles. We remain mindful of the challenge facing the legislature and hope that a new funding structure can be a durable solution for Montana's aquatic invasive species programs.


We very much appreciate that legislative leadership intended that the AIS hydropower fee was to be used only as a bridge to the next legislative session with a commitment that the hydropower fee would sunset in 2019 as scheduled under current state law. The EQC proposal honors that commitment and we offer our support for the proposed funding structure.
