

EAIC REVIEW OPTIONS:

DEPARTMENT OF LABOR & INDUSTRY ATTACHED AGENCIES/REPORTS

The Economic Affairs Interim Committee (EAIC) is responsible for monitoring four departments, one agency run by an elected official, Montana State Fund, and two divisions attached to agencies that normally do not report to the Economic Affairs Committee but whose legislation usually comes before members of the House Business and Labor Committee or the Senate Business, Labor, and Economic Affairs Committee. The following table lists the agencies attached to the Department of Labor and Industry, which the EAIC monitors. Below the table is a list of reports that the Department of Labor and Industry or one of its attached agencies is required to provide to the legislature or to the EAIC. The table and list are to help the EAIC determine if more information is wanted in the form of presentations at the committee's June 2018 meeting.
