

RE: COVID-19 Federal Assistance to Tribes in Montana

This memo is to provide the State-Tribal Relations Committee additional detail pertaining to COVID-related federal funding awarded to tribal governments. Those funds are part of the total federal funding that has been awarded in the state for COVID-19 assistance; for more details about the total funds awarded in the state, please see the Legislative Fiscal Division's COVID-19 Federal Funds Summary report: <https://leg.mt.gov/content/publications/fiscal/2023-Interim/Dec-2021/Fed-funds-COVID-summary-December-2021.pdf>

Of the \$14.1 billion provided to Montana, through state agencies and directly from the federal government, COVID-19-related direct federal assistance to tribes and tribal colleges from the federal government was approximately \$1.2 billion or 8.3% of the total. The following chart shows federal assistance to Montana, broken down by category and amount.



The funding shown in orange was awarded to the state and was appropriated through the specified house bills or was added to the state budget through budget modification. The funding in blue are funds associated with state-run programs, such as unemployment benefits, but are not budgeted funds. The gray portions, both light and dark, represent various federal funds that were provided in Montana directly to individuals or entities other than the state; of those funds, the dark gray shows funds awarded to tribes and tribal colleges by the federal government, as of December 15, 2021. The funding to tribes does not include the direct economic impact payments, child tax credit payments, nor COVID-related federal funding that was sub-granted from the state.

The tables below show a specific breakdown of direct federal assistance to tribes and tribal colleges under each COVID-related federal supplemental act. CARES I includes the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) funding, as well as the three smaller federal supplemental assistance acts that were passed in 2020. CARES II is funding that was authorized under the Consolidated Appropriations Act of 2021 and, for funding to the state, was appropriated under HB 630. The American Rescue Plan Act (ARPA) of 2021 was the most recent federal supplemental assistance act and, for funding to the state, was appropriated under HB 632. Finally, there was some funding classified as non-emergency and was authorized under the various supplemental acts, but the data used does not specify under which supplemental act the funding was authorized.

The source of this data is [usaspending.gov](https://usaspending.gov), a federal open data source of federal spending information that includes grants, direct payments, and contracts for all entities, including tribes, states, local governments, foreign governments, non-profits, and for-profit entities. For COVID-related funding, [usaspending.gov](https://usaspending.gov) applied COVID flags to the funding awarded from the COVID federal supplemental acts, distinguishing those funds from other non-COVID funding that was awarded. The funds included in this table are those that have been committed or “obligated” for Montana’s tribes and tribal colleges; they do not necessarily represent what has been distributed to tribes nor do they represent expenditure of funds. Also, while [usaspending.gov](https://usaspending.gov)

does include awards that pass through other entities or sub-recipient awards, those are not included in the data presented here; this data only includes assistance awarded directly from the federal government to the tribes. The data was last updated by [usaspending.gov](https://usaspending.gov) on December 15, 2021. There may be additional COVID-related obligations that will occur as time goes on, particularly under ARPA.

These funds are obligated for various purposes. To provide a clearer understanding of the purpose of the funds obligated, the tables included at the end of this report provide a breakdown of the funding by awarding agency and by the catalog of federal domestic assistance (CFDA) number and title associated with the obligations. The CFDA is a government-wide listing of all the financial assistance programs administered by the federal government; it is now known as assistance listings. For context regarding the Health and Human Services funding, the Confederated Salish & Kootenai Tribes (CSKT) and the Chippewa Cree Tribe of Rocky Boy's Reservation have tribally owned and operated health departments, which is why there is additional funding provided for those tribes under CFDA 93.210 Tribal Self-Governance Program: IHS Compacts/Funding Agreements. There are also six IHS-operated service units (health clinics or hospitals) at Fort Peck, Fort Belknap, Northern Cheyenne, Crow, and Blackfeet Reservations; some Health and Human Services COVID-19 related funding was provided in support of those. The Little Shell Chippewa Tribe's health center was recently completed and opened in November 2021; there has not yet been Health and Human Services funding provided for the Little Shell Tribe with the exception of the Native Language Preservation funds.

Additionally, there are two tribally controlled schools in Montana: Two Eagle River School in Pablo and Northern Cheyenne Tribal School in Busby. Additional COVID-related funding was provided to CSKT and the Northern Cheyenne Tribe through the Bureau of Indian Education for those schools.
