



**STARTING** from East Middle School, take Grand Avenue to Harrison Avenue and turn le onto Harrison Avenue. Take Harrison Avenue south to 4 Mile Road and turn right. Proceed one mile to the Margaret Leary School. Turn right on Jeremy's Way. Park in any of the available lots. The BBQ will be in the center of the soccer complex—look for the building at the north end of Jeremy's Way.







#### WORKSHOP DESCRIPTIONS

Workshop Session 1 - Tuesday 10:30am-12:00pm

- Fostering Safety & Positivity: Exploring East Middle School's Transformation & Safety Initiatives through 1st-hand experiences during a presentation, followed by a school tour, learn how design can enhance student safety, inclusion, learning apportunities, and community spirit.
- 2) Empowering Educators: Strategies for a Positive Classroom Climate -effective strategies to manage rising student behavior issues, providing participants with methods and resources to transform these challenges into opportunities for classroom growth and success.
- 5) The 3 C's of School Safety: Climate, Culture & Context the roles of School Climate, Culture, and Context in security operations, their interaction in creating a safe educational environment, and receive model policies, effective practices, and resources
- 4) Rehearsing Resilience: The Power of Tabletop Exercises the purpose, design, facilitation, and benefits of tabletop exercises (TTXs) for emergency planning, featuring insights and lessons from a March 2023 TTX with the Bozeman School District and partner organizations.

- 1) **Proactive Strategies for Cyber Resilience in Montana's Schools** -the current cyber threat landscape to Montana's schools; free services and resources are available to help minimize those threats, and a walkthrough of creating a cyber incident response plan.
- 2) Sacred Gifts for Healing Indigenous Two-Spirit Children/Youth -define LGBTQ2S terms, examine resilience factors & resources for Two-Spirit youth, & provide strategies to support a safe, inclusive educational environment, aligned with the Sacred Gifts for Healing Indigenous Two-Spirit Children/Youth Toolkit.
- 3) Universal Screening: How to Ensure a Healthy System & Connect Students Who Need More Supports -overview of universal screening for social-emotional and behavioral concerns, best practices for implementation, common tools and procedures, and strategies to overcome barriers, enhancing support and sustainability across student support systems.
- 4) **Behavioral Threat Assessment & Management: What's a School to Do? (BTAM pt-1)** -clearly identify what is a threat, why should a school conduct behavioral threat assessment and management, overview of the behavioral threat assessment and management process and school roles within that process.

#### Workshop Session 3 - Wednesday 10:00-11:30am

- Preventing Violence: Root Cause Analysis & Early Interventions (BTAM pt 2) -realm of threat assessments and early, supportive interventions, addressing root causes and preventing violence plus how these strategies contribute to fostering a more safe and supportive school climate.
- 2) Reimagining School Safety in Practice -restorative approaches to transform harm into healing and cultural responsiveness to foster connection and belonging, providing strategies to create an empathetic, resilient, and inclusive school environment.
- Trusted Adult: Enhancing Supports training for adult champions on the role and characteristics of a trusted adult, focusing on how fostering trust can prevent youth violence and identifying key behaviors to address warning signs or threats with overview of Sandy Hook Promise.
- 4) Enhancing MTSS to Create Effective Systems of Crisis Planning, Response & Recovery -how integrating school mental health within a Multi-Tiered System of Supports (MTSS) can enhance prevention, preparedness, response, and recovery from crises, offering a comprehensive crisis planning approach that includes equity, systems, data, and practices, supported by recent studies and best practices for mental health in schools.

Workshop Session 4 - Wednesday 1:00-2:30pm

- 1) Data, Privacy, and Learning: Charting an Ethical Course for AI (Artificial Intelligence) in Schools Al's role in education, addressing both its benefits and risks, including data privacy, algorithmic bias, and ethical implications, while fostering collaboration to develop strategies for responsible implementation and student & school safety.
- 2) **Beyond Emergency Management: Comprehensive Strategies for School Safety** comprehensive school safety, including bullying, cyberbullying, child exploitation, cybersecurity, mental health, school climate, threat assessment, targeted violence, and public health concerns, alongside Emergency Operation Plans (EOPs) to prepare for disasters, providing participants with essential knowledge to enhance their school's safety practices.
- 5) Suicide School Safety Planning & Postvention safety planning and postvention practices to respond effectively to mental health crises and suicide risks in school settings, addressing the unique challenges for mental health practitioners, educators, and parents.
- 4) School Safety in Today's World the importance of Behavioral Threat Assessment teams in promoting early intervention and a safe school climate based on trust and respect, referencing insights from the US Secret Service and NTAC on preventing attacks and apprehending plotters before incidents occur.

# SPEAKERS & PRESENTERS





**ERICHA ANDERSON** 

Vancouver Public Schools

Ericha Anderson is a Positive Behavior Intervention Support (PBIS) Coach at Vancouver Innovation Technology & Arts (VITA) elementary school in Vancouver Public Schools (Vancouver, WA) who works with administrators, teachers, and students to transform teaching and learning by implementing a project-based learning approach. The focus of her work is to engage students in learning that is deep and long-lasting, inspires joy and personal connection, and amplifies communication, collaboration, critical thinking, and creativity. Ericha has a BA in Elementary Education from the University of Montana, Masters of Educational Technology from City University, and library endorsement from Portland State University, and is currently working toward earning administrative credentials at Gonzaga University. She has worked in the educational field for 24 years as an elementary classroom teacher, teacher librarian, and K-12 instructional coach. Ericha has served on several school and district-based committees focused on improving school safety and social-emotional learning. She has experience as a professional development leader in her district guiding nearly sixteen hundred teachers in best practices for developing a broader set of knowledge and skills to prepare students for college, careers, and beyond. She has presented at several state and national EdTech Conferences addressing impactful technology integration and digital safety including International Society for Technology in Education, Northwest Council For Computer Education, IntegratED, and CUE California.



#### MIKELSHAN BARTSCHI

Cache County Sheriff's Office

With a 24-year law enforcement career, Mikelshan Bartschi (Michael-Shawn Bar-Chee) currently oversees the Cache County Sheriff's Office Criminal Division, including investigations and school resource officers. He has experience in patrol, corrections, investigations, and supervision. A former SWAT operator and commander, he is NASRO certified and a certified Force Science Analyst. Mikelshan serves on the executive board of the Child Abduction Response Team (CART) and led a five-day search for a missing child. He is trained in various interview techniques and threat assessment models and has attended the FBI Intermountain Law Enforcement Executive Command College. He chairs the countywide active attack committee and sits on the Cache County School District's Safety Team, overseeing safety for over 18,000 students. Mikelshan is a member of the Association of Threat Assessment Professionals and trained in Crime Prevention Through Environmental Design (CPTED). He is also part of the Cache Valley Unified Response Team. His spouse and two adult children are educators in Utah.



NANCY BERG

University of Montana Safe Schools Center

Nancy Berg, who holds a Master's Degree in Social Work, is the Assistant Director at the Montana Safe Schools Center at the University of Montana. She oversees fiscal management of grant and non-grant accounts, assists with data collection, tracking, reporting, and coordinates project reports for Federal and State sponsors. The Montana Safe School Center's mission includes school safety, emergency and crisis management, and providing training, research, and professional development to schools and communities. Ms. Berg is trained in the I Love U Guys Standard Response Protocol, Standard Reunification Method, and ALERRT Civilian Response to Active Shooter Events (CRASE).

She provides training on emergency operations planning, school safety, educator wellbeing, trauma-informed practices, and suicide prevention. Ms. Berg is a certified master trainer in ASIST and safeTALK suicide prevention protocols.

Currently working towards her clinical Social Work licensure, she volunteers at the YWCA in Missoula, providing crisis and counseling services to survivors of domestic violence, sexual violence, stalking, and human trafficking.



#### **GUY BLIESNER**

Idaho Office of School Safety and Security

Guy Bliesner began his career in 1994 as a high school teacher and coach, moving into administration in 2006 as the Safety and Security Coordinator for the Bonneville School District. He was named to Idaho's Governor's School Safety Task Force and was a finalist for the 2011 Campus Safety Magazine's national Campus Safety Director of the Year Award. In 2013, he co-founded Educators Eyes, a consulting firm that developed Idaho's first statewide school safety assessment. He dissolved the firm in 2016 to join the newly created Idaho Office of School Safety and Security.

Currently, he serves as the School Safety and Security Analyst for schools in Southeast Idaho. He is a board member of the National School Safety Center Association (NSSA), President-Elect of the National Council on School Facilities (NCSF), and a founding member of the National School Safety Directors Association (NSSDA). He also chairs a sub-committee for ASIS International's Technical committee for developing School Safety Standards. Guy advocates nationally for school safety and supports public and charter schools in Southeast Idaho with assessments, training, and planning assistance.



#### **ERIN BRILEY**

Mountain Plains Mental Health Technology Transfer Center (MHTTC)

Erin Briley joined the Western Interstate Commission for Higher Education (WICHE) in 2019. She currently is the School Mental Health Coordinator for the Mountain Plains Mental Health Technology Transfer Center Network (MHTTC). As the program manager and school mental health lead, her work focuses on providing intensive technical assistance, resources, and training to school staff on ways to support school-based mental health. Ms. Briley worked as a School Psychologist and has over 20 years of experience working in the schools, serving school districts in California, Hawaii, and Colorado while providing direct and indirect supports for children ages 3 through 22 of all developmental levels.



#### **COLE CONWAY**

Former EMS SRO, Butte Police Department

Cole Conway is a second-generation police officer, native, and lifelong resident of Butte, Montana. He attended Butte Schools and graduated in 2008. In high school he was a standout athlete in football, basketball, and track. Cole became a police officer in Butte in 2014, graduating from the Montana Law Enforcement Academy in 2015. In 2020, Cole was assigned the duties of the Student Resource Officer for the Butte School District and completed National Student Resource Officer training. His office was housed at East Middle School, but his work encompassed all of the elementary schools in Butte. During his tenure at East Middle School, the school underwent a complete remodel in which significant safety and security features were brought to East Middle School. Cole was an essential member of the team that trained the staff, administration, and his colleagues on the force, in the safety features that were the center piece of the renovation project. Cole was also an instrumental member of the active shooter training team in the Butte School District. Cole was promoted to the position of Detective in 2023 and, even though his office and his job has changed, he continues to be a reliable resource for the Butte School District on matters of safety concern. Cole is married to Taelor Conway, an elementary school teacher in the Butte School District. Together, they have two great sons in Noah, age 5, and Cooper, age 3. In his spare time, Cole spends his time as a t-ball coach, and as a volunteer football coach at Butte High School. He is an avid basketball player and has laid claim to winning the MVP award of this year's East Middle School Student-Staff basketball game.



#### **JASON DAVIS**

SMA Architecture + Design

As a Principal and Partner of SMA Architecture + Design, P.C., Jason's twenty-year career has included K-12, higher education, commercial and historic projects. Jason is involved in every step of project development from pre-bond planning, educational specifications and conceptual design to the resulting elementary, middle school, high school and athletic facility construction. Tina Eblen is the University of Montana Safe School Center's Training and Technical Assistance Specialist. She brings to the center a wealth of experience including over eight years of Emergency Management, ten years of Behavioral Health and five years working directly with schools.



#### JENNIFER FREEMAN

**UW SMART Center** 

Dr. Freeman has over 20 years of experience in public education at the K-12 and higher education levels. She is currently an associate professor in educational psychology at the University of Connecticut, and a technical assistance director for the Center on Positive Behavioral Interventions and Supports (PBIS). Her work focuses on applying multi-tiered systems of support such as PBIS to improve overall school climate and a sense of belonging for students and educators. She is particularly interested in improving graduation rates for students with behavioral and/or mental health disorders. She also studies professional development methods for improving teacher's use of evidence-based classroom management strategies and teaches undergraduate and graduate courses in the special education program. Dr Freeman leads a national crisis preparation response and recovery workgroup within the Center on PBIS and has 10 years of experience supporting schools, districts, and states in recovery efforts following incidents of school or community violence. This work focuses on supporting short- and long-term recovery efforts as well as prevention and preparation efforts at the district and state levels.



#### JOE FROLICH

Cybersecurity and Infrastructure Security Agency (CISA), Dept. of Homeland Security
Joe Frohlich serves as a Cyber State Coordinator (CSC) for Montana, Region 8 (UT, CO, MT, WY, ND, SD) of the Cybersecurity and Infrastructure Security Agency (CISA) in the Department of Homeland Security. He is based out of Helena. CISA works with public and private partners to defend against today's threats and build more secure and resilient infrastructure for the future. The CISA Cybersecurity Advisor program includes promoting cyber resilience through various engagements and performing risk and resilience-based assessments.

Prior to joining CISA, Joe was the IT Director at Ravalli County, Montana for nine years. During his time at Ravalli he co-founded Montana's Local Government IT group and served on the executive board for the Multi State Information Sharing and Analysis Center, better known as MS-ISAC. In 2015 he moved to Helena to work for the State of Montana as the Enterprise Security Manager for the Department of Administration. In this role, he assisted in the creation and management of the Governor's appointed Montana Information Security Advisory Council (MT-ISAC) whose primary focus was cybersecurity in State and Local Government. Joe directed the State Government enterprise security policy, managed the security and awareness campaign, and supervised a team of IT risk management professionals. Early in 2021 Mr. Frohlich transitioned to DHS/CISA in his current role as a CSA for Region 8.



#### **BOB GREEN**

Former Montana Tech Head Football Coach

Coach Bob Green retired as the Head Football Coach at Montana Tech in 2010 after leading the Orediggers for 24 seasons. During his tenure, Tech had its most successful period ever in football with 5 NAIA National Playoff appearances which included the 1996 National Championship game. In 2013 the stadium replaced its surface with artificial turf and named the new field after Green in honor of his accomplishments. The Legendary Coach Green has an incredible sense of humor and his "Greenisms" have gone viral over the years.



**CURTIS HERRING** 

WestEd

Curtis Herring, MEd, is a School Safety Technical Assistance Specialist with the WestEd Justice and Prevention Research Center. He supports local, regional, and state education agencies in their implementation of evidence–based violence prevention strategies. Herring began his work in education in 2013 as a high school science teacher and progressed to the Director of Counseling and Student Support for Comal ISD (Texas) before coming to WestEd. His work has included several notable projects, such as the development of a campus mindfulness room, the introduction of processes and procedures related to Behavioral Threat Assessment, the development of a campus-based mentorship program, and the institution of school counseling data collection and analysis methods. In his more recent role serving as the Director of Counseling and Student Support, Herring oversaw certified school counselors, licensed social workers, and licensed professional counselors at 34 campuses, leading the continual development of a robust school-based mental health framework and comprehensive school counseling program. Curtis received his MEd in educational psychology from Texas A&M University and his BS from the University of Texas at San Antonio.



#### MARILYN KING

Bozeman Public Schools


















# 3RD ANNUAL SCHOOL SAFETY RECOGNITION AWARD RECIPIENTS

The School Safety Recognition Awards are part of the Jeremy Bullock Safe Schools Summit's effort to help promote school safety. Individuals, schools, organizations, and youth all play an important role in these efforts and the awards allow for acknowledgement of the dedication, commitment and hard work put into striving for safer schools in our communities. The awards provide an opportunity to highlight the exceptional work of select honorees that make a significant difference in our schools and communities.

#### Champion of School Safety - Jeremiah Nitz, Havre High School Assistant Principal

Jeremiah Nitz is the recipient for his significant contributions to Havre Public Schools. Over the past decade, he has served on the District Safety Committee and recently stepped up as the Safety Coordinator. Despite the instability caused by having four Superintendents in five years, Mr. Nitz single-handedly updated and modernized the District Safety Plan in 2023, creating an effective emergency action plan for all five schools. His hands-on experience includes coordinating evacuations, managing bomb and shooting threats, and leading numerous ALICE trainings to prepare staff for violent incidents. Jeremiah's expertise, dedication, and proactive approach have significantly enhanced the safety and security of students and staff, earning him the highest respect and appreciation from his colleagues.

#### School Resource Office of the Year - Scott McCormick & Bozeman Schools SRO Team

Scott McCormick and the entire Bozeman School District SRO team are the recipients for their exceptional dedication, service and commitment. Handling an average of 230-260 calls monthly, they support students, families, and staff through various crises, including child abuse reports and high-level threats. Their proactive measures include student threat assessments, safety plans, and multi-agency preparation events. Embracing the NASRO triad model, they serve as public safety educators, mentors, and law enforcement officers, fostering positive relationships and a sense of security within the school community. Their compassion, professionalism, and visibility make them invaluable to the district and Bozeman community.

#### Youth Safety Spotlight Award - Great Falls Public Schools Peer Mentoring Groups

The Great Falls Public School District's Peer Mentoring Program is the recipient for its outstanding impact on student mental health and safety. Serving grades 7-12, the program trains students in evidence-based mental health practices to identify and refer peers in need, fostering a supportive school culture. Overseen by licensed therapists and supported by school counselors, the program ensures high standards of care. Its success is evident in reduced ER visits for suicidal ideation and decreased teen substance use, demonstrating a significant positive shift in mental health awareness and intervention.
